progress and grade level standards are shared with parents. Student progress in relation to state and local standards will be explained to parents including the curriculum being used, grade-level expectations for proficiency, data reporting for state and local assessments and available interventions in reading, ELA and mathematics for students needing assistance.

- c. If requested by parents, the school provides opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible. (20 USC 6318 (c)(4))
 - i. Through formal parent-teacher conferences, informal requests by parents for meetings, Back to School Nights, SSC, ELAC and PTA
- 5) If the schoolwide program is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the local educational agency. (20 USC 6318 (c)(6))
 - a. Roynon Elementary School will submit all written documentation of parent comments that reflect that the program is not satisfactory to Bonita USD.

Building Capacity for Involvement
