NOTICE IS HEREBY GIVEN that the Governing Board of the Rocky Point Charter School, at its Regular Meeting on September 18, 2025, will hold a public hearing, pursuant to Education Code Section 52062, to solicit comments from members of the community regarding Resolution No. 25-26-01, Sufficiency of Instructional Materials.

**RESOLUTION**  
**Education Code Section 60119 Sufficiency of Instructional Materials**

Whereas, the governing board of Rocky Point Charter School, in order to comply with the requirements of Education Code Section 60119 held a public hearing on September 18, 2025, at 3:00 p.m., which is on or before the eighth week of school (between the first day that students attend school and the end of the eighth week from that day) and which did not take place during or immediately following school hours, and;

Whereas, the governing board provided at least 10 days notice of the public hearing posted in at least three public places within the district that stated the time, place, and purpose of the hearing, and;

Whereas, the governing board encouraged participation by parents, teachers, members of the community, in the public hearing, and;

Whereas, information provided at the public hearing and to the governing board at the public meeting detailed the extent to which textbooks and instructional materials were provided to all students, including English learners, in the district, and;

Whereas, the definition of "sufficient textbooks or instructional materials" means that each pupil has a textbook or instructional materials, or both, to use in class and to take home, and;

NOTE: The definition of sufficient textbooks or instructional materials no longer includes the phrase "to complete required homework assignments." Students must now be able to take their instructional materials home.

Whereas, sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in the following subjects:
