Group 2: Town of Moraga and Civic Meetings (Town of Moraga Programs in Group 2 are those programs operated and staffed with Town of Moraga employees)

Group 3: **Youth non profit Organizations, clubs or associations exclusively organized to promote educational, sports and character development

Group 4: Program and activities sponsored by PTA's for which fees are charged, contributions solicited, or instructors are paid to provide services.

Group 5: **Non profit adult sports groups organized to benefit local citizens

Group 6: Private organizations/commercial use

Use Requirements:

For all categories 2-6 - A facility application is required; Weekend custodial fees are charged by the hour (if multiple locations are reserved by one group, fees will be adjusted to only one facility for that given day)
