**7. PRESENTATIONS / DISCUSSIONS**

7.1 Recognition Awards - (Salutatorian-Peyton Becker; Valedictorian-Makinze Massey)

Gillespie read each student's accolades while Stinson provided them with a Certificate. Both students were congratulated by the Board.

- 7.2 Bond Refund/Presentation – Jason List from Isom Advisors provided a handout outlining a Refunding Overview of our 2015 General Obligation Bond.
- 7.3 Ag Alumni and Supporters Proposal (Board policy 3513.4)  
Katie Moos and Melanie Michel spoke on a proposal for their newly formed Ag Alumni Organization, which was created to give financial support to EN FFA/Ag students and program. They are working on their first fundraiser dinner which they would like to hold at the school, either in the Ag Barn or the Gym, in January, 2027. The Gym may be a better option for the first year since the bathrooms are nearby. They're trying to keep their overhead for this first-year fundraiser as low as possible to increase profits for the program. They're hoping to have 100-125 people attend and their goal is to raise \$50k. Alcohol will be served and the event will have security guards and no one under 21 will be allowed. This will be strictly enforced with multiple ID check locations. It was suggested that maybe Sutter Co Sheriff's Dept could have someone present as a community liaison. They would also like to include a gun raffle at the event, but the gun will not be present, just pictures of the item being raffled. The Board directed the Group to provide a copy of the ABC License as well as insurance certificates 60 days prior to Stinson and Foster. It was noted that ABC won't issue the license more than 30 days beforehand, but they plan to provide all necessary documents to the school.
- 7.4 Ag West – Community Stewardship Grant (submitted) – Stinson reported that about a year ago, John Amarel reached out to him about this opportunity. He stated we would need a sponsor and he was willing to sponsor us. Neil in turn reached out to Debbie Lauppe about the EN Alumni bleacher project and thought maybe this might be an avenue to get more funding for the project. Lauppe stated her niece worked at Ag West and she would be happy to work on completing the application with the help of her niece. The Grant is for \$100k. Neil said he thinks we (M&O crew) could handle the demo of the old bleachers, which would lower the cost. The original quote to Boosters included demolition of the old bleachers. He stated our shop program could use the boards for projects or maybe a possible fundraiser. The funds from the Grant will go directly to the Spartan Foundation and we should know in the next 30-45 days whether or not we will be awarded the grant.
- 7.5 GSPP Patient Care Status – Stinson gave updates on the GSPP Grant; we were originally funded for the planning stage (\$190k), but we were unable to draw any applicants for that position. He thinks because our scope was too broad. He recently found out that we were awarded \$210k to move forward. This Grant is a little longer and won't conclude until June, 2028. He thinks we could possibly find an Athletic Trainer for this position. He hopes to narrow down the position and we will need to complete budget development which is due May 4<sup>th</sup>. When asked what happened to the \$190 in planning funds, he stated we still had it and it can be rolled over to the next phase. He was also asked if there was student interest and he stated he thought so, as we have had interest in the past when we previously had Sports Medicine. He was also asked if we had room to house another program. He stated he thinks we could hold the class on the MPR stage, which is currently only being used by Band during 1<sup>st</sup> period.

## **8. REPORTS/UPDATES**

- 8.1 Student Body Report – Student, Emreana G. provided updates on recent events and activities on campus including the FFA Easter Egg Hunt, Prom coming this Saturday 4/18 and a Blood Drive coming in May. She's assisting with the 2026-27 Officer Elections. She reported that we will be holding a Student Council meeting next Monday and they are looking to approve a few amendments to the ASB Constitution, including a policy on dispersing "leftover" funds in dormant ASB Clubs. Board member Moore thanked her for the info and asked if the ASB Constitution needs to be approved by the Board. Roddick stated he wasn't sure. Coupé stated that she doesn't believe it's required but currently we do not have any policy for this and it's been questioned by the Auditor in recent years. Moore said it's ultimately "the student's money and they should decide what to do with it, not the board and as long as the Student Council is voting on it he doesn't see a problem."
- 8.2 Athletics – Mr. Coulter reported that Varsity Baseball and Softball are both having a good season; Baseball is currently 13-4, while Softball is 11-0. They are undefeated in League. Track and Golf are going well, though it's a little harder to gauge it due to the nature of both sports. Both have good participation. Football and Volleyball schedules are complete; Boys Basketball is also complete, still working on the Girls Basketball schedule. He asked about our Freshman Baseball program and he stated they are pushing through. Board member Moore pointed out that while their record reflects a 3-9 record, they have lost to some much larger schools, while beating Wheatland and some others. Coulter also stated they are working on finding a good date for the Meet-the-Spartans dinner. Engler

requested a financial report on the Freshman Baseball team from Coulter. Coulter stated we may need to wait till the season is complete to get the full financial picture.

8.3 Board of Trustees - None

8.4 Director of Student Guidance – Gillespie reported our Enrollment is currently 304 students; 204 coming from outside our district. The DOC application deadline is May 1<sup>st</sup> and we do have a wait list. Fales pointed out that he would like to see the class size cap drop to 90, it's currently at 100 (he stated we're not all in agreement on this) but we were too late this year to make adjustments, which needed to be done by October. VanDyke pointed out that each student represents roughly \$14k in revenue, so we need to be careful when adjusting class sizes/cap. Rebecca invited all Board members to attend the Academic E Banquet being held on May 14<sup>th</sup>, Dinner begins at 5:00 and we plan to begin awards at 5:30. We're almost done with Registration. {See additional notes from Gillespie's report attached}

8.5 Superintendent – Stinson reported that we completed the "March Madness" Attendance contest for the month of March. The Sophomore class edged out the Freshman by a slim margin to win a BBQ lunch that will be held for all Sophomore on Wednesday with our Culinary students organizing. We will also have an ice cream social for individuals with 2 days of 97% or better attendance. On discipline, we had 8 suspensions last month; 1 was for destruction of school property. We have 2 upcoming grants; one we've had previously, which is REAP and it's a Federal grant that funds teacher development, technology and improving basic instruction. It's geared for small, rural district. The other is for an approved LEA and it's generated from Prop 47, it would be for \$50/student, 3-year grant, which could generate a minimum of \$30k+. He feels he, Maria and Rebecca will be able to write the grant. We're currently looking for a date to hold Graduation Appeals, with 5-7 students possible. We'll be holding interview for Coupé's position later this week, as well as interviews for the Custodian/Janitorial position we have open. {See additional notes from Stinson's report attached}


