Parent read the following:

"CA Assembly Bill 1078 has passed both the assembly and the senate, and is currently on the governor's desk for signature. This bill, once signed, will counteract book banning in CA schools. Furthermore, it is an urgency bill, meaning as soon as it is signed, it takes effect immediately, rendering the proposed library policy in violation of state law.

It has recently come to the attention of a number of parents that the ACLU sent a letter to the board several weeks ago warning that the proposed library policy could end up costing our district money in litigation. Per board meeting agendas, it appears you all have had several closed session conferences with Legal Counsel about Anticipated Litigation. When will you be providing a copy of the letter from the ACLU in section 9.2 Correspondence Received by the Board, to date, for your constituents to review? When will you provide us with an accounting of counsel spend to-date on the proposed library policy? In our small district, where parents and teachers donate school supplies to ensure classroom needs are met, we deserve to understand when the fiscal solvency of our district is being compromised. Please do what is necessary to protect the district and not continue down a path that may result in harm to it." CW
