 - i. Suggestion to remove words "is a problem" to avoid stigma

 - 1. "Problem" is a word that increases stigma. Suggestion to use "concern" instead.
 - 2. Additional suggestion to remove word "negative" in second point. There is discussion around this idea because some impacts of teen pregnancy are negative, but we received community feedback to move away from the negative connotation/stigma.
 - ii. Motion to edit second paragraph to remove "negative", seconded.

 - iv. Motion to replace "significant problem" with "significant concern" in paragraph 1. Seconded.

 - d. Slide 52: suggestion to add information about impacts on teen fathers to give more balance to the slide. Additional suggestion to change 4th bullet to refer to "children of teen parents" instead of making it mother/father specific.
