5.2 Back to School 2025-2026

Ms. Drake reported a training was offered to teachers new to MCSOS on August 1st. All classrooms are staffed. A full-day training was provided on Monday regarding the new curriculum: Teach Town. Unique was the curriculum previously used. It required a lot of

staff time to print materials. It was not cost effective. Tuesday was the “kick-off” for all staff. Wes Kieschnick was the keynote speaker.

Mr. Cogan reported this is the second year of the reading initiative for CAES. He noted the good work completed by the Operations team, which has been running hard understaffed. Enrollment is being offered during the next two weeks. With the ICE sweeps, it is uncertain how successful enrollment will be.
