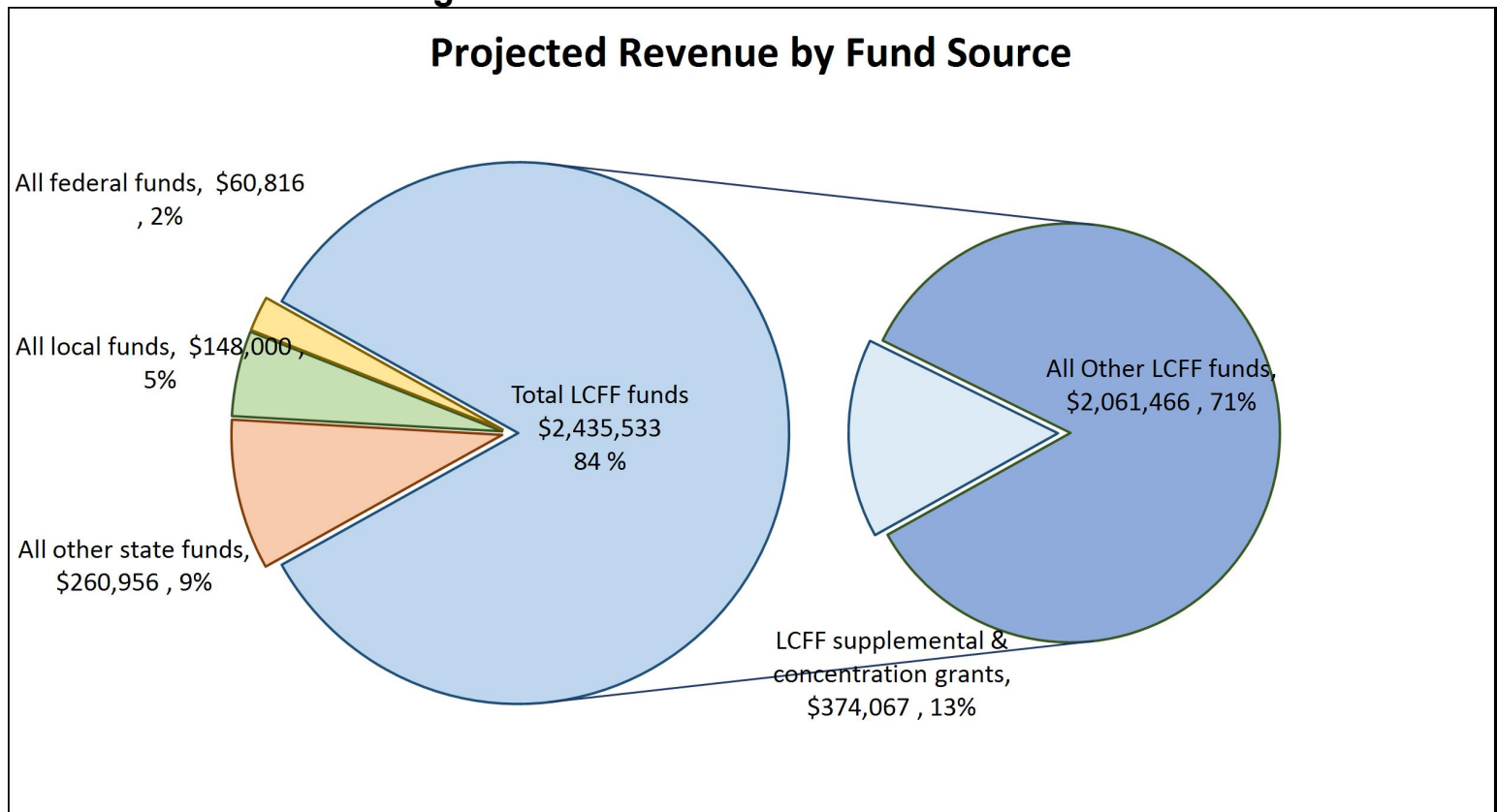

Budget Overview for the 2026-27 School Year

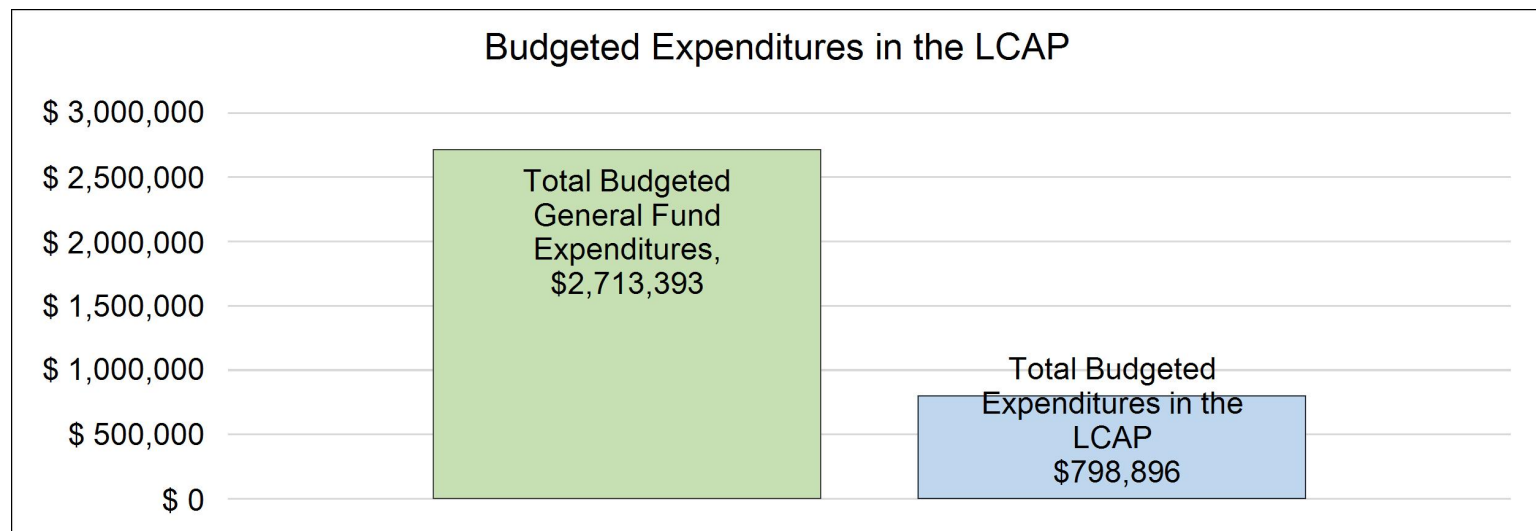


This chart shows the total general purpose revenue Thompson Peak Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Thompson Peak Charter School is \$2,905,305, of which \$2,435,533 is Local Control Funding Formula (LCFF), \$260,956 is other state funds, \$148,000 is local funds, and \$60,816 is federal funds. Of the \$2,435,533 in LCFF Funds, \$374,067 is generated based on the enrollment of high needs students (Foster Youth, English learner, and low-income students).

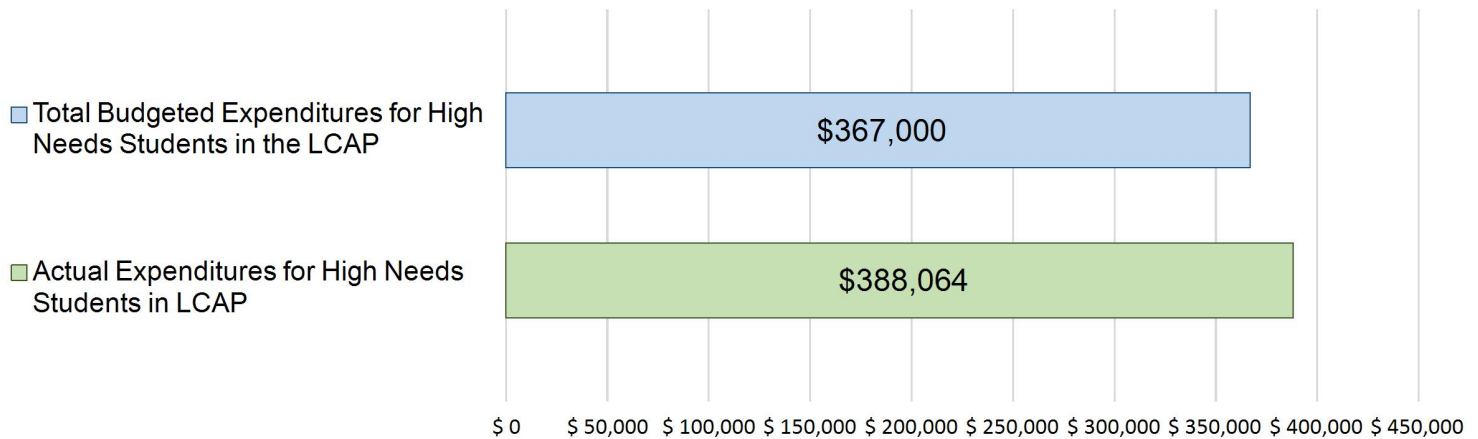
Increased or Improved Services for High Needs Students in the LCAP for the 2026-27 School Year

Plan Summary [2026-27]

General Information

Thompson Peak Charter (TPC) is authorized by Susanville School District for the period of 6/30/2027. Thompson Peak Charter is operated by Long Valley Charter School, a California non-profit corporation. Its main office is located in the Long Valley School in Doyle. The school serves students in grade TK-12 and provides a blended learning program through an independent study resource center. The 1.4 CALPADS Snapshot Report for the 2024-25 school year provides the following ethnicity/race of the 174 enrolled students. White: 109 or 62.64% Hispanic: 39 or 22.41% Multiple: 15 or 8.62% American Indian/ Alaskan: 6 or 3.45% African American: 1 or 0.57% Pacific Islander: 2 or 1.15% (2 or 1.15% missing) According to the 1.17 CALPADS Snapshot Report for the 2025-26 school year, Thompson Peak Charter has a total enrollment of 174 students in grades TK-12. Of those, 90 students of the population qualified for free or reduced-price meals. Two students identified as homeless. The total unduplicated count is 96 students or approximately 55% of the school's student population.

As of May 15, 2026, SEIS records indicate 22 students as having exceptional needs, representing 13% of the school's population.

Thompson Peak Charter actively identifies homeless students as part of the enrollment process. To better serve students experiencing housing insecurity, a housing information form is included as part of the enrollment packet, and office staff are trained to help families complete the form while at the same time looking for signs of inadequate housing. Signage describing student rights under the McKinney Vento Act are posted in conspicuous areas.

Partnering with Lassen County's Foster Youth Coordinator and other local foster agencies, Thompson Peak Charter works to provide a supportive environment for foster students, when enrolled. Credit waivers under AB 167 are available for consideration to assist such students in meeting graduation requirements.

The school provides an educational alternative for students in the Susanville area. During the Fall of 2023, TPC created and has continued to offer a "Home School Academy" to serve more traditional types of homeschool families. This program allowed for a greater level of parent involvement. The school identifies many of the students enrolled in the program as "high-risk" in areas of credit deficits and behavioral issues.

TPC vision statement is as follows: Thompson Peak Charter School envisions every student becoming lifelong learners, pursuing meaningful work, and participating in civic activities.

The charter is using this LCAP as it Single Plan for Student Achievement (SPSA) as permitted by law.

Thompson Peak Charter does not qualify for Equity Multiplier Funds.

2025-26 Dashboard Data Reflection -

Analysis of CAASPP Performance Data for 2025-26:

The 2025-26 CAASPP results for Thompson Peak Charter found growth over English Language Arts (ELA) but a recession in Mathematics from previous year results. In ELA, 40% of all students met or exceeded grade level standards, an increase of 3% from last year's results. Socioeconomically disadvantaged (SED) performed better than the whole student group with 44% on or above grade level standards. Our Students with Disabilities (SWD) group showed less proficiency with 0% of students at grade level, 44% of this group are in the Standards Nearly Met performance band. Additional support is needed for the SWD group. Math performance decreased by 5% from previous year results to 7% of all students meeting or exceeding standards. SED performance was consistent with the whole student group at 7% meeting or exceeding standards. SWD did not meet grade level standards, while 27% of this group nearly met standards. These outcomes highlight a need for additional focus in math across all student groups.

Local Assessment Data for 2025-26:

iReady diagnostic assessment data for 2025-26 school year demonstrates steady academic growth in both Reading and Mathematics. In reading, 39% of students performed on or above grade level up from 23% of students in fall. In addition to growth in the group of students on or above, we saw a decrease in the number of students at two or more grade levels below from 50% of students in the fall to 34% by spring. Based on iReady typical growth metric, the median student growth was 150%, with 61% of students meeting typical growth goals. Growth was seen across all grades using iReady (1st-11th grade).

Math results display a similar trend of growth; the movement between tiers was lighter. In fall, 7% of students were on grade level and 63% of students were 2 or more grades below. By spring, 17% of students were on or above grade level and 52% were 2 or more grades below. From iReady typical growth metric, the median student growth was 85% with 40% of students meeting their typical growth goals. Grades 1st and 8th grade showed good growth in math, while 3rd-5th grade showed some needs for additional support.

According to the 2023 California School Dashboard, two student groups, Socioeconomically Disadvantaged students and White students, performed in the lowest performance level in mathematics. This indicates a need for additional support in mathematics, which will be addressed through targeted tutoring and intervention services.

English Learner Achievement -

Not reported due to limited numbers and confidentiality.

Attendance -

The attendance data from Thompson Peak Charter over the past year showcases consistently high attendance rates that exceed the school's goal of 94% or better. In 2025-26, TPC had an attendance rate of 99.1%.

Graduation/Dropout Rates -

Thompson Peak Charter's high school graduation rate for the 2024-25 school year increased to 82.4%. This is a 3.2% increase from the previous year.

Behavior Data -

The school prides themselves on maintaining a record of zero expulsions and under 1% suspension rate. These efforts are a result of the successful implementation of schoolwide positive behavior supports.

During the 25/26 school year the school has continued to offer virtual mental health counseling services to students. The school benefitted from a wellness coach position to support staff and students.

CCI -

In 2025-26, 40% of the graduating seniors completed a CTE pathway. The area of A-G requires attention as no students graduated with a completed A-G pathway. This will continue to be an area of focus. A combined total of 81% of students were prepared or approaching prepared on the overall CCI scores due to dual enrollment college course credit completion.

School Climate - The Spring 2025 survey from Thompson Peak Charter shows overwhelmingly positive feedback about the school climate from parents, students, and staff. Parents consistently report high levels of satisfaction with school safety and communication regarding their child's learning progress.
Learning Recovery Emergency Block Grant Thompson Peak Charter has fully expended this grant during the 2025-26 school year. Goal 1 Action 3 (Instructional Materials) were partially funded with this resource as will Goal 2 Action 9 (Academic Performance Data). These uses are in alignment with Education Code 32526 c (E)-academic services such as diagnostic, progress monitoring, and benchmark assessments. This supports the school in the identification and support of specific students needing academic intervention.
Thompson Peak has developed and implemented classes in integrated math I and foundational math, which have seen high enrollment numbers. The school is utilizing the Modern Classroom Project format, providing recorded direct instruction, self-checks, and assessments, along with a structured path to unit completion featuring "must dos," "should dos," and "aspire to dos." The approach has proven effective in facilitating the development of self-paced lessons, particularly noted in the Integrated Mathematics I class, where students have positively reported on their experience with the units. As the school continues to track student achievement data for these classes, it plans to support this initiative with ongoing professional development opportunities.
The school continues to be guided by our strategic plan, which outlines clearly defined priorities to enhance our educational environment and improve student outcomes. The first priority is the development of a passionate and innovative staff committed to making learning engaging and meaningful. The second priority focuses on elevating student academic achievement through the design of effective instructional models that serve both independent study and traditional classroom settings. The third priority is ensuring a safe, healthy, and supportive school environment that fosters the well-being and success of all students.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

The development of our adopted LCAP was significantly shaped by the feedback provided by our educational partners, encompassing teachers, students, and parents, each bringing unique perspectives that directly influenced our strategic priorities and actions.

Teachers emphasized the need to improve student achievement in mathematics and English Language Arts, as measured by CAASPP. They advocated for targeted actions such as expanding direct instruction opportunities, providing curriculum training, and data driven intervention classes. Teachers also recommended ongoing refinement of the schoolwide writing project to better align with the independent study model, as well as adding lessons to the teacher repository to enhance student engagement and choice. Additionally, they expressed the importance of strengthening mental health support services to meet the broader needs of the student population.

Students voiced their appreciation for all that the school provides them and the caring relationships they have with their teachers. They feel safe and seen at the school. Specific actions created to reflect their sentiments included student-led conferences and implementing a social-emotional learning program.

Parents expressed the need for improved academic achievement for their children, and in response, the school implemented specific actions to address this. These actions include providing tutoring, offering hotspots and one-on-one devices, and adding additional paraeducators to support student success. Additionally, they voiced the importance of sustained and effective communication between the school and families to ensure that parents remain well-informed and actively involved in their children's education.

In response to these articulated needs, our LCAP has been crafted to prioritize these areas. It includes strategic measures to elevate academic performance through enhanced instructional training and support for teachers, bolster mental health services and initiatives to support student well-being, and improve communication channels to ensure continuous engagement with parents. By integrating this feedback into our LCAP, we aim to create a more inclusive, effective, and supportive educational environment that aligns with the needs and goals of our school community.

The public hearing for the LCAP was held on June 17, 2026 and the LCAP was adopted on June 17, 2026.

By identifying areas for growth and excellence, we ensure that our instructional staff is always improving. Additionally, we invest in professional development, specifically in mastery-based learning, to empower teachers to implement personalized, student-centered instruction that meets the varied learning paces and styles of our students. Encouraging enrollment in foreign language courses is another critical component, broadening students' cultural perspectives and enhancing their global competencies. Finally, we aim to instill a sense of student agency, helping students believe in their ability to influence their learning and outcomes. By fostering an environment where students feel empowered and engaged, we prepare them for lifelong learning and success. Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

The actions identified within this goal were implemented as planned and adopted, reflecting strong progress toward the goal. Three actions were partially implemented due to staffing limitations:

1. Training/Support for Academic State Standards was not fully implemented, Action 1.6, due to lack of qualified staff available to lead and sustain the training calendar. Competing administrative priorities further constrained full implementation.
2. ELD trainings were not completed, Action 1.6, due to lack of staff available to lead trainings.
3. Essential Standards refinement beyond ELA was not fully completed, Action 1.9, due to staff shortages that limited the capacity to address the required components of the work.

Successes for this goal include every student having access to standards-aligned instructional materials both at school and at home, consistently achieving 100% across all years measured. The school's one-to-one device program, hotspot distribution, and online coursework provisions were particularly impactful for students participating in independent study, ensuring that socioeconomically disadvantaged students had uninterrupted access to their education regardless of location. Additionally, the school maintained 100% enrollment in a broad course of study across all years measured.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Based on a review of metrics and outcomes, the implementation of actions within Goal 1 reflected varying levels of effectiveness, with the majority of actions producing meaningful results.

Teacher Quality and Credentialing (Actions 1.1 and 1.2 | Metrics 1.1 and 1.9): Actions 1.1 and 1.2 were effective. All teachers remained properly assigned throughout the measured period. Through Action 1.2, teacher self-reported ratings on instructional competencies improved from 2.43 in Spring 2025 to 2.88 by Spring 2026, reflecting meaningful growth in teachers' ability to apply and integrate effective teaching strategies across their instructional practice, exceeding the Year 3 target of 2.5.

Instructional Materials and Technology Access (Actions 1.3, 1.4, 1.5, and 1.11 | Metrics 1.2 and 1.5): Actions 1.3, 1.4, 1.5, and 1.11 supporting instructional materials and technology access continued to be effective in ensuring equitable access for all students. All students maintained access to standards-aligned instructional materials and a broad course of study with no change from baseline.

Standards Implementation (Actions 1.5 and 1.6 | Metrics 1.3 and 1.4): Action 1.6 was effective as staff survey data reflects meaningful gains across multiple subject areas from Year 1 to Year 2, with progress noted in ELD standards from 2.67 to 3.29 and HSS from 2.89 to 3.14.

While some areas experienced declines between Year 1 and Year 2, the recent hire of an instructional coach is anticipated to stabilize and rebuild progress toward the Year 3 targets.

ELD Standards Training (Action 1.7 | Metric 1.4): Action 1.7 was ineffective as the planned Universal Design for Learning trainings and instruction on utilizing embedded ELL materials were not completed due to a lack of available staff to lead the trainings. While staff survey ratings showed modest but consistent improvements, all measures remain below the Year 3 target of 3.5. . The school contracted with a coach who began providing ongoing Universal Design for Learning (UDL) training in March 2026. The coach will continue working with staff throughout the 2026–27 school year to strengthen understanding and implementation of UDL principles. In addition, the recent hire of an instructional coach has increased the school's capacity to plan, coordinate, and deliver standards-based and ELD trainings, providing more consistent support for staff implementation in the coming year.

Career and College Counseling (Action 1.8 | Metrics 1.6 and 1.7): Action 1.8 was effective as the career and college counselor met individually with all students throughout the year, providing personalized support for academic and career planning.

Essential Standards Development (Action 1.9 | Metric 1.10): Action 1.9 was ineffective. While ELA essential standards were developed in the prior year, no additional essential standards work was completed in math, science, or social studies during 2025-26. Staff shortages prevented the school from advancing the required components of this work beyond what had previously been established. The school will focus on math essential standards development in 2026-27.

Teacher Educational Resources/Repository (Action 1.10 | Metric 1.11): Action 1.10 was effective as the teacher educational repository continued to be developed and refined throughout the year, providing teachers with increased access to shared lesson plans, projects, and remediation materials. While student satisfaction data reflected some declines in Year 2, continued refinement of the repository is anticipated to support improvement in student engagement and ownership of learning in the coming year.

Teacher Competencies (Action 1.2) will be modified by removing the monthly professional development sessions accessible via the LVCS hub. This adjustment allows the school to concentrate efforts on identifying and refining teacher competencies through structured feedback and evaluation meetings, ensuring that professional growth is directly assessed and aligned with educational goals and standards.

Training/ Support for Academic State Standards (Action 1.6) will be modified to reflect the transition from the Curriculum and Instruction Administrator position to an Instructional Coach, and the training timeline will be updated to remove the specification of weekly trainings, allowing for greater flexibility in scheduling trainings to meet staff needs.

Career & College Counselor (Action 1.8) will be modified to broaden the scope of support by replacing the designated career and college counselor position with a staff member providing targeted support. This modification ensures consistent availability of personalized student support regardless of staffing changes.

Essential Standards (Action 1.9) will be modified to focus solely on the development of math essential standards for the 2026-27 school year, reflecting the need to concentrate efforts on advancing the required components of this work before expanding to additional content areas.

All other goals, metrics, target outcomes, and actions remain unchanged for the coming year.

An explanation of why the LEA has developed this goal.

This goal ensures all students demonstrate growth toward meeting or exceeding standards in English Language Arts (ELA) and math assessments, while increasing career and college preparedness, is a response to the significant academic challenges our students face. This goal aligns with State Priorities 4, 5, 7, and 8, emphasizing academic achievement and readiness for post-secondary success.

Recent assessment data highlights the urgency of this goal. Over several academic years, Thompson Peak Charter School has experienced concerning trends in student performance in both ELA and math across various groups. From the 2018-19 to 2022-23 school years, ELA performance has seen a slight decline and modest recovery, with a dip from 30.14% to 26.31%, while Math scores fell from 13.7% to 10.42%. Students with disabilities (SWD) in both subjects dropped to 0% performance in the 2020-21 and 2022-23 school years requiring immediate attention and response. Socioeconomically disadvantaged (SED) students are of special concern as this group faced declines in both subjects. Because of SED math performance, specific actions including individualized tutoring and direct instruction with foundational math within this goal have been developed. The school has recognized an urgent need for targeted interventions, classroom paraeducator support, and , setting future performance targets at 38% for all students in ELA, 20% in Math, 20% for SWD in ELA, 14% in Math, and 35% for SED in ELA, 18% in Math to improve outcomes.

The school will prioritize improving writing skills across all grade levels, identified as a critical area of need through both quantitative and qualitative data. By enhancing writing instruction, we aim to support overall literacy development, which is foundational to success in all subject areas. Project-based learning is also an area of interested growth for the school and metrics and actions have been created to ensure production in this area.

To ensure a steady increase in CCI data, the school recognizes continuing actions and metrics that support dual enrollment as well as CTE exploration.

This goal reflects our commitment to addressing academic deficiencies and ensuring all students are prepared for college and career success.

The actions identified within this goal were implemented as planned and adopted, reflecting the school's continued commitment to improving instructional practice and supporting student learning. One Action was not fully implemented:

1. Project-Based Learning professional development and course development were not completed, Action 2.14, due to staffing shortages and the elimination of the Curriculum and Instruction Administrator position. As a result, teachers did not receive the planned training and were unable to begin development of new project-based learning courses during the 2025–26 school year.

Successes within this goal include a growing number of seniors completing CTE pathways, reflecting the effectiveness of expanded course offerings and dual enrollment opportunities. All students had access to their own copies of standards-aligned instructional materials for use at school and home, and 100% of students were enrolled in a broad course of study.

Based on a review of metrics and outcomes, the actions implemented within Goal 2 reflected positive progress toward the goal, with the majority of actions producing meaningful results for students.

Tutoring & Support (Action 2.1 | Metrics 2.1 and 2.2): Action 2.1 was effective as tutoring, Rtl services, and supplemental learning materials provided students with an additional layer of academic support, contributing to growth in student performance.

Focus on Foundational Mathematics (Action 2.2 | Metric 2.2): Action 2.2 was effective as direct instruction in foundational math skills supported students below grade level in building mastery toward high school level mathematics, with continued progress noted from Year 1 to Year 2.

Individualized Learning Plan (Action 2.3 | Metrics 2.12 and 2.13): Action 2.3 was effective as individualized learning plans supported teachers in monitoring student progress and implementing targeted intervention strategies, reflecting continued refinement of support.

A-G Coursework (Action 2.4 | Metrics 2.8 and 2.9): Action 2.4 was effective in expanding course options with the rigor necessary for A-G completion, with continued efforts to build on Year 1 progress in providing students greater access to college preparatory coursework.

Career Technology Education/Dual Enrollment (Action 2.5 | Metrics 2.10 and 2.11): Action 2.5 was effective as expanded dual enrollment opportunities built upon Year 1 gains, providing students with greater access to college coursework and contributing to sustained CTE pathway completion rates.

Career/College Counseling (Action 2.6 | Metrics 2.9, 2.10, and 2.11): Action 2.6 was effective as the counselor met individually with students to support career and life planning, with CCI outcomes.

Schoolwide Writing (Action 2.7 | Metric 2.16): Action 2.7 was effective as focused writing instruction and professional development contributed to sustained growth in the proportion of students meeting writing standards from Year 1 to Year 2.

Paraeducator Support (Actions 2.8 and 2.11 | Metrics 2.1 and 2.2): Actions 2.8 and 2.11 were effective as paraeducator support provided all students, including students with disabilities, a consistent additional level of academic assistance, contributing to progress.

Academic Performance Data (Action 2.9 | Metrics 2.12 and 2.13): Action 2.9 was effective as data analysis continued to support administration and teaching staff in monitoring student academic growth and refining instructional decisions.

Supporting Students with Disabilities (Action 2.10 | Metrics 2.1 and 2.2): Action 2.10 was effective as regular oversight of special education staff supported continued progress monitoring for students with disabilities.

Student-led Conferences and Goal Setting (Action 2.12 | Metric 2.12): Action 2.12 was effective as students met regularly with teachers to review academic progress and set individual learning goals, supporting student ownership of learning within the independent study model.

Project-Based Learning (Action 2.14 | Metric 2.16): Action 2.14 was ineffective. No documented PBL projects were completed within standards-based courses in either Year 1 or Year 2, and planned professional development to support teachers in PBL design and implementation was not completed due to staffing limitations. As a result, the school has determined it is necessary to remove this action.

The Modern Classroom Project (Action 2.14 | Metric 2.17): Action 2.14 was effective as mastery-based courses continued to engage students and support growth in mathematics performance, building on the foundation established in Year 1.

Independent Study Direct Instruction (Action 2.15 | Metrics 2.1 and 2.2): Action 2.15 was effective as requiring students below grade level to attend regular direct instruction sessions in core subjects provided structured academic support, contributing to continued progress from Year 1 to Year 2.

Tutoring and Support (Action 2.1) will be modified to reflect the use of AI tools for personalized tutoring support, rather than specifying a particular platform, allowing for greater flexibility in tool selection. Additionally, HIT Tutoring will be added as a schoolwide tutoring program to provide targeted academic support for students in need.

Focus on Foundational Mathematics (Action 2.2) will be modified to reflect the designation of a staff member to serve in the role of math specialist, providing direct support to students in foundational mathematics instruction.

Career/College Counseling (Action 2.6) will be modified to reflect the transition from a dedicated Career and College Counselor position to a staff member who will assume the responsibilities of college and career advising, ensuring continued support for students in grades 7-12 in navigating college and career pathways.

Schoolwide Writing (Action 2.7) will be modified to replace references to professional development with trainings, allowing for greater flexibility in supporting staff implementation of schoolwide writing efforts.

Project-Based Learning (Action 2.14) will be eliminated from the LCAP due to staffing limitations and the school's need to focus energy and resources on other priority actions that reflect a greater need for improved academic outcomes.

Analyzing the metrics of priorities 3, 5, and 6, which address "engagement," led to the development of this goal. As a school of choice that emphasizes parent involvement, we have many positive metrics in areas such as parent input and involvement, connectedness, and safety. Some actions are focused on maintaining and increasing these positive statistics. TPC prides itself on having a low chronic absenteeism, zero suspension and expulsion rate. A key focus is enhancing support for student mental health. Post-COVID-19, a higher than desired number of students have reported prolonged sadness and stress, according to recent surveys. This concern has been acknowledged by both staff and families, leading to prioritized actions such as implementing a Social Emotional Learning (SEL) curriculum and providing mental health counseling to students. Additionally, safety planning has been completed, and training will ensue. Efforts to support anti-bullying and classroom management are also prioritized actions within this goal. By addressing these concerns, we aim to create a more supportive and engaging school environment for all students. Progress towards this goal will be measured by the metrics listed below.

Parent/Family Outreach (Action 3.1 | Metric 3.2 and 3.3): Action 3.1 was effective as multiple surveys and outreach efforts were conducted throughout the year, maintaining high levels of parent involvement and satisfaction with school engagement opportunities.

Parent Communication (Action 3.2 | Metric 3.11): Action 3.2 was effective as continued use of Parent Square and the school website supported consistent and accessible communication between the school and families, with parent satisfaction remaining high from Year 1 to Year 2.

Credit/Course Monitoring (Action 3.3 | Metric 3.7 and 3.8): Action 3.3 was effective as close monitoring of student credit attainment supported efforts to reduce dropout rates and keep students on track toward timely graduation.

- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
