Breaker Families, welcome to the 2026-2027 school year. To ensure your student(s) are prepared to start school on Wednesday, August 5th, please review and complete the required information below by the indicated dates.

### **Synergy Registration:**

Current PGUSD families received an email reminder in April to log in to their Synergy ParentVUE accounts. Parents/Guardians will need to complete the Synergy online registration process by Thursday, June 11th, for their students to participate in our Breaker Nation Events that follow. **Students whose registration has been submitted and approved will be able to access their class schedule in their Synergy StudentVUE portal on August 4th.**

**For Synergy Registration, please be prepared to upload:**

- A current copy of your lease or proof of home ownership (*see reverse side for details*)
- A current copy of a utility bill (*no older than 30 days*)
- Upload all required registration forms to Synergy

# **Frequently Asked Registration Questions**

**1. We recently moved, and we don't have a utility bill. What do I need?**

Please provide a current copy of your rental/lease agreement to Summer Coe in the Counseling Office. We will need a copy of your first utility bill within 30 days after we've received your rental/lease agreement.

**2. I uploaded my lease or proof of homeownership last year, and we haven't moved. Why do I have to upload it again?**

Our district policy requires an annual update of proof of residency.

**3. I have a Shared Residency/Caregiver Affidavit/Inter-district transfer as proof of residency. Is it still valid for the new school year?**

No. The district office requires that residency approval be renewed on an annual basis. Please contact the District Office at 831-646-6517.

**4. My lease includes all utility bills, so I don't have a utility bill to upload.**

When uploading your lease, please highlight or circle the area that shows what utilities are included in your contract. Otherwise, please provide two first-class mail pieces, such as proof of insurance and/or a current bank statement.

## **Approved Proof of Residency Documentation**

**1. For Homeowners:**

A current mortgage statement, tax bill, deed, affidavit of title, or settlement statement, and a current PG&E bill, water bill, or cable bill. We cannot accept cell phone or telephone bills.

**2. For Renters:**

Current lease with all adults and children listed, or a completed Landlord Affidavit. The district will contact the current landlord/property management company to confirm any tenants not listed on the lease and a current PG&E bill, water bill, or cable bill. We cannot accept cell phone or telephone bills.

**3. For Shared Residency & Caregivers:**

If the person with whom you are living owns the house you share, or if the caregiver owns the house, they provide:

1. A current mortgage statement, tax bill, deed, affidavit of title, or settlement statement, and a current PG&E bill, water bill, or cable bill.
2. Persons requesting Shared Residence or Caregiver would also provide a photo ID.
3. If your student will be living with a relative or legal guardian, please contact our District Office at 646-6517 to apply for a Caregiver Affidavit. If the student will be living with a family friend or relative who is not a legal guardian, please contact the District Office for more information.
