PART A - BIDDING AND CONTRACT REQUIREMENTS

The bid date has not changed. Bids are due Monday, January 30th, 2026, by 2:00 p.m. at the Washington Unified District Office, 930 Westacre Road, West Sacramento, CA 95691

Q: Can the work be performed during school hours or do we need to do the work during the weekend?

A: Yes, work can be performed during school hours.

Q: Is this project prevailing wage?

A: Yes

PART B – SITE AND MAIN STRUCTURE INFORMATION

Q: What is the exact location of the proposed building?

A: The building will be located within the perimeter boundary identified within Exhibit A. Campus address is 1 Raider Ln, West Sacramento, CA 95691

Q: What is the size of the building footprint?

A: In the range of 18,000 – 22,000 square feet. Building has not been designed, to be determined.

Q: How many stories will the proposed building have?

A: Single story building with high ceiling suitable for a high school Performing Art Center

Q: Will the proposed building includes a basement?

A: No basement may have an Orchestra pit.

Q: Will the building have a high or domed ceiling?

A: Yes

Q: Will the building include balconies?

A: Building has not been designed, to be determined.

Q: Will the building include a receiving/loading dock?

A: Building has not been designed, to be determined.

Q: Are there any stormwater management facilities that will require percolation testing?

A: Building has not been designed, to be determined. The building must comply with all federal, state, and city environmental regulations.

Q: Will there be any detached or attached changing rooms or storage rooms?

A: Building has not been designed, to be determined.

Q: Will there be paved parking spaces and driveway surrounding the building?

A: Yes

Q: Are there plans for site retaining walls? Are pavement recommendations needed?

A: No plans for adding a retaining wall. Building has not been designed, to be determined.

Q: What are the requirements for soil cuttings?

A: The current project site has a levelled surface. However, the building and landscape have not been designed yet.

Q: Does the District have any existing geotechnical/geological reports for the campus? If so, can we have a copy.

A: District do not have any existing geotechnical/geological reports for the campus.

Q: Is there a preliminary conceptual plan for the planned improvements besides Exhibit A?

A: No

Q: Are there any proposed shade structures?

A: Building has not been designed, to be determined.
