

RESIDENCY REQUIREMENTS

(For parents/guardians enrolling students)

The Coronado Unified School District may only enroll students whose parent/guardian resides within the school district boundaries or students who have approved interdistrict transfer. This form is designed to verify residency in a specific school's

attendance area.

- Residency is defined as meaning the student is living a majority of the time at the address specified with the parent/guardian
- Each student may claim only one residence and the address must be located within the CUSD boundaries.
