5.2 Report from closed session.

Discussion:

As you know, our superintendent, Ms. Kathy Miracle, will be leaving GOUSD. After careful discussion and consideration, the GOUSD Board has decided to appoint an Interim GOUSD Superintendent/Principal of Pleasant Valley Middle School. Mrs. Deborah Atkins has been offered the position and has accepted. While Mrs. Atkins serves in this role, we need to appoint an Interim Principal for Gold Oak Elementary. Mrs. Sarah Carlin has been offered this position and has accepted. The appointment of an interim superintendent/principal and interim elementary principal will allow necessary time for our Board to meet with Dr. Ed Manansala, the El Dorado County Superintendent of Schools, and his team while we launch our superintendent search and follow a thorough process. Dr. Manansala and his team will be meeting with our Board during the Closed Session of our next General Board Meeting on Tuesday, June 25th, to continue the discussion and guidance of our process and timeline.

The Gold Oak Union School District Board is pleased that Mrs. Atkins has accepted the Interim Superintendent/Principal of Pleasant Valley Middle School position. Mrs. Atkins has previously served seven years in administration, two of which have been as the Gold Oak Elementary School Principal. Mrs. Atkins is a proven leader who works alongside her supportive staff to create a student-focused school environment which welcomes families and the community. Ms. Miracle and Mrs. Atkins will begin working toward a seamless transition immediately. Mrs. Atkins will begin her work in this role on July 1, 2024. We are also pleased that Mrs. Carlin will serve as the Interim Gold Oak Elementary School Principal. Mrs. Carlin has served as a respected teacher at Gold Oak Elementary for eleven years. She obtained her Master's Degree in Educational Leadership with an Administrative Services Credential in 2014.

Both Mrs. Atkins and Mrs. Carlin are excited to lead within the Gold Oak Union School District while our Board works with Dr. Manansala and his team throughout the superintendent hiring process. Thank you for your continued support!
