All students are given their own individual standards aligned textbooks and/or instructional materials in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the State Department of Education, making the textbooks used in the school the most current available. Standards aligned materials are reviewed by the certificated staff and a recommendation is made to the School Board. All recommended materials are available for parent examination at the district office prior to adoption.
