The preparation included, but was not limited to students taking practice tests (Interim Assessments) to prepare for the exam.

 - We discussed that in the past that students who meet the criteria for reclassification and hence reclassify from an English Learner (EL) to Redesignated Fluent English Proficient (RFEP) received the following recognition last school year: Recognition at the school's awards assembly with a certificate of achievement and a certificate for a free pizza at Me n Eds. This year, we would like to continue recognizing students at the awards assembly with the certificate of achievement and a voucher for a free meal, however we also would like to give them a t-shirt that acknowledges their accomplishment.
