



# Proof of Residency

## Lampasas ISD

**Students are required to provide proof of physical residency when enrolling as a:**

- New student to Lampasas ISD
- Returning student
- Current student who has had a change of address

**Acceptable forms of documentation required and/or allowed to establish proof of residency in Lampasas ISD include:**

- A utility bill of services received, dated within the last 30 days that indicates address in parent/guardian's name (preferred) **or**,
- Lease agreement in parent/guardian's name (additional documentation may be required to verify residency) **or**,
- If the proof of residency documentation is not in the parent/guardian's name, the following must be provided: A notarized signed/dated "Verification of Address From Property Owner" with whom the student resides, along with a utility bill of services received, dated within the last 30 days for the homeowner/lessee along with the homeowner/lessee's ID.

\* *A bill must be a service to the home where the student resides.*

**\*Please note that falsifying education records is a criminal offense under Section 37.10 of the Texas Penal Code and could subject the person submitting the falsified record(s) to liability under Section 25.001(h) of the Texas Education Code.**

**\*\*Lampasas ISD retains the right to send a school representative to verify the residence of any specified student(s) at any time.**
