PUBLIC HEARING: CJUSD PRELIMINARY BUDGET FOR FISCAL YEAR 2026-2027

The purpose of this portion of the meeting was to set aside time to provide information to the public and to receive public comments and input on the district's budget for the upcoming year.

The Public Hearing on the CJUSD Preliminary Budget for Fiscal Year 2026-2027 was opened at 6:42 p.m. Lisa Coronado, Director of Fiscal Services, noted that her numbers are based on the May Revise from the Governor's office. She shared the following slides: 2026-2027 CA Governor's May Budget Revision; District ADA, Enrollment, and Rate; General Fund - Revenue vs. Expenditures; Reserves & Ending Fund Balance; 2026-27 Site and Department Budget Allocations; 2026-27 Departmental Budget Review Process; Budget & LCAP – 2026-2027; Status of Labor Negotiations; Other Funds – 2026-27 Budget; and Conclusion.
