School Year 2022-2023

Senate Bill 9 anytime child abuse, dating and family violence and/or sex trafficking is addressed there must be Board and parent approval.

Parents must now opt in to this instruction.

It is optional for students to participate. These new violence prevention TEKS mirror the process for sex ed.

Counselors visit students at least 8 times a years . What is the best way to get permission slips to students?

Violence Prevention will be part of Guidance lessons to allow more opportunities for this information.

Guidance Lessons gives the opportunity to reinforce what's taught in Health.
