Discovery Elementary School is a UTK-5th grade comprehensive school that serves a diverse population of scholars, including four SDC classes for students with exceptional needs and one 3rd/ 4th CUBS class designed as an alternative classroom setting for children utilizing behavioral and social emotional skill building strategies. Our goal is to educate the whole child by ensuring access to rigorous core and supplemental content, providing multiple opportunities for scholars to learn at the level and time they need while engaging with grade level standards and the demands of 21st century learning. Discovery Elementary is committed to elevating instructional rigor and academic language development to improve scholar performance in English Language Arts and Mathematics across all student groups by 2026. We are also prioritizing meaningful family engagement by expanding school-led workshops designed to strengthen the home-school partnership and align supports for every scholar. In

addition, we are enhancing student success and well-being by implementing restorative and Social-Emotional Learning practices, reducing suspensions, and significantly decreasing chronic absenteeism so scholars remain connected, supported, and fully engaged in their learning. Guided by our mission to provide a safe, equitable, and rigorous environment that embraces diversity, and our vision to inspire the traits of STARS one day at a time; Stay Safe, Take Responsibility, Aim, High, Respect Everyone, and Shine Bright. Discovery remains committed to excellence. We also offer a wide range of enriching clubs and extracurricular activities including Folklorico, Mariachi, Cheer, Hip Hop Dance, Board Games Club, LEGO Club, Golf Club, Bowling Club, Spanish Club, and our Run and Reflect Wellness Club, giving scholars meaningful opportunities to explore interests, build confidence, and connect with peers.

To support positive, inclusive, and structured play, Discovery Elementary implements Playworks elements throughout all recess and lunch periods. Our supervision and coaching team facilitates daily games and activities, and our supervision aide team plays a vital role in reinforcing expectations, maintaining safety, and ensuring that scholars have consistent and engaging experiences during unstructured times. Discovery Elementary also implements Positive Behavior Intervention and Support and Capturing Kids Hearts as foundational frameworks. Expected behaviors are taught, modeled, and positively reinforced, while our SEL teacher and dedicated SEL classroom offer scholars direct instruction in emotional regulation, problem solving, and relationship building. Our counseling team collaborates closely with the SEL teacher to align interventions, strengthen schoolwide SEL practices, and ensure cohesive social emotional support for all scholars.

During the 2024–2025 school year, our counseling team and administrative team began the site-wide implementation of restorative practices. This effort reflected our growing commitment to providing scholars with supportive, developmentally appropriate responses and utilizing other means of correction that strengthened social-emotional learning, built relationships, and promoted the overall SEL growth of every scholar we served.. Beginning this current 2025 2026 school year, Discovery is implementing sitewide restorative practices to further support scholar voice, conflict resolution, emotional regulation, and community building. This intentional shift enhances our commitment to the social emotional development of each and every scholar we serve. Our two full time school counselors, campus supervisor, supervision aide team, teachers, staff, and administration work together to promote safety, belonging, and connection throughout the school day.

School Facility Conditions and Planned Improvements

General

The district takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument developed by the Los Angeles County Office of Education. The results of this survey are available at the school office or at the district office.

Maintenance and Repair

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

Cleaning Process and Schedule

The district governing board has adopted cleaning standards for all schools in the district. A summary of these standards is available at the district office. The facilities department works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance Budget

Although the State no longer requires a Deferred Maintenance contribution, Lancaster School District is still dedicated to maintaining the facilities for our students. These expenditures would include but not be limited to roofing, plumbing, heating, air conditioning, electrical, painting, and flooring. For the 2024-25 school year, the district has budgeted \$2,683,000. for deferred maintenance projects.

Support is always readily available for any parent or partner who wishes to complete the volunteer process. Families may volunteer regularly to support PBIS initiatives such as our Rocket Ticket Store, assist in the library, participate in book fairs and fundraisers, and contribute to a variety of community school events. Additionally, all parents and partners are invited to attend our major annual events, including the Welcome Back Event, Back to School Night, Hispanic Heritage Celebration, Black Heritage Celebration, Cultural Nights, Home/School Connection Parent Workshops, Podcast Digital Series sessions, Open House, and Family Curriculum Nights.</p> <p>Finally, we strongly encourage parents and partners to share their voices through active participation in school leadership committees such as School Site Council (SSC), English Learner Advisory Committee (ELAC), African American Advisory Council (AAC), and Coffee with the Principal. Our Family Ambassador and Community Liaison play a central role in supporting family engagement, ensuring access to volunteer information, event announcements, meeting opportunities, and feedback processes that guide continued engagement.</p>

Professional Development

The Lancaster School District provides professional development throughout the school year that trains and supports staff in the effective implementation of our adopted core and cornerstone programs including, but not limited to: Teacher Clarity, PLC+, Standards-Based Grading and Reporting, Structured Literacy, Data Analysis, Leadership Training, Writing Instruction, Coaching, Direct Instruction, Conceptual Development, Building Academic Vocabulary, Culturally Responsive Teaching and Learning (including Capturing Kids Hearts), Integrating Technology into the Classroom, PBIS, Intervention, and Differentiation in Strategies for teaching Multilingual Learners and at-risk students. High-quality, ongoing professional development opportunities are recognized as an important component in our work towards continuous improvement in student learning.

Ongoing opportunities include in-services during and after the work day as well as through site and district in-class and on-site coaching. All teachers are provided multiple opportunities to receive optional paid professional development. The school year calendar allows for 37 minimum days in which 26 days are utilized to provide 1-2 hours of district and site designed professional development specific to their needs. Outside workshops, conferences and other in-services that provide more in-depth training and further prepare our staff members to become trainers for our district are available as approved by the Board of Trustees.

Professional development supporting our instructional programs and services for students is also provided for our classified staff members. Additionally, workshops designed to improve technology skills, provide training with key software programs utilized in the district, and offer information on personal excellence and social responsibility are included in the professional development course offerings for classified staff throughout the school year.
