Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. At RISE, we understand that academic progress is deeply connected to emotional well-being. That's why our approach blends high-quality instruction with intensive social-emotional support. Students engage in learning that promotes interpersonal skills, anger management, personal responsibility, collaboration, self-reflection, and emotional regulation. Programs such as

Capturing Kids’ Hearts, Restorative Practices, and Second Step help nurture respectful, supportive relationships between students and staff. To reduce chronic absenteeism and suspensions, we monitor key indicators weekly and provide proactive interventions. Counselors, administrators, mentors, and a registered behavior technician work closely with students to build positive connections and a strong sense of belonging. Tools like Habits of Mind and Sown to Grow help students identify emotions, develop problem-solving skills, and take ownership of their learning journey.

Our instructional approach includes Project-Based Learning (PBL), which encourages students to engage deeply with content while working individually and collaboratively to solve real-world problems. Regular use of formative and summative assessments allows educators to identify learning gaps and provide timely academic and emotional interventions. We reinforce positive behavior through a school-wide Positive Behavior Intervention and Support (PBIS) framework, celebrating students who embody the character traits and life skills we teach. School Facility Conditions and Planned Improvements

General The district takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument developed by the Los Angeles County Office of Education. The results of this survey are available at the school office or at the district office. Maintenance and Repair District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. Cleaning Process and Schedule The district governing board has adopted cleaning standards for all schools in the district. A summary of these standards is available at the district office. The facilities department works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school. Deferred Maintenance Budget Although the State no longer requires a Deferred Maintenance contribution, Lancaster School District is still dedicated to maintaining the facilities for our students. These expenditures would include but not be limited to roofing, plumbing, heating, air conditioning, electrical, painting, and flooring. For the 2024-25 school year, the district has budgeted \$2,683,000. for deferred maintenance projects.

Professional Development

The Lancaster School District provides professional development throughout the school year that trains and supports staff in the effective implementation of our adopted core and cornerstone programs including, but not limited to: Teacher Clarity, PLC+, Standards-Based Grading and Reporting, Structured Literacy, Data Analysis, Leadership Training, Writing Instruction, Coaching, Direct Instruction, Conceptual Development, Building Academic Vocabulary, Culturally Responsive Teaching and Learning (including Capturing Kids Hearts), Integrating Technology into the Classroom, PBIS, Intervention, and Differentiation in Strategies for teaching Multilingual Learners and at-risk students. High-quality, ongoing professional development opportunities are recognized as an important component in our work towards continuous improvement in student learning.

Ongoing opportunities include in-services during and after the work day as well as through site and district in-class and on-site coaching. All teachers are provided multiple opportunities to receive optional paid professional development. The school year calendar allows for 37 minimum days in which 26 days are utilized to provide 1-2 hours of district and site designed professional development specific to their needs. Outside workshops, conferences and other in-services that provide more in-depth training and further prepare our staff members to become trainers for our district are available as approved by the Board of Trustees.

Professional development supporting our instructional programs and services for students is also provided for our classified staff members. Additionally, workshops designed to improve technology skills, provide training with key software programs utilized in the district, and offer information on personal excellence and social responsibility are included in the professional development course offerings for classified staff throughout the school year.
