 - i. Discussion of health topics covered the last 3 months
 - ii. Health education, safety activities, speakers & screenings
 - iii. Immunizations up to date, with 2 on a catch-up schedule and 1 provisional; 28 affidavits on file to waive immunizations
 - iv. 4 flu cases, 1 case RSV, 1 rhinovirus, 7 Covid cases, 2 strep throat, 2 fractures
 - v. 1015 total nurse visits
 - vi. Ccma students shadowing beginning in November
 - vii. Nurse Tatum presented for Coach Roberts
 - 1. Marathon kids, 3 days per week; adopted military unit coming soon to do boot camp exercise; planning on trying pickleball later this year

 - 1. Trouble with consent forms, SNAP benefits decreased which has affected funding for snacks, food drive & Angel tree ongoing

 - i. Immunization updates: 27 affidavits on file, 5 catch-up schedules for Hep A
 - ii. Common illnesses: HFM, flu b, gi illnesses
 - iii. 1,000 total visits
 - iv. Hearing and vision screenings completed 10/15/25; 419 students screened, 77 referrals sent out, 5 required treatment
 - c. Carisa Brown, Hannah Springs Counselor
 - i. Counselors – 32 referrals
 - ii. Missing 7 consents for SB 12
 - iii. Call from Dr. about mental health and having screening here instead of going to Killeen
 - iv. Charlie Health – like tchat, but in groups, more long term
 - v. New bullying posters, waiting until next semester so that consents can go out to be able to do surveys

 - i. 384 total screened for hearing and vision, 31 hearing referrals, 54 vision referrals

 - iv. 820 nurse visits total, 1 student missing vaccine, all other immunizations up to date

 - i. Scoliosis screenings 18th or 19th of December
 - ii. Only sent home 1 child with flu like symptoms
 - iii. No Goodside or Tchat referrals
 - iv. 1,277 student visits

 - ii. October Fentanyl awareness month
 - iii. 25 screenings
 - iv. Krista working on more free Narcan through University of Texas, each campus has at least 4
