Course Description/Student Learning Outcomes:

English IV is designed to demystify and break down the process of forming academic arguments while practicing the writing conventions to communicate a student's thoughts and opinions. It intends to prepare students to write for a range of college applications while reinforcing reading skills and practices begun in English III. Students will deal mainly with non-fiction essays around current topics of public discourse as well as Mathabane's Memoir.

- 4. Homework/outside of class practices (AR 6154):
 - a. Students are expected to practice responsible study skills and complete homework given in a thorough manner. Assignments not completed in class are homework. If assignments are not complete the next grading period, it is

considered late and therefore half credit.

- 5. Excused absence make-up practices (Education Code 48205(b)):
 - a. Absent students with an excused absence are expected to see their teacher the day they return to arrange any make up work. In general, students have one week to make up missing assignments.

7. Late work practices:

a. Late work is accepted for full credit at any time during the academic year. However, if a student is missing a Summative Assessment or is more than 30 points behind, he or she will be required to attend 6th period until caught up.

8. Revision practices:

a. Students are expected to revise essays. As the rough draft is written, I will provide comments, suggestions, and directions for revision. For full credit, The final piece of writing must meet all requirements of the assignment and address all comments and suggestions provided by the teacher. After the writing is scored on the rubric, students may further revise their writing to achieve a higher score. This opportunity may be limited by the teacher's available time.

9. Extra credit practices:

- a. Extra Credit is available to any students in good standing in the class. To be in good academic standing, a student must:
 - i. Have completed all summative assessments and major assignments
 - ii. Have earned at least 70% of daily points
- 10. Additional grading practices: Students who wish to participate in the graduation ceremony on June 3rd, 2020 will be required to meet the following deadlines for assignments:
 - a. Friday, May 22, 2026: Last day for missing essays to be submitted to teacher
 - b. Wednesday, May 27, 2026: Last day for short stories to be submitted to teacher
 - c. Friday, May 29, 2026: Last day for all completed work to be submitted to teacher
