CHaSE Standing Committee Notes

10/13/2023

- 1. Meeting called to order by: Ben at 11:35am
- 2. Committee reviewed notes from 10/06/2023 CHaSE meeting.
 - a. Marisol moves to approve
 - b. Ben seconds
 - c. Committee voted unanimously to approve the notes with minor change of specifying PE/Health will coordinate with CTB.
- 3. Discussion about timeline of edits and approval.
 - a. One back up plan suggestion is to get 7th done for implementation in spring for both 7th and 8th grade. 8th grade edits/approval would be left to spring and implemented 2024/25 school year.
 - i. Any materials need to be on campuses by February for spring implementation.
 - b. The plan for now is to continue with Friday meetings and finish 7th grade for review and approval. We still aim for 8th to be ready for that as well, but as the deadlines approach, we will add more meetings then or consider the idea of moving 8th grade edits/approval to spring.
- 4. Returning to discussion about Lesson 2, Slide 18. There was feedback that some parents in a member's single member district were uncomfortable with the term "anal sex" and a member wants to revisit the topic.
 - a. There is extensive conversation about the topic again today because there are strong opinions both in the room and in the community we represent.
 - b. The committee is deciding at this time to move on because we voted twice last week. The vote will stand.
 - c. We will make sure the parent preview and permission slips state clearly the topic will be included. After a semester of implementation, we can assess opt-in data.
 - i. Additionally, we discussed with Cliff from CTB in the meeting today to see if the softer use would even be an option. Cliff states it is worded as written to be "inclusive and as medically accurate as possible." He suggests the alternative (if needed) "transmission through sexual activity including skin to skin sexual contact."
 - ii. If we need this wording or the alternate wording from 10/6, we will write a teacher note to clarify questions related to "what is sexual activity?" so teachers are prepared to answer within TEKS and district requirements.
 - d. For now, the committee opts to leave the wording as written, but with the option to return to the discussion should alternate wording be required.
