MULTI-YEAR FINANCIAL PROJECTIONS

The multi-year financial projection indicates that the District will have a positive ending fund balance for the current fiscal year and expects positive ending fund balances for the next two fiscal years, based on current assumptions from the School Services of California (SSC) and the California Department of Education. In January 2026, School Services of California provided revised projections from the Governor’s approved budget for the current year, 2026-27, and for 2027-28. These assumptions are reflected in the Second Interim Report.

Based on current information and the School Services Dartboard, the projections include the following assumptions for each year beyond 2025-26.

RESERVE FOR ECONOMIC UNCERTAINTIES

Although there is always the potential that future unforeseen budget revisions may negatively impact the District's Reserve for Economic Uncertainties, the Administration expects that the District will still be able to meet its financial obligations for the current fiscal year.

As of the Second Interim Period, the District's Reserve for Economic Uncertainties is \$5,365,431, which will satisfy the required 3% percent of the District's current budgeted expenditures.

Throughout the year, budget revisions will be made for revenues and expenditures that were previously unknown or unmeasurable. As the District's budgeted expenditures fluctuate, the recommended 3% reserve amount will also fluctuate.



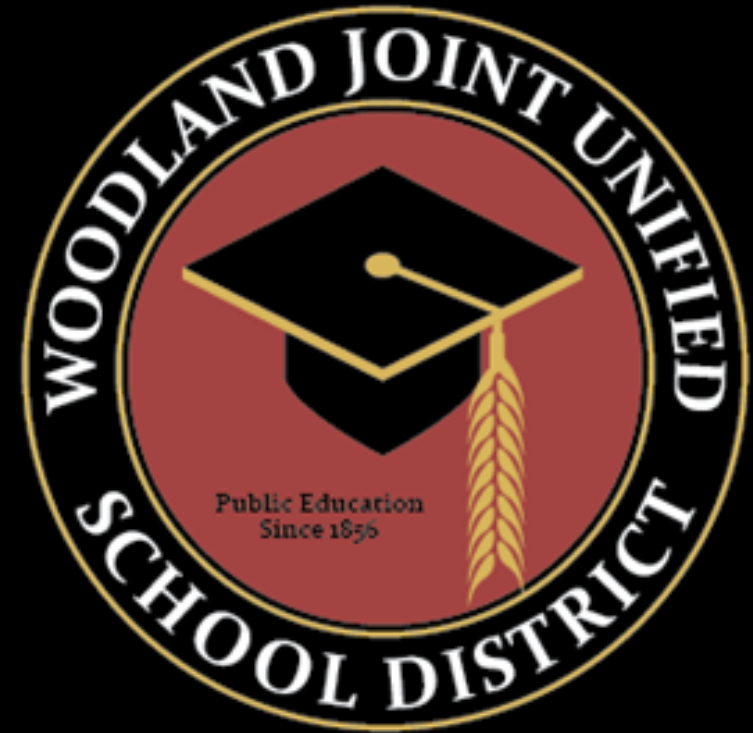

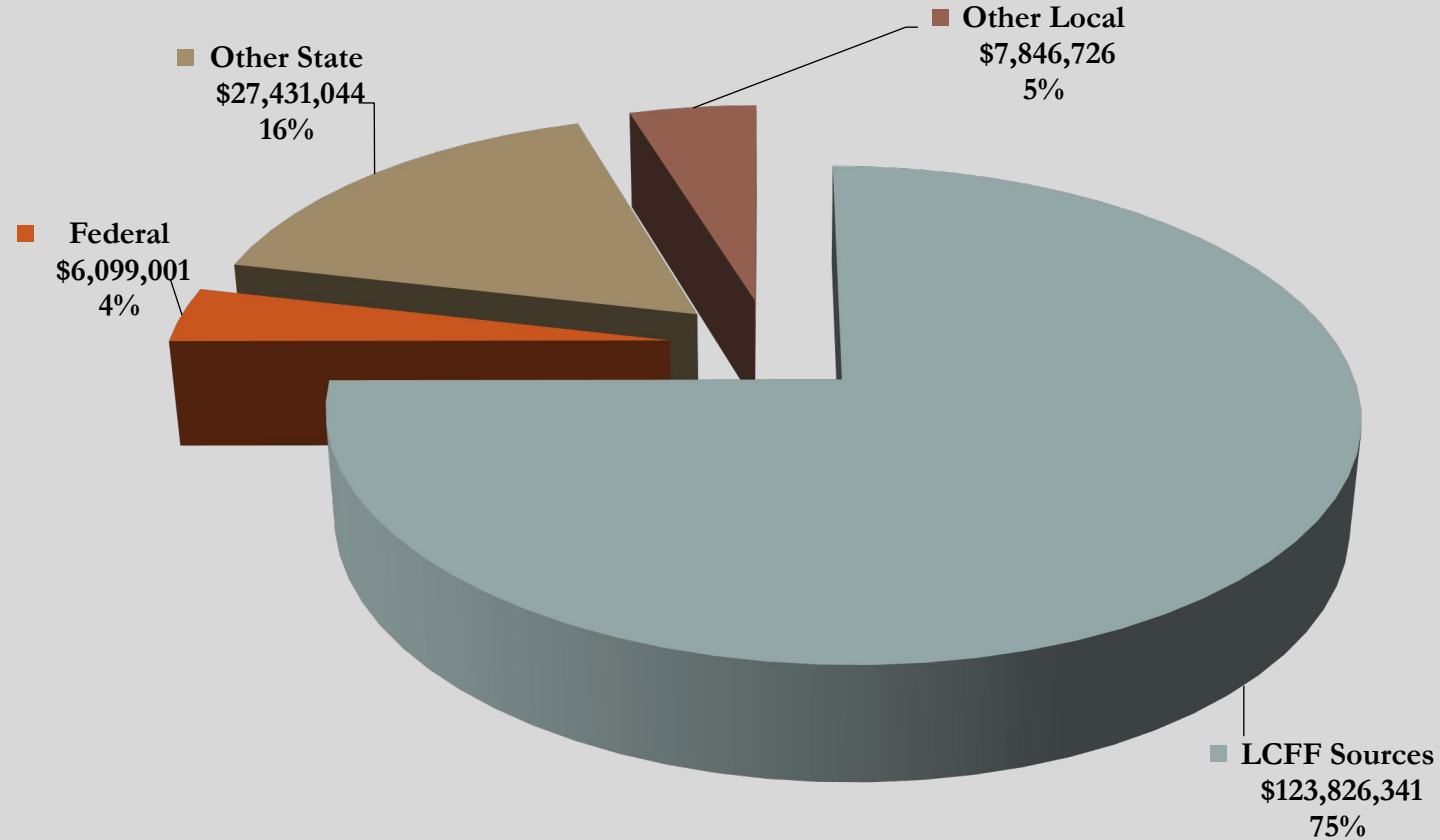

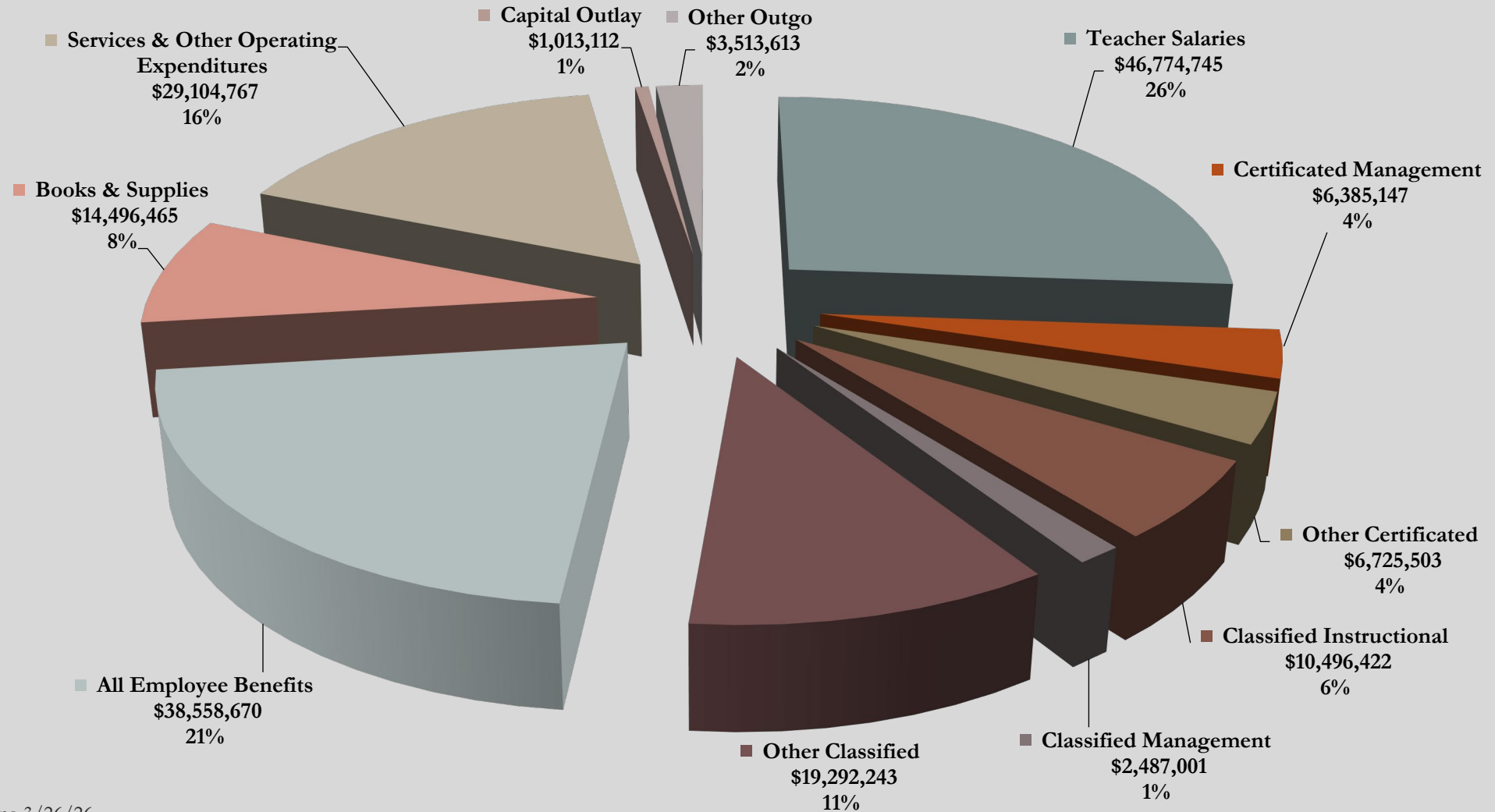
2025-26 General Fund Revenues

Total Revenues \$165,203,111



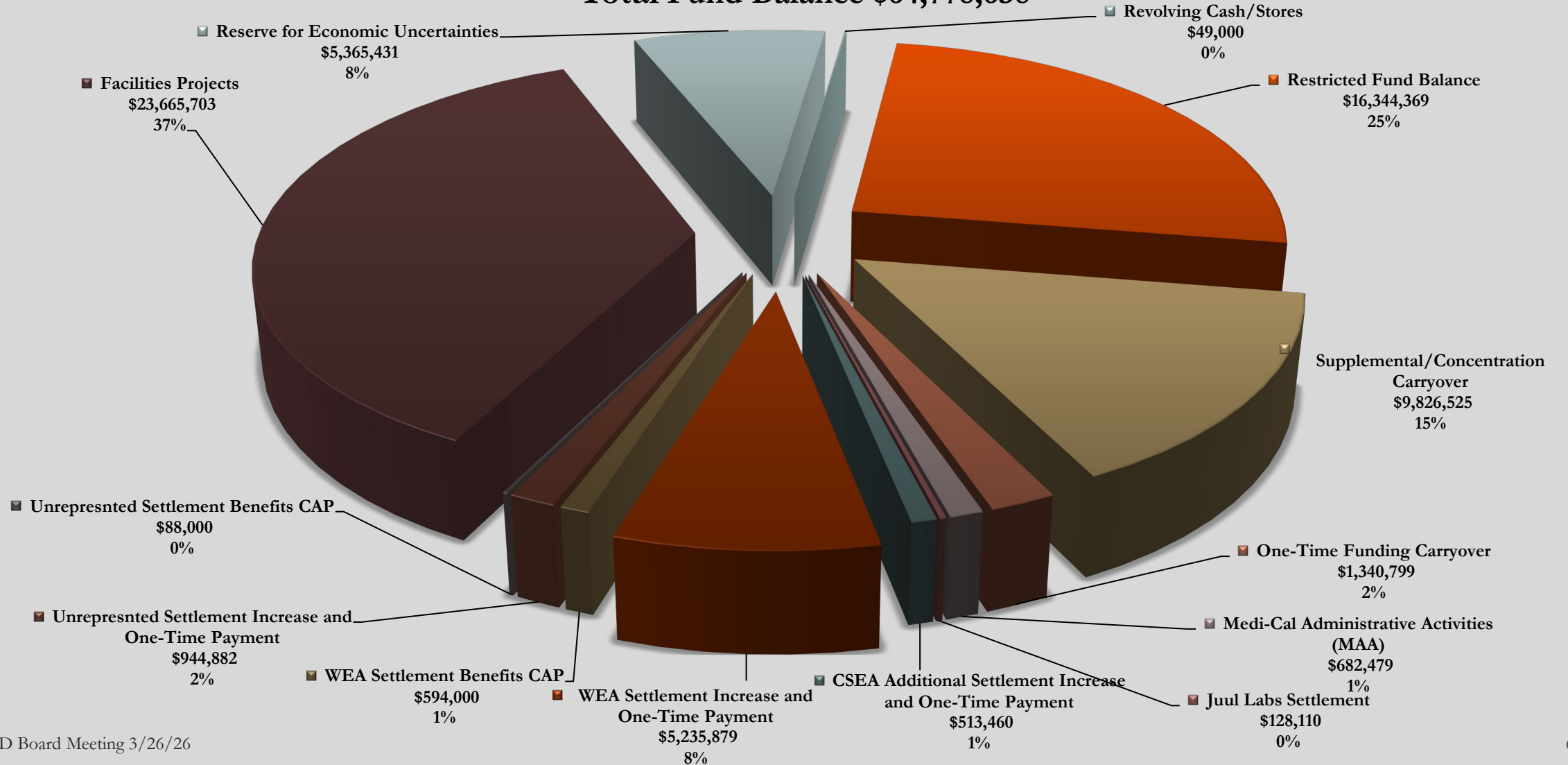
2025-26 General Fund Expenditures

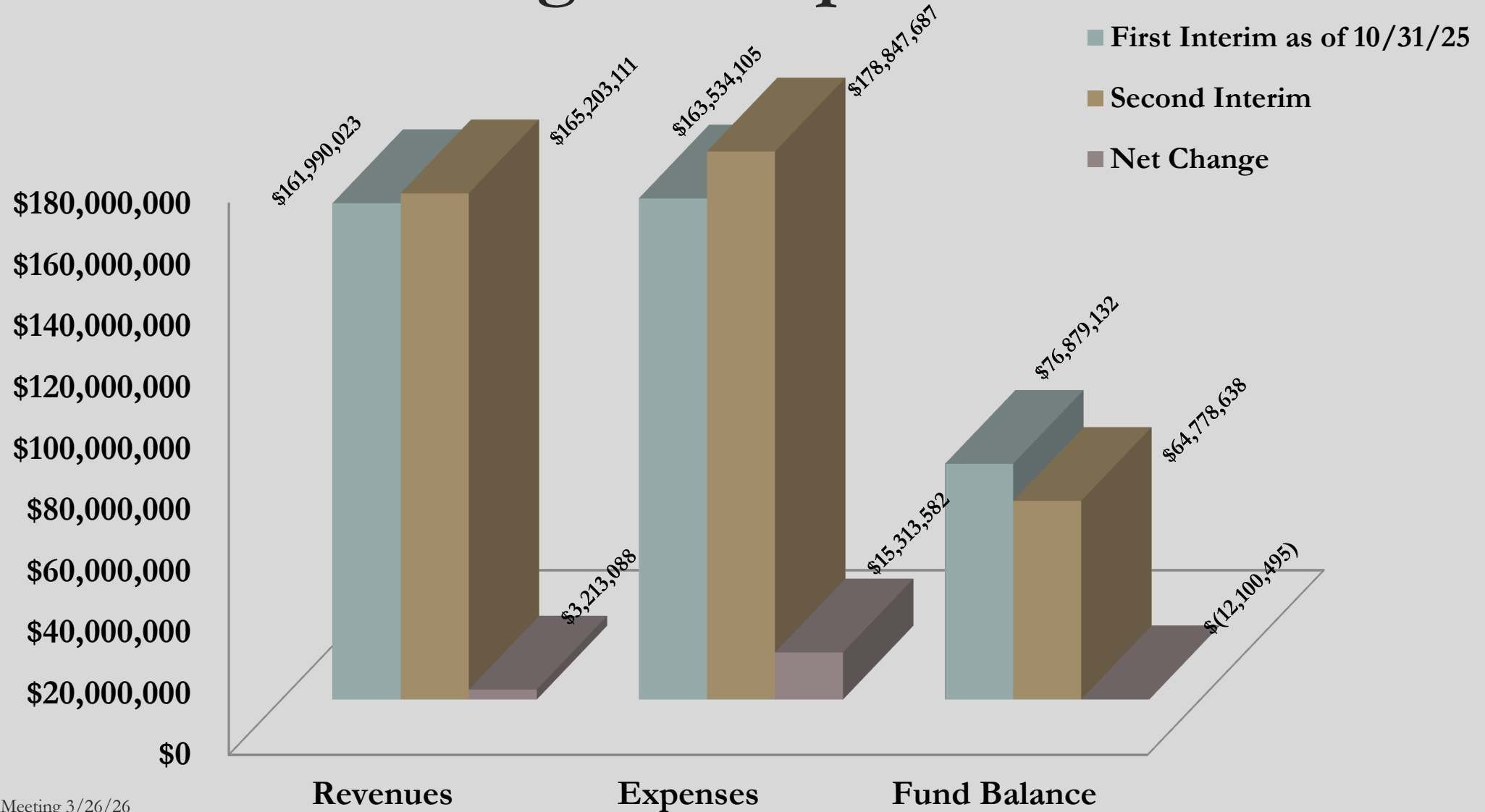




