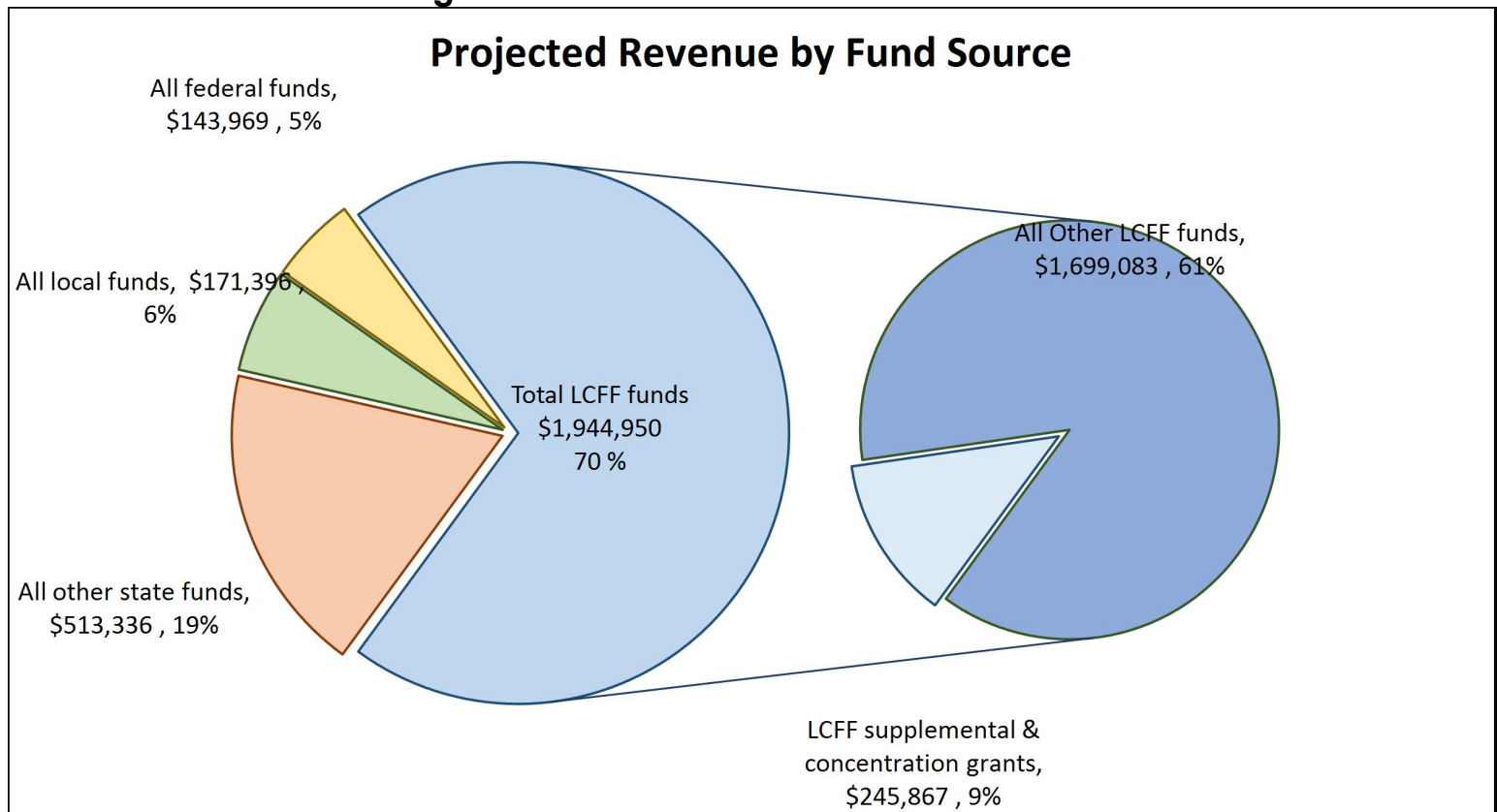

Budget Overview for the 2026-27 School Year

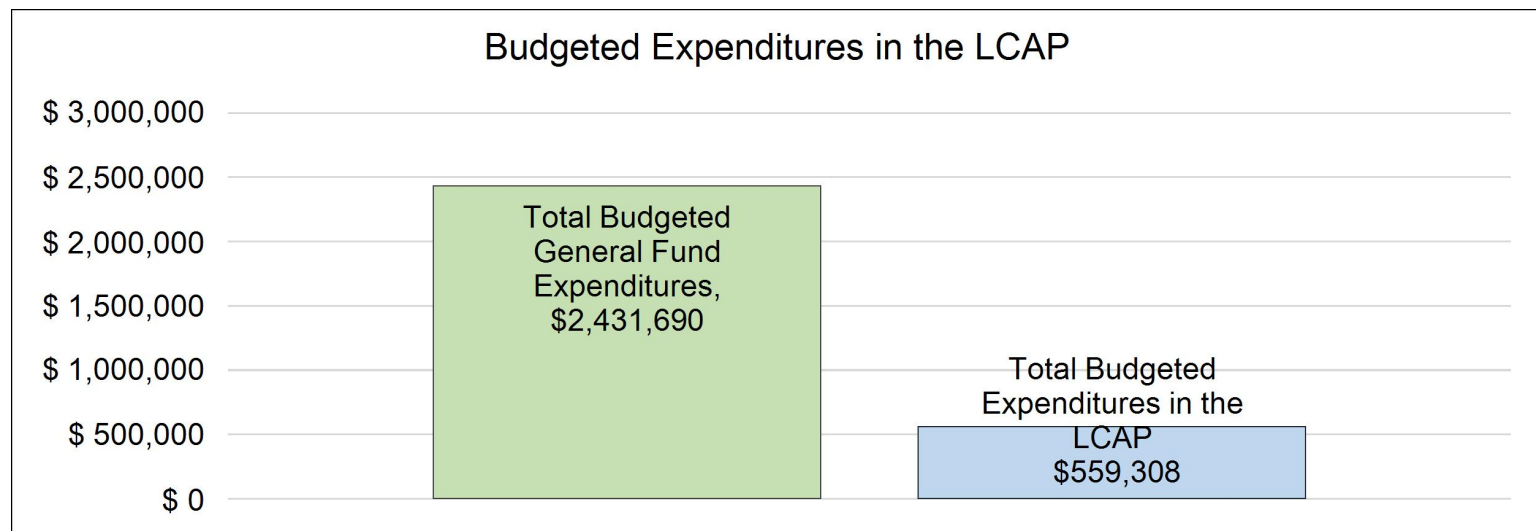


This chart shows the total general purpose revenue Burnt Ranch Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Burnt Ranch Elementary School District is \$2,773,651, of which \$1,944,950 is Local Control Funding Formula (LCFF), \$513,336 is other state funds, \$171,396 is local funds, and \$143,969 is federal funds. Of the \$1,944,950 in LCFF Funds, \$245,867 is generated based on the enrollment of high needs students (Foster Youth, English learner, and low-income students).

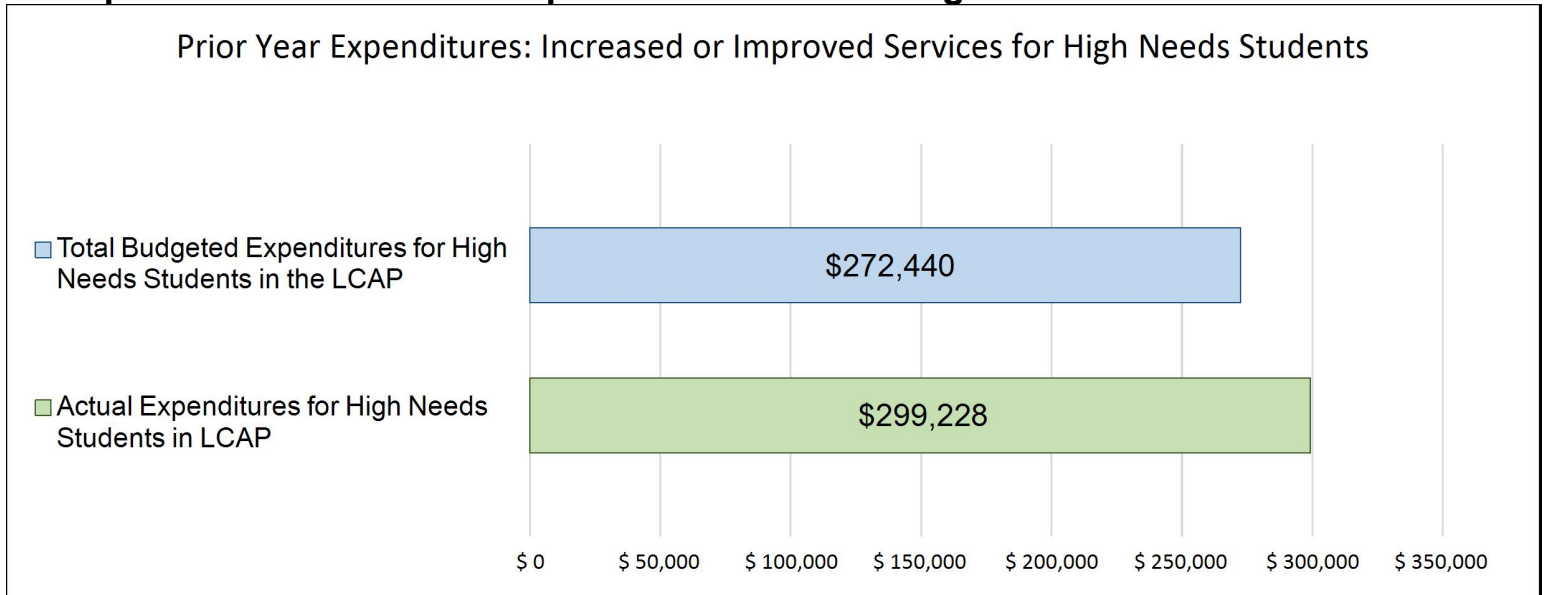
The majority of the general fund expenditures are not included in the LCAP. These expenditures are predominantly for salaries and benefits. Other expenditures include general operating expenses (utilities, etc.), instructional materials, special education costs, after school program costs, transportation and maintenance costs, Indian Education and administrative costs.

Increased or Improved Services for High Needs Students in the LCAP for the 2026-27 School Year

In 2026-27, Burnt Ranch Elementary School District is projecting it will receive \$245,867 based on the enrollment of Foster Youth, English learner, and low-income students. Burnt Ranch Elementary School District must describe how it intends to increase or improve services for high needs students in the LCAP. Burnt Ranch Elementary School District plans to spend \$268,733 towards meeting this requirement, as described in the LCAP.

Plan Summary [2026-27]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA. LEAs may also provide information about their strategic plan, vision, etc.

Burnt Ranch Elementary School District serves 80 students TK-8th grade in five multi-graded classrooms. Our school district is a remote, rural, single school district covering a large geographic area and serving students in both Trinity and Humboldt counties. Almost 60% of our students have transferred in from surrounding districts. Approximately 30% of our students are Native American, which, being 25 students, represents a significant student group. Additionally, over 70% of our student population is economically disadvantaged, and currently, very few students are homeless and none are foster children. We are a SWP Title I school. Presently we have no ELL students, therefore metrics 2b, 4e, and 4f do not apply. We are an elementary TK-8 district and therefore metrics 4b, 4c, 4d, 4g, 4h, 5c, 5d, and 5e do not apply.

Every student receives a broad course of study (Priority 7A) which includes ELA, Mathematics, Social Studies, Science, Physical Education, Art, Music/Drama, in grades 7th-8th, College/Career Technical Education and grades 5-8 receive Foreign Language experience. All students have sufficient access to standards-based curriculum and instructional materials (Priority 1B).

All classroom teachers are appropriately assigned and all are fully credentialed (Priority 1A). Our school buildings and campus were rebuilt in 2019, and are in excellent condition. Our school facilities are in Good condition, as evidenced our by FIT score (Priority 1C). Each year, repairs and maintenance are performed as needed. Opportunities for Parent Involvement include participation in the LCAP Advisory Committee, the Governing Board, the Indian Education Parent Advisory Committee, and the BR Parent-Teacher Organization(PTO). A unique characteristic of our school, a little over 50% of our staff members are parents, providing unparalleled involvement and dedication.

As a small school district, we complete a comprehensive need and budget analysis assessment for our school site on an annual basis. Due to the small student population size, which results in a small pool of data to analyze, all resources are equally distributed for all students in the district. We will continue to monitor our resources to ensure equity for all students.

Included in this year's planning was the required needs assessment and plan for the LREBG funds that was completed in 2025.

The LCAP will serve in lieu of the Single Plan for Student Achievement (SPSA) and will include funds previously in the SPSA. Additionally, the LCAP educational partner (PAC) group will serve in lieu of the School Site Council. The Burnt Ranch Elementary School District has a Special Education teacher who provides special education support for identified students throughout the week. Students receive both push in and pull out services, individually and in small groups. We receive services from a Special Education para-professional to support the speech and language program. Trinity County Office of Education (TCOE) provides support services including school psychologists, speech and language pathologists, a school counselor twice per week, a wellness coach on site 5 days per week, as well as contracted physical and occupational therapy services. For students with social-emotional needs, educationally relevant mental health services are provided by the school counselor or mental health clinicians through partnerships with Trinity County Behavioral Health Services.

Foster Youth

The Trinity County Office of Education coordinates all county services for Foster Youth through the positions of Foster Youth Education Coordinator and Foster Youth Services Liaison. They provide support to our Foster Youth, placed both in and outside our county, by helping with transfers, making sure records are moved quickly, and tracking attendance, suspension, expulsion rates, and graduation rates to be sure that they are equal to those of their non-foster peers. They also intervene to refer or provide direct services, including transportation, as needed.

We do not have any EL students at this time, nor have there been any in the last 5 years.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Burnt Ranch Elementary School District has demonstrated areas of success and areas to focus on for improvement based on a review of the California School Dashboard and local data.

Academic Achievement and Growth

The 2025 California School Dashboard identifies the district in the "Blue" region (the highest performance level) for both English Language Arts (ELA) and mathematics. This is an increase from the "Green" region on the 2023 and 2024 Dashboard in both ELA and mathematics.

Local metrics confirm this upward trend, with ELA proficiency reaching 73.58% in 2025 (a significant increase from 62.3% in 2023) and Mathematics proficiency reaching 64.71% in 2025

Dashboard data classifies student growth in both ELA and Mathematics as "Accelerated," with 90.5% of students improving their ELA scores and 81% improving their Mathematics scores from the prior year.

Science Benchmarks: While CAST (Science) proficiency was 40% in 2025, the district implemented the Galileo science benchmark, which showed that 64.2% of students were on course for grade-level achievement.

School Climate and Student Engagement

The district achieved a 0% chronic absenteeism rate in 2024-2025, a performance level marked as "Blue" on the Dashboard. and increase from the "Green" in 2023.

Overall P2 attendance rates have climbed steadily to 96.88% as of 2025-2026

Dashboard reported a 4.1% suspension rate for 2023-2024, local data for 2024-2025 shows a sharp reduction to 1.1%. The Dashboard now categorizes the district's suspension rate in the "Green" region, improving from the "Orange" tier in 2023.

Parent perceptions of safety reached a high point in 2025-2026, with 100% of survey respondents reporting their child feels safe most or all of the time.

Student surveys 100% of students feel safe most or all of the time.

Systemic Implementation and Successes

Qualified Staffing: As of May 2026, 100% of classroom teachers hold Clear Multiple Subjects teaching credentials.

The district successfully filled specialist positions to provide Physical Education, Art, and Drama/Music instruction to 100% of students

The district maintained 100% implementation fidelity for required IEP services and reported 100% parent satisfaction regarding involvement opportunities for families of students with exceptional needs

Areas for Focus and Improvement

Despite high overall performance, a needs assessment revealed that Students with Disabilities are performing at a "low academic status" in both ELA and Math.

This group often overlaps with socio-economically disadvantaged and American Indian students, leading the district to prioritize these groups for Learning Recovery and Emergency Block Grant (LREBG) funded interventions.

Implementation reflections note that the district's ability to provide Tier 2 mathematics support to all identified students is limited, with a priority given to reading intervention in the primary grades.

Parent satisfaction with school-home communication decreased by 7 percentage points

In response, the district is implementing weekly newsletters from all teachers and "mini-progress reports" to better share student data with families

The adopted LCAP (Local Control and Accountability Plan) was shaped by the invaluable input from our educational partners. Through a structured framework of collaboration and engagement, we ensured that every partner group had a voice in crafting a plan that reflected the needs and aspirations of our school community.

An emphasis on increased communication within our staff this year and the implementation of the Gamut/Simbli platform to share school board and other important meeting agendas, supporting documents and minutes has increased participation and transparency for our district.

Weekly staff collaboration sessions provided a crucial platform for discussing problems of practice, implementation challenges related to standards, and addressing school climate and social-emotional learning (SEL) needs. By fostering an open dialogue and an agenda that is created collaboratively, educators were able to share insights, identify areas of improvement, and collectively brainstorm solutions to enhance student outcomes. Specifically, classified and certificated staff influenced Goal 1 and 2 actions and metrics related to professional learning, NGSS implementation support, parent progress reporting and communication.

Our engagement efforts extended beyond the school walls to involve parents and the broader community. Through a series of events and surveys, we gauged school connectedness and solicited feedback on the importance ranking of various LCAP actions. This direct input from parents and community members not only ensured alignment with community priorities but also fostered a sense of ownership and partnership in the improvement process. Student Climate survey results directly affected Goal 2 and SEL actions and implementation of Restorative Practices and leadership activities.

Additionally, consistent Parent Advisory Committee (PAC) meetings played a pivotal role in the development and refinement of the LCAP. These meetings provided a forum for discussion on metrics and actions, allowing for a thorough examination of progress and the identification of areas needing adjustment. The PAC group's input sessions and activities synthesized and then refined, directly influenced the maintenance of the two broad goals, with updated metrics and actions that reflect necessary adjustments to make meaningful changes. Experienced leadership, consistent participation and productive meeting/feedback facilitation made for an meaningful experience for PAC members.

In essence, the adopted LCAP stands as a testament to the power of collaboration and partnership in driving educational excellence. By integrating feedback from educational partners at every stage of the planning process, we have created a roadmap for success that reflects the shared vision and collective aspirations of our entire school community.

The district believes that to provide our students with a comprehensive education, all components of this goal are essential. Quality teachers need a standard-aligned curriculum for each subject and each student throughout the school. Teachers need access to professional development, instructional assistants, and adequate materials and supplies so they can offer their students the core curriculum, enrichment opportunities, and any needed interventions. Based on our data and metrics in the 2025 annual update, Burnt Ranch School has identified ELA, Math, and NGSS proficiency levels as priority areas for this goal. Continuous improvement is our desired outcome, and we set our metrics and actions to reflect a commitment to this practice. All actions related to this goal will be implemented throughout the cycle at Burnt Ranch Elementary School.

Goal Analysis [2025-26]

The overall implementation of our instructional program has been successful, though we encountered some challenges and many successes.

1.1 Planned action was implemented as intended, but we continue to fall short in meeting 100% of students in the Tier 2 range receiving intervention services.

1.2 Planned action was implemented as intended, with teachers demonstrating strong commitment to the Computer Science Professional Learning Communities (PLCs). These collaborative teams have been particularly effective, with all regular classroom teachers actively participating as well as some specialty teachers. The success of these PLCs is evidenced by positive trends in our benchmark data, indicating improved student outcomes in mathematics and implementation of project based learning opportunities embedded with Computer Science standards.

All our actions were implemented as intended, with nuances as to the effectiveness/appropriateness of the action as we 'hit the ground'. Our recently acquired NGSS benchmark has proved to be a challenging platform and will be discontinued by the publisher this summer.

Moving forward, we plan to address the identified science benchmark assessment implementation gap and increase NGSS support in totality.

Goal 1 Action 1: Academic Intervention and Progress Monitoring saw a material decrease due to a reduction in Title 1 Funds.

Goal 1 Action 2: Professional Development saw a material difference due to an increased in PD offerings to staff.

The data demonstrates that our actions have been predominantly effective in advancing toward our goal, with significant progress in ELA, and expanding course offerings. The maintenance of highly qualified teachers and comprehensive instructional materials has provided a strong foundation for student success. Our primary challenges remain in mathematics achievement and intervention implementation, where staffing constraints have limited effectiveness.

The balanced improvement across multiple metrics, particularly the strong performance in benchmark assessments, suggests that our focus on professional learning communities and differentiated instruction has been effective in supporting student achievement within the classroom setting. However, additional resources and refined implementation strategies are needed to address mathematics proficiency and ensure consistent intervention services across all subject areas.

Additionally we will define Tier 2 and timeline for identification in the coming year and plan to update metric language for the new 3-year cycle.
 1.3 will now include intervention and support materials for NGSS.
 Additionally, metrics 1.4 and 1.6 will be tweaked to adjust for new NGSS benchmark assessment and effective timelines for reporting out results. Such that, we will use a new TBD NGSS benchmark and will report out our winter benchmark data, to allow for a less intrusive testing schedule in the spring.

The implementation of planned actions aimed at supporting student success, maintaining a positive school climate, and fostering parent engagement demonstrates both significant successes and notable challenges during the current period.

2.1 was implemented as planned, but remains a high priority, we saw 25% of our students being referred for mental health services.

2.2 was implemented as planned, with great success as indicated by the high attendance rate and drastic reduction in chronic absenteeism.

2.3 was implemented as planned. We are pleased with the success as reported in the FIT report indicating our facility in 'Good' status.

2.4 was implemented as planned, with notable commendation for the implementation of Compassionate Systems tools and PBL. We will continue to emphasize and build on incorporating a school government that facilitates a budget and solicits genuine student interest input.

2.5 was implemented as planned, with success in hosting dinners to encourage family participation and working with PTO for implementation.

2.6 was mostly implemented as planned, with challenges related to consistent newsletters. Input from Parent/LCAP and School Climate surveys indicate there is still a need to improve communication. We will be monitoring staff communications and supporting methods to share student progress and events.

2.7 was implemented as planned with notable success in hosting beloved annual events and providing a career exploration course with a local elder specializing in stone masonry.

Challenges:

1. Communication Systems: Despite concerted efforts to improve school-home communication, our implementation in this area has shown limited effectiveness. Parent satisfaction with communication decreased and LCAP survey participation remained below target, indicating persistent challenges in engaging families through our current communication strategies. Action 2.6 has been re-vamped to address these shortcomings.

Successes:

1. Attendance Initiatives: Our attendance improvement strategies have been highly effective. We successfully maintained over 96% attendance rates and reduced chronic absenteeism to 0%, demonstrating effective implementation of our attendance monitoring and intervention systems.

3. Special Education Services: We have maintained 100% implementation fidelity in providing appropriate services to students with exceptional needs, alongside 100% parent satisfaction with involvement opportunities for these families.

4. Expanded Course Offerings: We successfully implemented a more comprehensive specialist program, expanding from the previous year's PE and art offerings to now include drama/music instruction for all students and foreign language for grades 5-8.

5. Social and Emotional Learning and Support: We successfully offered mental health support to all students. Staff participated in a variety of SEL related PD.

5. Social and Emotional Learning and Support: We successfully offered mental health support to all students. Staff participated in a variety of SEL related PD.

The improved action indicates that all classroom teachers and specialty teachers will send home newsletters and use a bulk messaging system purchased by the district. Also included in the revision is parent training on accessing the parent portal for Schoolwise, our student information system.

- **5. Total Planned Percentage of Improved Services**
 - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

Pursuant to EC Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7).  - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

- **13. LCFF Carryover — Percentage (12 divided by 9)**

- This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
