School Description and Mission Statement (School Year 2020–2021)

Winship-Robbins Elementary School District was formed in July 2005 when Robbins Elementary, a part of Yuba City Unified School District, joined Winship Elementary. Winship had been a one-school district in Sutter County since 1863, and Robbins School dates back to 1927. The reorganization of the two small schools into one district has combined resources and strengthened both schools. Robbins has a superintendent/principal, a teaching staff of eight including teachers and para educators, and the small classes are combined in different ways depending on the number of students in each grade. Two preschool terachers. There is an additlional instructional aide to assist both in the classroom and in the afternoon intervention program for students who need a little more support. We have a breakfast and lunch program, a bilingual administrative assitant/school secretary, a confidential office manager, part-time technology coordinator, two bus driver/maintenance people, and a part-time custodian. Free bus transportation is available. Our rural atmosphere and old-fashioned family values are a rarity in this era, and we are proud to say that our schools offer sound educational training along with a good dose of character. Our test scores have improved dramatically over the past couple of years, and we are continually fine-tuning our curriculum and our staff to offer quality education to small groups of lucky children. Our Mission: As the keystone of rural education, rich in natural resouirces and deeply connected to one another, the land and our global community, W-RESD will inspire and challenge students to achieve academic excellence and personal goals, develop character and confidence, and instill habits of learning that will sustain them throughout life.

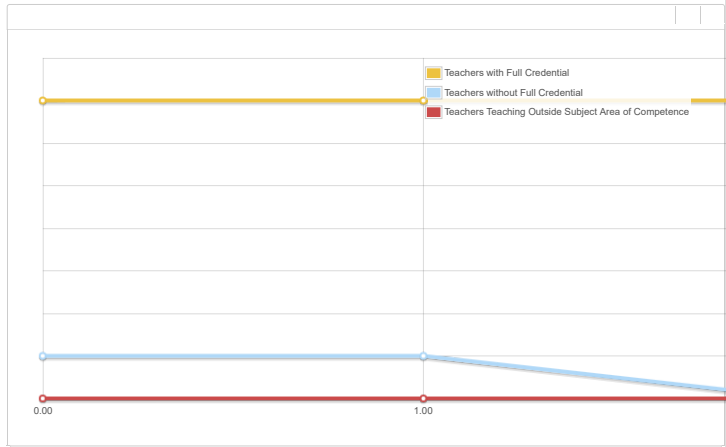

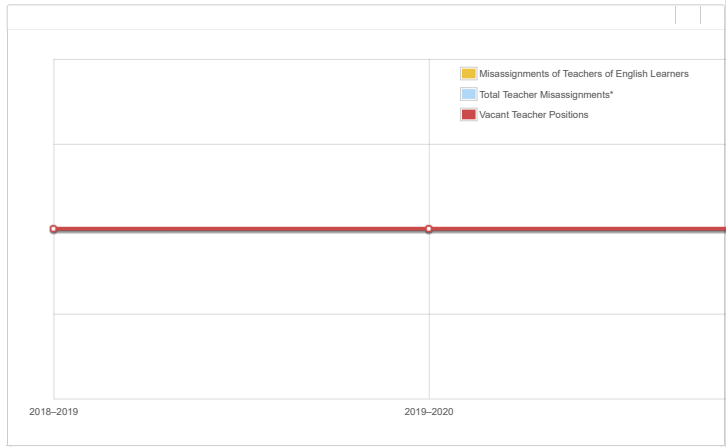

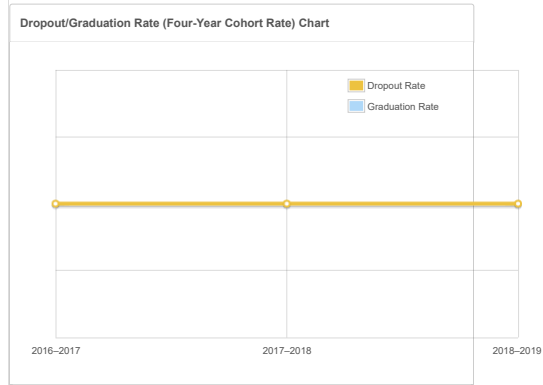

School Safety Plan (School Year 2020–2021)

The school comprehensive safety plan is due every year by March 1st. W-RESD is taking the fall of 2020 to develop a more comprehensive, robust plan to include a pandemic portion due to COVID-19. WRESD's Reopening Plan that was revised on September 23, 2020 includes safety measures due to COVID which include illness prevention, face coverings, movement on campus, transportation, food service, educational programs, child care, extracurricular activities and campus access. This plan also includes how we communicate with our staff, students, parents and community for the health and safety of all. 8/28/2019 was the approval date of the last annual review in which W-RESD updated and discussed with school staff, students and community members. Key elements of the plan focus on the maintenance of a safe and secure campus for students and staff. The plan is approved and updated by ther Board of Trustees. The school is in compliance with the laws, rules, and regulations pertaining to hazardous materials and state earthquake standards. The school's disaster preparedness plan includes steps for ensuring student and staff safety during a disaster, fire, disaster drills, and active shooter training are conducted throughout the school year. Students are supervised during lunch and recess by the para educators. There is a designed area for student drop off and pickup. All visitors are required to check in at the office and sign a visitor log. The entire School Safety Plan can be found on the district web site.

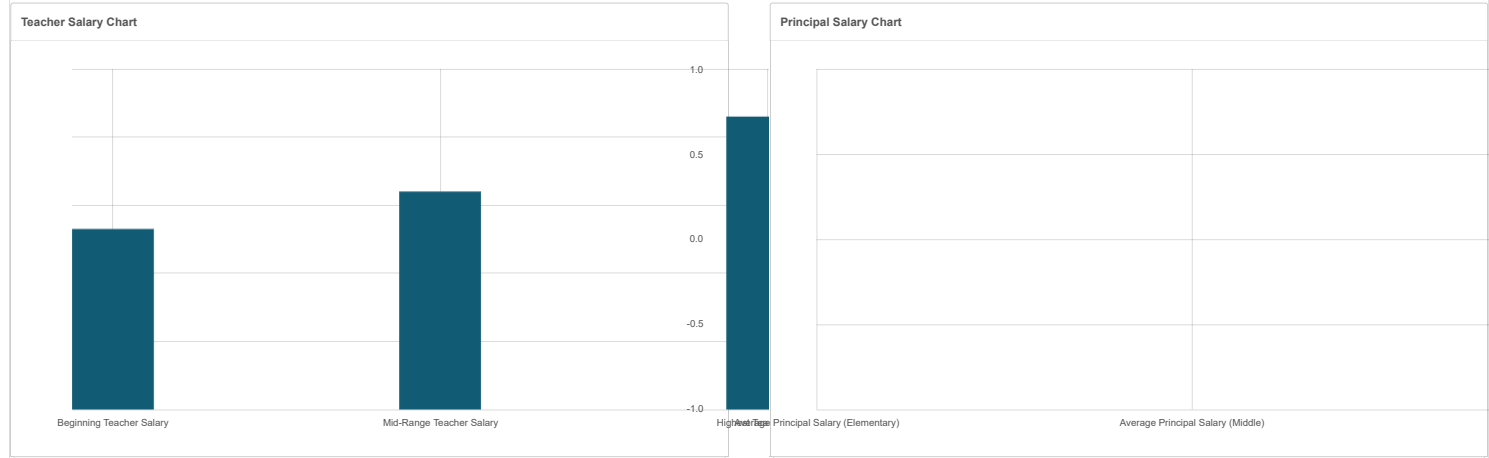

or the 2019-2020 school year, the Instructional Staff of the Winship-Robbins ESD are participating in Professional Development (PD) through workshops provided the second and fourth Wednesdays of each month. With the monies provided through the MTSS Grant, the Professional Developments promote the use of Universal Lesson Design (UDL) for the access of instruction by all students, and Restorative Practices for the promotion of positive learning environments in all classrooms. In addition, Professional Development also provides on-going instructional support based on the data analysis of the CAASPP results, ELPAC results, MAPs through NWEA results and

Winship-Robbins Elementary School District's district assessment results. After collaborative analysis of the collected data, the instructional staff determined the need for more support in the area of Conceptual Mathematics. To provide the instructional support, the Winship-Robbins Elementary School District's Professional Developments are continuing our focus using John Hattie's "Visible Learning for Mathematics." Through the book read and Professional Developments, the Instructional staff has implemented the use of Content Objectives, Social Objectives and Language Objectives into their daily math lessons, along with the practice of productive struggle and the implementation of tasks to promote problem solving. Throughout the Professional Development process, the Instructional Staff of Winship-Robbins Elementary School District are partners in determining the direction and support needed to provide the most effective instruction to all students of the district. Teachers are encouraged to attend professional development through local county offices.
