1. OPENING ITEMS

- .01 Call to Order and Pledge of Allegiance – Chairman Sanchez called the meeting to order at 10:04am.
- .02 Roll Call - LCF Board Members Present: Buck Goodspeed, Ambar Martinez (arrived at 10:17am), Jessica Rodriguez (arrived at 10:10am, dismissed at 10:13am), Marisol Sanchez, and Sabrina Schneider. LCF Board Members absent: Vianey Gonzalez.

2. APPROVAL OF MINUTES

- .01 Approval of the Minutes of the Regular Board Meeting Held December 5, 2025 – On a motion by Buck Goodspeed, seconded by Jessica Rodriguez, vote 4-0, the LCF Board of Directors approved agenda item 2.01.

3. PUBLIC COMMENTS - None

4. DISCUSSION/ACTION ITEMS

- .01 Introduce Sabrina Schneider as a Member of the Lewis Center Foundation Board
- .02 Discuss Upcoming Foundation Events
 - Golf Tournament 2027 – Mrs. Corona updated the Foundation to move the tournament date to June 14/15, 2027 and provided locations. Dr. Lamb added that there will be construction taking place on LCER school campuses during the same time in 2027 and may open it up to additional sponsorship opportunities.
 - Spring Social – May 21, 2026 – High Desert – Location is TBD and planning will continue. Raffle prizes will be needed. PTC and PTO are great supporters and donors.
 - 2026 Gala – Date TBD – San Bernardino – Mrs. Corona updated the Foundation that Saturdays in September and October 3rd will be explored for venue availability. September 19th and September 26th have attendance limitations for some members. Gala themes were discussed and included benefits and engagement opportunities. The Foundation ultimately agreed to move forward with “Casino Royale”. Additionally, community nominations will begin early February.
 - Changemaker Hub – March 10, 2026 – NSLA – Dr. Lamb updated the Foundation on the Changemaker Hub details, in partnership with World Savvy. It’s objective is developing global competency and global citizens. World Savvy received a grant to hold this 3-part series on civic engagement at the NSLA campus. The community can come together for a full day event and the Board is encouraged to attend. Panelists were invited and announced.
- .03 Discuss in Person Presence and Alternating Locations for Foundation Board Meetings – Mrs. Sanchez offered the opportunity to join together in person for upcoming meetings. Attending virtually will remain an option.
- .04 Discuss Foundation Recruitment – Mrs. Sanchez added that increased presence on campus during meetings would tie into recruitment efforts.
- .05 Discuss and Review Foundation Board Member Job Description – Dr. Lamb shared the Job Description and reviewed it collectively. Section “Appointment/Election” was discussed as it related to ASB nominating a high school student to participate with provisions. Dr. Lamb will bring it back to principals. The board agreed but had concerns with student participation during class time. Student schedules, master rosters, and moving Foundation meetings were discussed. There are revisions needed including principal’s attendance, ex officio members, and frequency of meetings. Dr. Lamb reminded the Foundation of current public facing issues being expressed and being mindful of representations.

Lewis Center Foundation Board Member Job Description
(Fundraising Committee)**

ROLE STATEMENT: The Lewis Center Foundation (“Foundation”) is organized as a subordinate standing committee authorized and sponsored by the Lewis Center for Educational Research Board. The Foundation’s role is to support the mission of the Lewis Center for Educational Research (LCER) and to provide supplemental financial support to the LCER and any and all schools and programs it operates.

COMPOSITION: The Foundation consists of no more than 15 members, up to 3 of whom may be Lewis Center for Educational Research Board (“LCER Board”) members appointed by the LCER Board Chairman, and one high school student from each high school. The remainder will be parent and community members representing the schools and communities served by the LCER.

QUALIFICATIONS: Foundation members must have an interest in raising supplemental financial support for the LCER and any and all schools and programs it operates.

FOUNDATION DUTIES:

- Actively participate in fund development
- Plan, implement, and evaluate fundraising events and strategies
- Recommend potential new fundraising events and strategies
- Solicit funds from donors and sponsors
- Identify potential new donors and sponsors
- Communicate events and strategies to stakeholders
- Advise school staff members of possible school-specific fundraising strategies

OFFICER DUTIES:

1. Chair:
 - a. Shall call and preside at Foundation meetings and meet with the President/CEO to prepare agenda items.
 - b. Shall report all actions taken during Foundation meetings at the LCER Board meetings.
 - c. Shall act as a liaison between the Foundation and the LCER Board through the President/CEO who will report out at each meeting, respectively.
 - d. Shall coordinate the work of volunteers and staff and receive regular reports on the progress of their work.
2. Vice Chair:
 - a. Shall, in the absence of the Chair, carry on all duties of the Chair.

APPOINTMENT/ELECTION:

1. Except for ex officio members, the Foundation shall elect members at any properly noticed and duly constituted meeting of the Foundation Board by majority vote.
2. The Chairman of the LCER Board may appoint up to 3 LCER Board Members (~~Ex officio members~~) to the Foundation Board.

3. The ASB of each high school shall nominate one high school student, subject the approval of the Principal.
4. The Foundation may remove any members whenever such removal serves the best interest of the LCER.
5. The Foundation Board Chair is nominated by the Foundation Board and appointed by the LCER Board Chairman. The Chairman of the LCER Board may remove any appointed Chair or LCER Board Member whenever in his or her judgment such removal serves the best interest of the LCER.
6. The Principal may remove any high school student whenever in his or her judgment such removal serves the best interest of the LCER.

LIMITS OF AUTHORITY:

The LCER Board is fully responsible for the operation and fiscal affairs of the Lewis Center for Educational Research, and retains final supervisory authority and responsibility. However, the LCER Board has delegated the responsibility for the duties described above to the Foundation.

REPORTS TO: The LCER Board through the Foundation Chair.

FREQUENCY OF MEETINGS: The Foundation meets bi-monthly or as needed, and in accordance with the Brown Act.

STAFF SUPPORT TO THE FOUNDATION: The President/CEO, Director of Finance, and Public Relations and Marketing Coordinator ~~and Principals~~ provide staff assistance to the Foundation. Principals or other site administration will be invited as needed. LCER staff shall prepare the agenda and supporting documentation, and record and distribute minutes of the meetings. Copies are sent to all Foundation members, members of the Lewis Center's Executive Team and Chairman of the LCER Board.
