#### I. BACKGROUND AND OVERVIEW

Lancaster School District ("District") serves about 14,837 in transitional kindergarten (TK) – Grade 8 across 22 school sites, including a virtual/online academy. The District is seeking SOQs and Proposals from experienced entities to provide modular services, including design, engineering, construction, delivery, installation, coordination, administration, consulting and advice, and related services ("Consultant") for the District's Modernization and New Construction Project at Mariposa Elementary School ("Project").

#### A. LIMITATIONS

This RFQ/P is a formal request for bids, an offer by the District to contract with any party responding to this RFQ/P. The District reserves the right to add additional prequalified Respondents for consideration after distribution of this RFQ/P if it is found to be in the best interest of the District. The award of the contract pursuant to this RFQ/P, if at all, is at the sole discretion of the District.

The District reserves the right to contract with any entity responding to this RFQ/P. The District makes no representation that participation in the RFQ/P process will lead to an award of contract or any consideration whatsoever. The District shall in no event be responsible for the cost of preparing a response to this RFQ/P. The awarding of the Consultant contract(s), if at all, is at the sole discretion of the District.

The SOQs, Proposals, and any other supporting materials submitted to the District in response to this RFQ/P, will not be returned and will become the property of the District unless portions of the material are designated as proprietary at the time of submittal and are specifically requested to be returned. Vague designations and/or blanket statements regarding entire pages or documents are insufficient and will not bind the District to protect the designated matter from disclosure. Pursuant to *Michaelis, Montanari, & Johnson v. Superior Court* (2006) 38 Cal.4th 1065, SOQs and Proposals shall be held confidential by the District and shall not be subject to disclosure under the California Public Records Act until after either: (1) the District and the successful Respondent

have completed negotiations and entered into an agreement, or (2) the District has rejected all Proposals. Furthermore, the District will have no liability to the Respondent or other party as a result of any public disclosure of any SOQ or Proposal.

#### B. FULL OPPORTUNITY

The District hereby affirmatively ensures that Disadvantaged Business Enterprises ("DBE"), Small Local Business Enterprises ("SLBE"), Small Emerging Local Business Enterprises ("SELBE"), Disabled Veterans Business Enterprises ("DVBE"), and minority and women business enterprises shall be afforded full opportunity to submit SOQs and Proposals in response to this RFQ/P and no respondent will be excluded from participating in, be denied the benefits of, or otherwise be subjected to discrimination on the basis of race, color, gender, sexual orientation, political affiliation, age, ancestry, religion, marital status, national original, medical condition or disability, or disability in any consideration leading to the award of the contract. #### C. RESTRICTIONS ON LOBBYING AND CONTACTS

From the period beginning on the date of the issuance of this RFQ/P and ending on the date of the award of the contract, no person or entity submitting in response to this RFQ/P, nor any officer, employee, representative, agent, or consultant representing such a person or entity, shall contact through any means or engage in any discussion regarding this RFQ/P, the evaluation or selection process or the award of the contract(s) with any member of the District's Governing Board ("Board"), Committee members, any member of the Citizens' Oversight Committee, or with any employee of the District except for clarifications and questions as described herein in Section IX (Submission Guidelines) below. Any such contact shall be grounds for the disqualification of the firm submitting an response to this RFQ/P.

#### II. SCOPE OF REQUIRED SERVICES

The anticipated scope of services is set forth at **Exhibit "A"** to the District's form of Agreement for Modular Services, which is distributed with this RFQ/P as **ATTACHMENT A** and incorporated herein by this reference.

The exact scope of services, however, will be negotiated with the selected firm and finalized in any resulting contract.

Any entity retained as a result of this RFQ/P shall be required to work cooperatively with the District in conjunction with all other technical consultants, the architect, and any Program and/or construction manager, if any, retained by the District for the Project, as well as other entities retained by the District to facilitate the timely completion of the Project.

#### III. CONTRACTUAL REQUIREMENTS

Consultant must be able to execute the District's standard agreement. (A copy of the District's Agreement for Modular Services is attached to this RFQ/P as ATTACHMENT "A.") Firms

responding to this RFQ/P must acknowledge that they have reviewed the agreement and must agree to the indemnity and insurance provisions contained in the District's standard agreement and confirm in writing that, if given the opportunity to contract with the District, the firm has no substantive objections to the use of the District's standard agreement.

#### IV. RELATIONSHIP TO OUTSIDE GOVERNMENTAL AGENCIES

Depending upon the scope of work, respondent may be required to assist the District in working with various outside governmental agencies, including but not limited to, the following as applicable: City or County Planning Commissions and Departments, the Department of Toxic Substance Control ("DTSC"), the regional air quality control district, the state and regional water quality control boards, the State Department of Education, the Division of the State Architect, the State Allocation Board, and the Office of Public School Construction. Respondent shall discuss its experience with each of these agencies.

#### V. CONFLICT OF INTEREST

Respondent shall certify that no official or employee of the District, nor any business entity in which an official of the District has an interest, has been employed or retained to solicit or assist in the procuring of the resulting contract, nor that any such person will be employed in the performance of any contract without immediate divulgence of this fact to the District.

Firms responding to this RFQ/P must comply with the following format requirements. Material must be in 8-1/2 x 11 inch format. Submittals shall include divider tabs labeled with boldface headers below, e.g., the first tab should be entitled "Cover Letter", the second tab should be entitled "Business Information", etc. Submittals must not exceed twenty (20) single-sided pages, or ten (10) double-sided pages.

#### **B.** CONTENT REQUIREMENTS

**COVER LETTER**

- Each Submittal must include evidence that the firm is legally permitted and properly licensed for the scope of work and to conduct business in the State of California.
- Absent extenuating circumstances, the District requires the key personnel identified
  as the Respondent's team will remain intact through the project(s) duration. If a
  team member must leave, respondent must provide the explanation for such
  departure and provide a replacement team member at Respondent's expense and

subject to the District's reserving the right to approve that team member's replacement.

#### LITIGATION HISTORY

• Provide a comprehensive five (5)-year summary of the firm's claims, litigation, arbitration, and negotiated/settlement history with previous clients ("Claims"). This includes current/ongoing Claims. For each lawsuit, state the issues in the lawsuit, the status of the lawsuit, names of parties, and outcome. The fee proposal shall also include hourly billing rates by position (proposed); staffing plan (proposed); and reimbursable schedule (proposed).
- The Proposal shall provide a Schedule of Rates ("SOR") by position, for each position proposed by your firm, whether you are submitting as a prime with subconsultant(s), or as joint venture or partnership. The SOR should identify proposed reimbursables by category. This SOR will be the basis for calculating the value of any additional services that may be added to the Respondent's scope of work.

#### VIII. SELECTION PROCESS AND CRITERIA

A Committee will evaluate all submissions on a best value evaluation. Each submittal must be complete. Incomplete submittals will be considered nonresponsive and grounds for disqualification. The District retains the sole discretion to determine issues of compliance and to determine whether a firm is responsive, responsible, and qualified. Based upon the information presented in the submissions and the pre-qualification forms, the District may elect to conduct interviews with some or all the respondents. After the interviews, if any, the Committee will

identify the firm(s)/team(s) that can provide the greatest overall benefit to the District.

#### A. EVALUATION CRITERIA

Submittals will be reviewed for responsiveness and evaluated pursuant to the specific criteria set forth in this RFQ/P, including, without limitation:

- 1. Experience and performance history of the firm with similar services;
- 2. Experience and results of proposed personnel;
- 3. Acceptable and verifiable professional references for relevant experience;
- 4. Current commitments and ability of firm to handle several simultaneous projects, including without limitation, availability of staffing and the level of service and support for the Project(s), and availability of resources to meet anticipated schedule and Project requirements;
- 5. Capacity and commitment to provide services to District, including ability to respond to District's requests in a timely and appropriate fashion; to inform District of all issues discovered on the Project; and to work positively and cooperatively with District's team;
- 6. Credentials, including without limitation, professional and technical expertise, of specific employees assigned as members of the proposed team for the District;
- 7. Proposed Fee and value of services; and
- 8. Overall responsiveness of the SOQ and Proposal.
- 9. Approved prequalification submittal

#### **B.** DISTRICT INVESTIGATIONS

The District may perform investigations of responding parties that extend beyond contacting the references identified in the SOQs. The District may request a respondent to submit additional information pertinent to the review process. The District also reserves the right to investigate and rely upon information from other available sources in addition to any documents or information submitted.

#### C. INTERVIEWS

The District, at its sole discretion, may elect to interview selected firm(s). The District may elect to interview one or more firms. In the event the District does so, the procurement scoring will be cumulative. If your firm is requested to come in for an interview, the key proposed Project staff will be expected to attend the interview. The interview will be an opportunity for the District's Selection

Committee to further inquire as to the firm's suggested approaches to the projects and the issues identified in this RFQ/P. Any comments or objections to the District's form of Agreement attached to this RFQ/P as **Attachment A** may be the subject of inquiry at the interview.

# ATTACHMENT B PROJECT DESCRIPTION: MARIPOSA ELEMENTARY SCHOOL NEW CONSTRUCTION AND MODERNIZATION IMPROVEMENTS PROJECT

The District has selected Caldwell Flores Winters, Inc. (CFW) to act as the District's program manager to direct the selection, design, approval and construction phases for the team of professionals required to implement the Mariposa Elementary School New Construction and Modernization Improvements Project (Project). Selected firms shall work at CFW's direction in the presentation of work product to be approved by the District.

The Mariposa TK-8 School Modernization and New Construction Project (Project) consists of the modernization of 18 of the school's existing permanent classrooms, providing 21st century improvements to 12 portables and the existing library, removal of select portables, and the construction of four new permanent transitional kindergarten/kindergarten (TK/K) classrooms, a new music room, a new science lab, and a new gymnasium. Improvements are to be built according to current State code, District specifications, and 21st century educational program requirements. Modular construction is planned for the new TK/K classrooms, music room, and science lab.

The need to house students in interim facilities will be required during the new construction and modernization of classroom improvements over the project's duration. Based on available funding and the estimated eligibility for State grants, proposed improvements are depicted in Figure 1 below.



Figure 1 – Mariposa Elementary Proposed Improvements

#### **Proposed Improvements**

The Project consists of the modernization of 18 of the school's existing permanent classrooms, providing 21st century improvements to 12 portables and the existing library, removal of portable classrooms 29-32 and 38, and the construction of four new permanent modular TK/K classrooms, a new permanent modular music room, a new permanent modular science lab, and a new gymnasium. Improvements are to be made according to the current State code, District specifications, and 21st century educational program requirements. The four Title 5 compliant TK/K classrooms are to be constructed in the current location of portable classrooms 29-32 and 38, and a new modular music room (1,200 square feet) and new modular science lab (1,200 square feet) are to be constructed near classrooms 16 and 18. The 18 existing permanent classrooms are to be modernized and receive 21st Century improvements, including new furniture and technology. Twelve portable classrooms, including three SDC rooms, will continue to be used for instruction and are to receive furniture and technology upgrades. The school's library will also receive 21st Century upgrades to create a more modern library media center. Three additional portable classrooms will be used for support services but will not receive improvements. A new 8,000 square foot gym with changing facilities is also proposed to be constructed. Modular construction is planned for the new music room, science lab, and TK/K classrooms. The new modular music room (1,200 square feet) and new modular science lab (1,200 square feet) may be combined into one 60' x 40' modular building of 2,400 square feet total.

#### **Project Specifications**

#### I. Kindergarten Classrooms

Under State standards and proposed District 21st Century Learning Environment specifications, transitional kindergarten/kindergarten (TK/K) classrooms must incorporate Title 5 mandates of not less than 1,350 square-foot, including required in-classroom restrooms, storage, teacher preparation areas, and wet and dry facilities. The restrooms are self-contained within the classroom, with access from the play area, if possible, and are designed to allow for supervision from all areas of the classroom and play yards. It is divided into two components: a private toilet and a common sink area for washing their hands. A fenced play yard is designed to provide a variety of activities for the development of large motor skills with associated impact resistant surfaces where elevated play structures may be located. There is a sink that is needed for science and art projects and for washing hands prior to lunch that is independent of the restroom facility.

#### A. Design Requirements

- The modular classrooms of approximately 1,440 square-foot each are to include a shared restroom, workroom, and vestibule with an exterior door.
- Sliding markerboards are installed to cover approximately forty-five (45) to sixty-five (65) percent of classroom wall surfaces
- On walls without markerboards, mineral fiber core tackle panels may be installed to maximize presentation space and help modulate acoustic reverberation.

- Broadband-connected high-definition displays are attached to hydraulic wall mounts
  which allow easy adjustment of the displays' viewing angle and height to allow students
  to view content from any point in the room.
- One (1) share restroom space of approximately 200 square-foot, to include two (2) Title 5 compliant toilets and stalls as well as two (2) sinks in the shared vestibule
- One (1) shared work room of approximately 200 square-foot accessible from both classrooms with one (1) row of shelving 6' high along three (3) of the interior walls.
- Eight (8) 4' by 9' fixed markerboards, which will be located along the two non-windowed walls
- On walls that do not have markerboards, mineral fiber core tackle panels will be installed
- One (1) sink with approximately 6' of plastic laminate countertop space near the exterior door
- Blocking and framing for three (3) broadband-connected high-definition video displays will be added in each classroom and attached to hydraulic wall mounts which allow easy adjustment of the display's viewing angle and height. Location to be determined by the District during design.
- Four (4) 4' by 9' platinum-quality sliding markerboards, which will be located along the two windowed walls and can be stowed on either side of each respective set of windows. Tracks shall span module joints
- Lighting fixtures should provide a general condition of room illumination to allow sufficient legibility of materials, while minimizing glare on electronic screens. Options to provide energy efficient solutions may be considered.

#### II. Music Room

The Music Room is designed as an open space to accommodate different music programs the school might offer including band and choir. In addition to the main open space, approximately 150 square feet of attached storage is required for instruments or equipment students are using in the program. There are acoustic panels on the walls and ceiling as needed to meet the acoustic needs of the room and to minimize disruption to adjoining classrooms. There is a large flat screen display at the front of the room between stationary marker boards. The music room will include sliding marker boards along walls with windows and sliding marker boards in front of mobile storage furniture and instrument storage areas.

#### A. Design Requirements

- A new 1,200 square-foot Music room to be constructed near classrooms 16 and 18.
- One (1) sink that meets codes.
- Open floor plan.
- Lighting fixtures should provide a general condition of room illumination to allow sufficient legibility of materials, while minimizing glare on electronic screens. Options to provide energy efficient solutions may be considered.

#### III. Science Lab

Science labs include 1,200 square-foot of open space, equipped with Wi-Fi connectivity, mobile group science tables with chemical resistant tops, and stools and workstations that can be moved as needed to support the instructional needs of the day. Storage cabinets are mobile and flexible so that they can be selected to meet the specific needs of the curriculum chosen. There is a lockable storage room of 100 square feet with shelves for the equipment, supplies and chemicals needed for classroom instruction. Markerboards are available on most walls, and where windows occupy greater than 20 percent of the vertical wall space, a floor-to-ceiling markerboard installed on a track may be "rolled" in front of the window to provide additional instructional space as well as temporary obstruction of natural light when digital projectors are in use or light sensitive experiments are taking place. On one wall, a long trough sink with six faucets for students to clean science equipment at the conclusion of an experiment is provided. Standard fixtures required for safety, including a mobile fume hood, and an eye-wash station are also in the room. There are three monitors with WIFI accessibility that are at least 60 inches diagonally and are mounted on reliable adjustable arms that provide the option of extending the display out from the wall.

#### A. Design Requirements

- A new 1,200 square-foot Science lab room to be constructed near classrooms 16 and 18.
- One (1) long trough sink with six faucets that meets codes on one wall.
- Open floor plan.

#### IV. General Requirements

It is anticipated that the design of these buildings will include the following specifications and amenities:

- Dual pane anodized aluminum windows.
- Exterior Doors will be hollow metal with a vision panel. Door hardware is to be recommended by the proposer and approved by the District.
- Embed weld plates are to be furnished by this contractor and installed by the lease leaseback contractor
- Poly vents and access frames and grates furnished by this contractor and installed by the lease leaseback contractor
- HVAC units and fans
- Minimum 2" x 6" exterior walls.
- 6' of weather overhang over the exterior door.
- Standing seam metal, 24-gauge roofing.
- Exterior finishes are to include cement plaster, painted 2-tone with trim color, the design of which is to be approved by District.
- One (1) exterior LED light fixed near the exterior door and one (1) LED light on the side of the building
- Current DSA code-compliant interior lighting comprised of approximately fifteen (15) overhead LED 2' by 4' troffers in ceiling grid.
- Title 24 compliant electrical systems, including a duplex electrical ceiling box mounted in acoustic ceiling grid the touchscreen data box and required conduit
- One (1) data ceiling box mounted in the acoustic ceiling grid, seven (7) wall mounted data boxes, routed to the ceiling plenum and one (1) data floor box routed to the ceiling plenum.
- Code compliant conduit throughout all utility systems the fire alarm and security to be approved by the District, as well as for the clock, bell, and PA systems.
- Twelve (12) duplex convenience wall outlets per classroom
- Completed connections of utilities within five (5) feet of the buildings
- All buildings will be on concrete foundations.

#### **Additional Project Requirements**

The following shall be considered and incorporated into the Project.

- The proposer must describe its product's foundation system for each building type and to specify if it is included in their proposal. If the foundation system is included, the proposer must list the cost of the foundation system.
- Mechanical systems are to be approved by District. The proposer is to recommend system, testing, and balancing, and to provide certified air balance report.
- Electrical and data systems, locations of which will be determined by the District, are to include:
  - One (1) data ceiling box mounted in the AC grid. Seven (7) wall mounted data boxes and one (1) data floor box with code-compliant conduit routed to the ceiling plenum.

#### **Project Budget and Schedule**

The total project budget is \$18,582,100 and represents the total "all-in" budget. The "all-in" budget is estimated in current dollars (including contingencies, and both hard and soft costs), including demolition and site work. The construction budget (projected Guaranteed Maximum Price, or "GMP") for the project is \$13,926,676 inclusive of general conditions and requirements, contractor fees and overhead. The soft costs include design fees, consulting services, testing and inspection services, agency approval fees, furniture and equipment (FF&E), etc.

- DSA Submittal: December 2025
- DSA Approval: May 2026
- Bidding/Start Construction: June 2027 (subject to change and availability of funding)
- End Construction: November 2028

The anticipated project timeline is subject to adjustment based on the timing and processing of administrative approvals, prevailing market conditions, weather, environmental conditions, and unforeseen site conditions.

#### **Method of Delivery**

The District desires to contract directly with the modular manufacturer for the delivery of the new classroom buildings. A site contract will be selected through a lease-leaseback (LLB) or a design-build method of construction as selected by the District. The modular manufacturer will be expected to work collaboratively with the architect and either the lease-lease pre-construction services contractor or design build contractor, to develop proposed designs, cost estimates, construction schedules, and a site logistics strategy, resulting in a design that meets District specifications, functions, budget and timeline.
