## Superintendent's Report November 2025

Mission Statement: Walden Academy is dedicated to fostering integrity, academic excellence, and social-emotional growth in our students. With small class sizes and low student to adult ratio, we create a nurturing environment that values curiosity, accountability, and perseverance, guided by the CARES traits. Utilizing Responsive Classroom and Toolbox strategies, we offer personalized intervention time and rigorous academics to instill a growth mindset. Our River Hawk STEM and Ag program connects students to their rural roots while preparing them for future success, supported by hands-on learning and engaging out of school learning experiences. We value and seek active partnerships with families and the community to enhance our students' educational experiences.

**I. LCAP Goal 1:** Walden Academy will provide learners with engaging and challenging learning opportunities in a broad course of study through the implementation of state academic content, performance, and ELD standards. Learners will be instructed by highly qualified professionals with sufficient instructional material and technology, on a well maintained campus set up to meet the needs of all learners.

## **Conditions of Learning**

## 1. Basic

#### A. Credentialed teachers

We currently have 2 individuals working with emergency/ preliminary credentials. One is a teacher in their second year of induction. The other is Joe Schykerynec. He is currently taking courses. Mrs. Brown has been teaching 6th grade since the beginning of the month, and we are very pleased with her performance thus far. It has been a huge transition for this grade.

## B. Access to standards-aligned instructional materials

Nothing has changed. All students have access to standards-aligned instructional materials. Students have been working in our new program Lexia English. It has helped greatly with our designated ELD.

## C. Facilities in good repair

We completed the FIT report for this year and facilities are in decent condition. I will be reaching out to PTC regarding some projected improvement needs.

- **2. State Standards Implementation---***English language development standards and academic content & performance standards* 
  - **A. Differentiated Assistance:** As part of differentiated assistance with the state, the county has stepped in to support us with academics. We have officially closed out

our year of DA, and will continue working with GCOE. Presentation to follow.

## **B.** Walk-Through Data: Walk throughs highlight the following:

Summary and Comparison to October:

Student engagement remained strong with a 93.2% average on-task rate, slightly down from October's 94.8% but still above target. Differentiation continued to be highly visible in all classrooms, with strong use of process and environmental adaptations. Instructional aide utilization improved significantly (from 63% in October to 83% in November), reflecting better small group and individual student support.

While at least one form of UDL/ELL strategy implementation was at 83%, the drop in student-to-student discourse (from 38% to 17%) signals a need to re-emphasize peer interaction opportunities. Overall, classrooms demonstrated high engagement, quality questioning, and strong formative practice.

## **3. Course Access---**broad course of study

## **Broad Course of Study**

- **A.** Field Trips: By the end of this week, all classrooms will have gone on at least one field trip. Some have already had several. All lower grades did the first ever Barnyard Bash at the High school and enjoyed it. 6th grade is going on a floating field trip this week.
- **B**. River Hawk AG/STEM- We officially have our own FFA Chapter. In addition, 12 students participated in the Agribee. Mrs. Fischer and I will be attending the ACTE conference next month in Tennessee.
- C. We are gearing up for the Winter Songfest and teachers have picked songs and have begun practicing with their students. PTC will support.
- **II. LCAP Goal 2:** All Walden Academy learners will make annual growth towards meeting or exceeding standards in English Language Arts (ELA) and mathematics demonstrated by CAASPP/SBAC, other benchmark assessments such as iReady and report cards.

## **Pupil Outcomes**

- 1. Student Achievement- We are working towards our school and classroom goals. Students took the iReady Diagnostic test this week, and we are using the data to drive instruction.
  - **A.** School Goals: We will maintain the goals of last year. The school theme for this year is "Strong Roots, Exceptional Results", so you will see a lot on that

and we are hoping our collective collaboration with adopting this theme will also equate to growth.

- 1. Walden will have 45% of students score on or above level on the CAASPP for the 2025/26 school year in ELA.
- 2. Walden will have 30% of students score on or above level on the CAASPP for the 2025/26 school year in Math.
  - Test results from CAASPP show an 8.8% increase in ELA, 5.5% increase in Math and a 2.5% increase in Science. This puts us tentatively at 33.3% proficiency in ELA, 21.8% in Math and 22% in Science. This is huge growth!
- **B.** School Dashboard update: We are all yellow! Suspension rate decreased, and academics increased. Chronic absenteeism stayed the same.

III. LCAP Goal 3: A positive school climate for all stakeholders participating in activities that increase student engagement, attendance and parental involvement. Particular focus and attention will be given in the areas of attendance and positive student behavior to address low attendance rates and increased number of suspensions. An expansion of the food program to include second chance breakfast.

## **Engagement**

- **1. Parent Involvement---**efforts to seek parent input in decision making & parent participation in programs for special need subgroups
  - A. Newsletters weekly.
  - B. We have been busy posting updates, videos and picture compilations on Instagram and Facebook
  - C. We have our next Parent University planned for Dec. 2nd from 6-7:20pm.
    - 2. Pupil Engagement---attendance rates/chronic absenteeism
      - **A.** Attendance: Average daily attendance has gone back up to 96.18%
      - **B. Spirit:** Spirit award will be given to the classroom with the best attendance this month.
    - **3. School Climate---**suspension/expulsion, school safety & connectedness
      - A. Connectedness: We are currently doing an underground spirit week to increase attendance and to have fun as a staff. We have a holiday party planned for Dec. 19th. Ms. Jamie, Mrs. Berglof, Mrs. Crawford and Ms. Ashley received the staff of the month award. Mr. Joe and I will be delivering our Annual Report to the GCBOE this Thursday.

- **D. Safety:** We have had no safety issues or claims this month.
