Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. Student Achievement Goals & Progress Monitoring Linda Verde's Single School Plan for Student Achievement (SPSA) prioritizes improving outcomes in English Language Arts and mathematics, accelerating English Learner progress, and strengthening student engagement and regular attendance. school uses multiple progress indicators—including CAASPP, i-Ready diagnostics, DIBELS, ELPAC, STAR Spanish, sown to Grow SEL data, and PBIS-SWIS referral trends—to monitor growth and drive instructional decisions. Progress is reviewed every 6–8 weeks through PLC data cycles, classroom walk-throughs, and district assessment checkpoints to ensure timely intervention and continuous improvement. School wide Programs & Supports Linda Verde offers a variety of high-quality programs to support academic and cultural enrichment, including Dual Language Immersion, Mariachi and Folklórico performing arts, student athletics, and a growing Community Schools model designed to connect families with resources. Additional supports such as Tiered Intervention Systems, Special Education services, and Newcomer supports ensure equitable access to learning for all students.

School Facility Conditions and Planned Improvements

General

The district takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument developed by the Los Angeles County Office of Education. Maintenance and Repair

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

Cleaning Process and Schedule

The district governing board has adopted cleaning standards for all schools in the district. A summary of these standards is available at the district office. The facilities department works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance Budget

Although the State no longer requires a Deferred Maintenance contribution, Lancaster School District is still dedicated to maintaining the facilities for our students. These expenditures would include but not be limited to roofing, plumbing, heating, air conditioning, electrical, painting, and flooring. For the 2024-25 school year, the district has budgeted \$2,683,000. for deferred maintenance projects.

opportunities are recognized as an important component in our work towards continuous improvement in student learning.

Ongoing opportunities include in-services during and after the work day as well as through site and district in-class and on-site coaching. All teachers are provided multiple opportunities to receive optional paid professional development. The school year calendar allows for 37 minimum days in which 26 days are utilized to provide 1-2 hours of district and site designed professional development specific to their needs. Outside workshops, conferences and other in-services that provide more in-depth training and further prepare our staff members to become trainers for our district are available as approved by the Board of Trustees.

Professional development supporting our instructional programs and services for students is also provided for our classified staff members. Additionally, workshops designed to improve technology skills, provide training with key software programs utilized in the district, and offer information on personal excellence and social responsibility are included in the professional development course offerings for classified staff throughout the school year.
