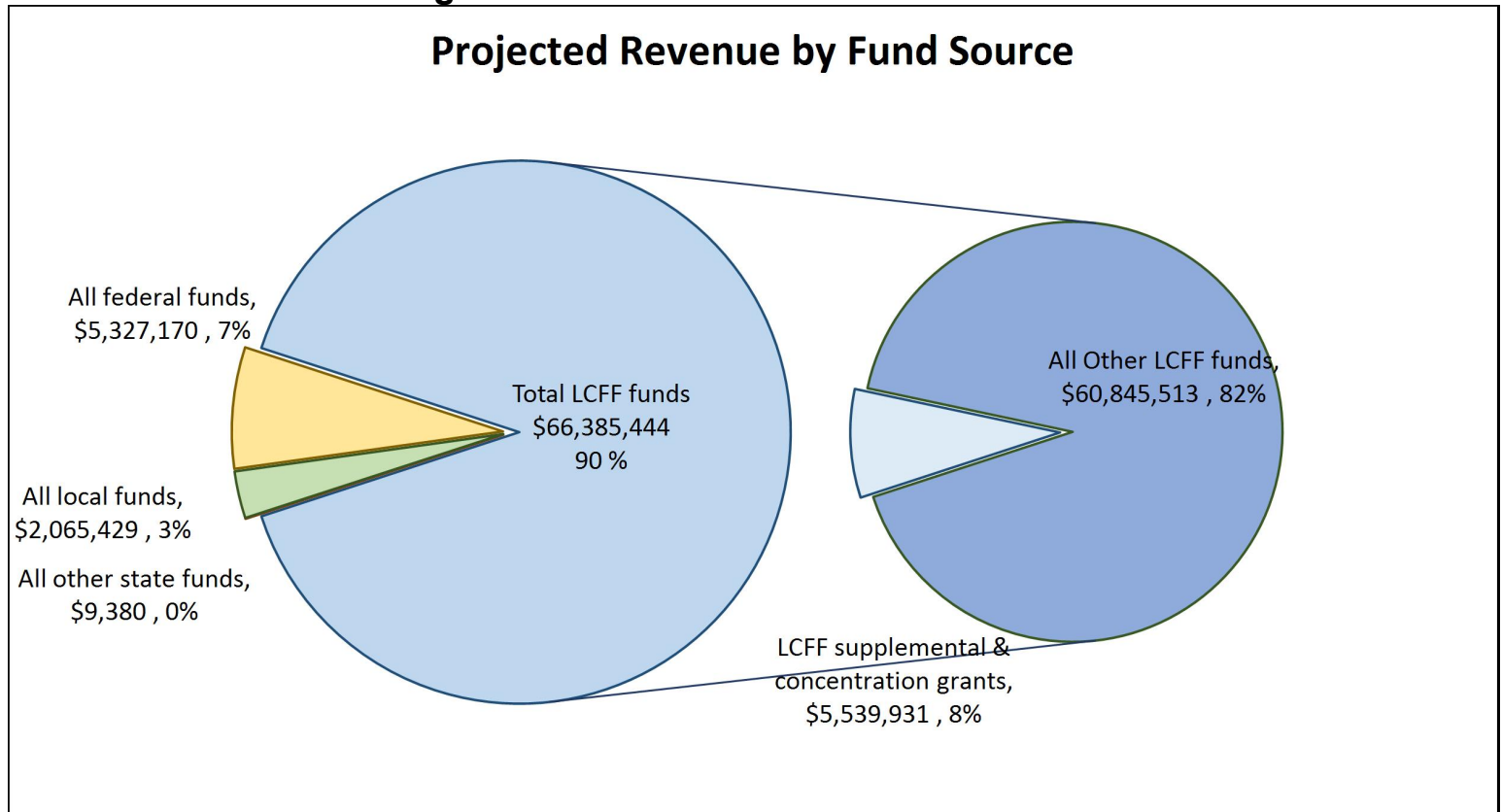

Projected Revenue by Fund Source

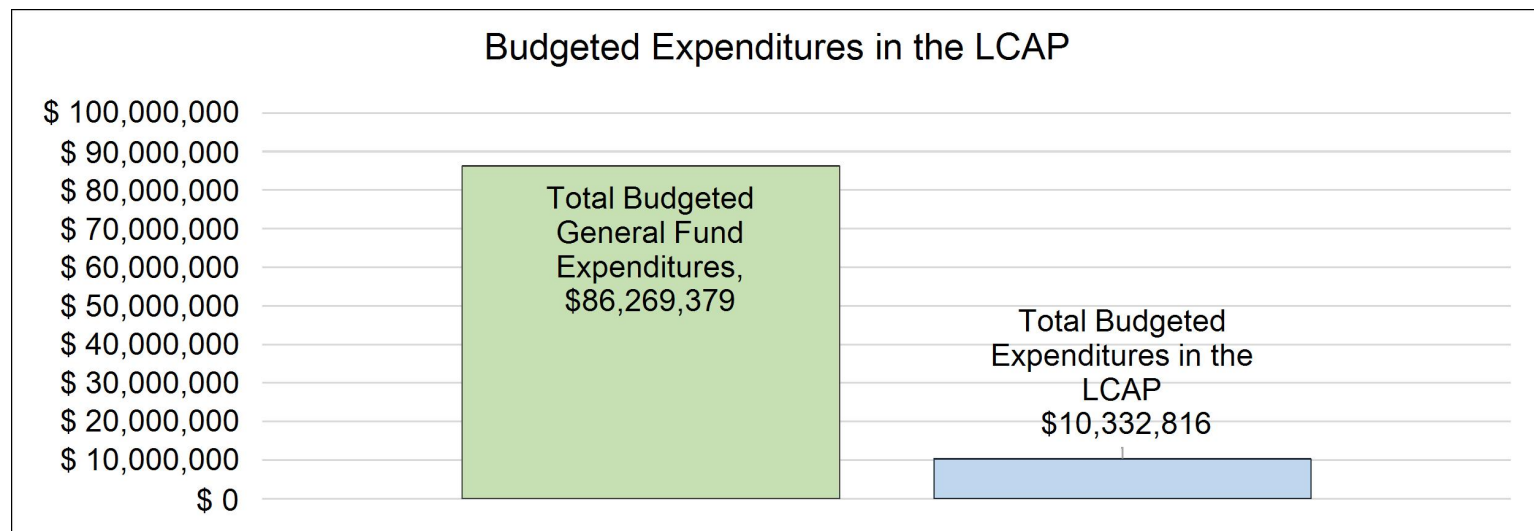


This chart shows the total general purpose revenue Travis Unified School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Travis Unified School District is \$83,157,925, of which \$66,385,444 is Local Control Funding Formula (LCFF), \$9,379.882 is other state funds, \$2,065,429 is local funds, and \$5,327,170 is federal funds. Of the \$66,385,444 in LCFF Funds, \$5,539,931 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The remaining \$75.59 million in budgeted expenditures support the following programs and services: General Education Instruction (\$30.8 million), Special Education (\$19.4 million), School Site Administration (\$4.7 million - includes school site support staff), Student Support Services (\$2.7 million -includes counselors, nurses, health and student services), General Administration (\$5.2 million - includes Human Resources, Business, Superintendent, Board and Technology), Instructional Supervision & Instructional Technology (\$1.6 million), Pupil Transportation (\$2.7 million), Custodial, Grounds & Security (\$5.4 million) and STRS on Behalf (\$3 million).

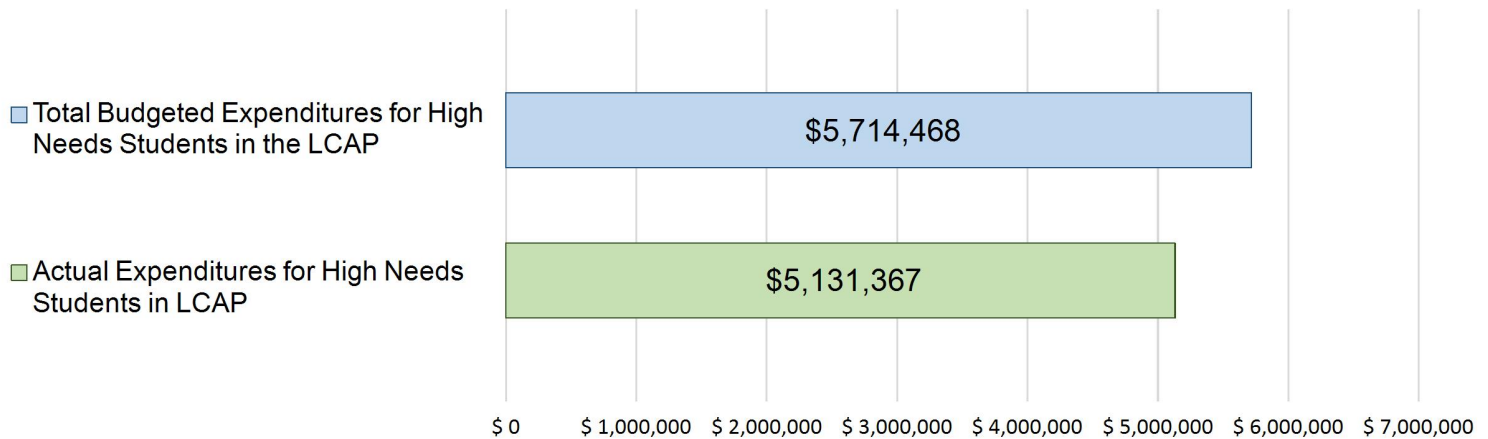

Plan Summary [2025-26]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA. LEAs may also provide information about their strategic plan, vision, etc.

Travis Unified serves 5,385 students in grades TK-12. The district is located between Fairfield and Vacaville, adjacent to Travis Air Force Base. About a quarter of our students are from military-affiliated families, and 44% of our students are socioeconomically disadvantaged. 2.9% of our students are learning English, and about 12.5% receive Special Education services. We usually serve about a dozen foster children and roughly the same number of homeless youth; both are 0.2% of our total population. Our student body is diverse, with no ethnic group making up more than a third of the population and 81 reported languages spoken in our families' homes.

We enjoy strong community support for our schools, and there is a great deal of parent involvement at school and in decision-making. Our programs, both in school and outside of school (athletics, band, robotics), are greatly enhanced through the efforts of parent volunteers.

We serve the community's children through five elementary schools, one middle school, one comprehensive high school, and an alternative high school. The alternative high school, TEC, has been designated as a Model Continuation High School. Our schools provide strong core academic programs along with rich experiences in the arts, music, STEM (Science, Technology, Engineering, and Mathematics), athletics, and Career Technical Education.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

We have had marked success with our graduation rates and English Learner Progress in recent years. Currently we have 98.3% graduation rate, with every measured student group performing at the highest level, save for our students with disabilities, who graduate at a rate of 89.4, which far outpaces statewide data. Chronic absenteeism continues to stabilize post-pandemic, and dropped an additional 4% to a rate of 13.1%

Our English Learners have also shown continued positive progress with 53.2% making progress on annual ELPAC assessments. These successes are in part due to the systematic intervention and support programs available TK-12 and also the targeted support for students at the secondary level to ensure on-time graduation.

Another area of overall growth has been suspension rates. We have seen improvement in our rates of suspension for African American students with disabilities (a previous area of focus), but have seen an increase in suspensions for African-American, Hispanic, Socioeconomically Disadvantaged, and Students with Disabilities groups.

Areas of continued focus are mathematics and English Language Arts performance, especially for students with disabilities. In both areas, our students with disabilities scored in the lowest band and that performance has declined by 13.4 points in ELA, and 2.2 in mathematics. Additionally, Travis saw a decline in ELA scores for African-American, Two-Or-More Race, Socioeconomically Disadvantaged, Asian, and Filipino students in ELA (Note: Asian and Filipino students continue to perform at the high level). In mathematics, African-American, English Learners, Hispanic, Socioeconomically Disadvantaged, and Filipino students declined.

While academic performance remains a focus for the district, TUSD does perform in the top two for CAASPP performance in Solano County, which is mirrored in local assessments, including NWEA/MAP. The overall ELA achievement level through Winter 2024-25 was 39% (high, high average) . For math, that number is closer to 38% with high levels of growth.

These academic results have impacted the College and Career Readiness Indicator for the district, which declined by 2.1%. While students are graduating from Travis at a very high rate, there is work to be done to ensure they are graduating with the requisite skills and experiences for success in the post-secondary world.

Although academic achievement has continued to be an area of focus for our students with disabilities, we have shown continued success in Least Restrictive Environment targets as our special education team continues to make strong progress toward meeting targets. The percentage of students with disabilities spending 80% or more of their day in general education classrooms has gone from 48.7% to 54.1% to 64.3% over the last three years, exceeding the state target of 53.2%.

Reflections: Technical Assistance

Currently, Travis Unified is involved in two levels of technical assistance: Compliance and Improvement Monitoring (CIM) and Differentiated Assistance (DA). In both cases, data related to our Students with Disabilities has been the focus.

For DA, the academic performance (ELA/Math CAASPP scores and CCI) of our students with disabilities is the focal point. In partnership with our county partners at the Solano County Office of Education, Travis has been researching the various structures in place (or not) to meet the needs of struggling students at individual sites. Additionally, the team has focused on ensuring high quality first instruction for all students, including those with disabilities. Additionally, we have engaged in math specific professional development at the middle school level to address the low performance of students.

For CIM, academic performance, Least Restrictive Environment for preschool aged students (under 4 yrs) and discipline data for our African American students with disabilities were identified. For our suspension data, we were found to have significant disproportionality for our African American students with disabilities, when compared to all students with disabilities. In 2023-24, we focused primarily on our suspension data, as this disproportionality is quite unsettling to our teachers and community. We created a team with members from each school site, did a data deep dive into all suspensions covered by this disproportionality and did a root cause analysis. We spent the last year with this group identifying the practices and beliefs that have impacted our suspension data. Working collaboratively with our SELPA, site general education and special education teachers, administrators and coordinators, we created a new suspension protocol for our students

with disabilities, refined our MTSS and PBIS structures and generated site-specific "other means of correction" options. We also provided cultural competency training for all teachers and administrators and scheduled de-escalation training for all teachers in the summer. This work resulted in us ending our disproportionality in suspension data, and we are now monitoring this plan. In 2024-25, our focus has been to build on this positive momentum using the same team that effectively addressed the suspension concerns. Aligned to our DA work, we have been working with practitioners to better understand the current practices and systems that are leading to the current result with an eye to disrupting those which are not having the intended positive impacts.

Information from educational partner consultation was categorized by goal or subject and summarized for consideration by administrators, who also considered data from previous years about the effectiveness of actions and services, educational research, and available financial resources. There was a strong consensus from multiple educational partner groups in support of the major items included in the LCAP. A reorganized and simplified set of actions and services emerged from this work. To make the LCAP more user-friendly, we continued to focus the LCAP on a few high-leverage areas rather than including everything being done in the district. Newly mandated areas of priority have been added at the school and district level.

We posted the draft of the LCAP on our website on May 31, 2025. The public was invited to submit comments related to the draft LCAP, including feedback about specific actions, services, and expenditures. The public was given the opportunity to comment on the plan at public hearings on the 2025-26 LCAP and district budget at the Board meeting on June 10, 2025. The superintendent had responded in writing to questions from the public. The Board adopted the LCAP and district budget at their meeting on June 17, 2025.

<p>Academic achievement is the primary purpose of school districts. This goal includes focus areas as measured by Goal 1 metrics along with a broad emphasis on equitable and positive outcomes for all students. We believe that all students can achieve and with the right supports and innovative curriculum we can engage students actively in their educations. We are committed to closing the achievement gap. An achievement gap is also an opportunity gap, which leads to an income gap, which leads to a gap in positive life outcomes, including a healthy lifespan. We believe that education is the antidote to poverty, and that our mission is to ensure that all students thrive as adults, both personally and through high-skill, high-wage employment.</p> <p>Dashboard and Local Data Areas of Focus: Our 2023-24 data showed we needed to focus on improving the performance of students with disabilities and low-income students. Local data (from NWEA MAP and class grades) from the 2023-24 school year shows those groups and English learners continue to need additional support. These trends continued on the 2024-25 Dashboard. Based on our data, our LCAP is focused on improving outcomes for all students, with special focus on students with disabilities at all school sites.</p> <p>When looking at the grade data for our secondary students (grades 7-12) we also see some troubling trends, especially for students in the 9th grade. Studies show that transitional periods (i.e., when a student goes from middle to high school) can be challenging for students. Nonetheless, we are committed to addressing the high number of students who do not successfully complete Algebra 1, World History, and English 1 on the first attempt. Unfortunately, success rates for students with disabilities in co-taught classes are not as we would hope.</p> <p>Feedback from Community Partners: Academics continue to be an area of focus for families, teachers, administrators and support staff. In focus groups, students often cited academics as an area of stress and the need to balance academic and social/family/athletic commitments. Although students reported different areas of challenge, math, science and English were all top for students across the grade levels. Whereas electives and college and</p>

career (CTE) classes were often seen as highlights, including history, Automotive and Medical Science. When students with disabilities were interviewed, both math and writing were considered the most challenging for elementary students and they would like more art. Students had suggestions to help improve their performance, including getting help from teachers, getting help and staying up-to-date on homework, and having fewer subs or having more "trained" subs.

1.1: Action implemented as written. Assessment results are used to create instructional groups for enrichment and/or intervention. Data are accessible to staff in a variety of ways, and used to make student-centered decisions.

1.2: Action implemented as written. Supplemental materials are available and used by staff to enhance English Learner access.

1.3: Action implemented as written. WIN is in place at all elementary sites. Assistant Principals are key players in efforts to provide targeted support for students.

1.4: Action implemented as written. Math Coach, supplemental materials, and professional development all in place for 2024-2025.

1.5: Action implemented as written. Additional sections allotted at secondary schools to better meet students at their level. Professional development in integrated ELD strategies occurred throughout the year. The Director of Curriculum and Instruction provides ongoing direct support to the ELD program.

1.6 Action implemented as written. Outside the school day tutoring is available at all sites, and a secondary summer school is in place to remediate credits. There is ongoing work to better align CTE offerings and an expansion of programming is planned for the 2025-26 school year.

1.7: Action implemented as written. Targeted leadership training centered on student achievement provided to leaders. All schools provided an allotment for site specific PD, and the elementary program received additional math support through the Math TOSA.

1.8: Action implemented as written. Home to school transportation is a key action to meet the needs of low-income families, and is a highly utilized service.

1.9: Action implemented as written. All schools have active MTSS teams, supported by the Directors of Student Services and Curriculum and Instruction. Moreover, the county office is supporting us in enhancing these efforts through the DA process.

No material difference between budgeted expenditures and estimated actuals.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

1.1: Assessments and data visualization allow for effective and ongoing monitoring of student achievement. Instructional groupings based on individual student needs are possible as a result. Students enrolled in elementary intervention groups show increased improvement on assessments which outpaces those of students not enrolled.

1.2: Specialized supplemental materials allow for teachers to effectively differentiate instruction for students based on their needs.

1.3: Intervention during the instructional day based on student needs from specialists effectively impacts student learning as evidenced by improvement on norm referenced assessments. Assistant Principals, TOSAs, and SST Coordinators are essential to MTSS efforts, which drives Goal 1's focus to improve instructional quality and equity for all students. Students take advantage of offerings to accelerate credit recovery as evidenced by the district's high graduation rate.

1.4: The SCOE math coach has met with and trained math teachers throughout the year. During observations and walkthroughs evidence of impact on instruction has been noted by site and district leaders.

1.5: Additional sections to reduce class sizes and to provide more discreet instructional groupings allow for more targeted and individualized instruction based on student need.

1.6: After school tutoring and summer school provide needed support of students preparing to meet A-G college entrance requirements. Ongoing support of the CTE program has resulted in a new pathway for the 2025-26 school year.

1.7: Site specific PD allows schools to be responsive to the unique needs presented in their contexts. Coaching for leaders centered on equity and supporting the instructional program results in administrators equipped to work with teachers to improve practices that benefit all learners.

1.8: 37% of our bus ridership are low-income students. Families report this is a critical service in order to get their students to school on time, safely, and ready to learn.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

In 2025-26 the 6th grade students in Travis Unified will move to the middle school. With the addition of approximately 400 students to the site, many of whom will need access to systems of support, the district will add a 1.0 FTE Assistant Principal to the site and will be added to Action 1.3.

An explanation of why the LEA has developed this goal.

We established this goal based on the understanding that student social and emotional well-being serves as a cornerstone for academic success. Embracing a 'whole child' approach, we prioritize fostering secure, enduring relationships that nurture academic, physical, cognitive, social, and emotional development. Research consistently underscores the effectiveness of this relationship-centered approach in enhancing achievement across diverse circumstances. Recognizing that every child requires a foundation of health, safety, engagement, support, and challenge, we remain steadfast in our commitment to this holistic approach.

The enduring effects of pandemic-related isolation and social stresses continue to manifest in students. Thus, maintaining a focus on this aspect remains imperative. Additionally, the TUSD Board, in conjunction with robust community involvement recently created a new Strategic Plan. This plan identifies safety and socio-emotional wellness as the top two priorities of the district.

Data supports this focus as our students continue to report high levels of chronic sadness (Elem: 17%; Middle School: 30%; Vanden: 29% and TEC: 24%). Although students at all grade levels report high expectations from adults at school, and generally high scores for feeling physically safe at school, there has been a sustained drop in school connection; this includes all student groups, even elementary students who traditionally report high levels of school connection.

Focus group and survey data supports a focus on socio-emotional supports, as it is the top single subject that teachers requested PD on this year. They also identified a need for peer collaboration, trauma informed practices and de-escalation training. Our labor partners shared this desire for increased training.

2.1: Action implemented as written. Staff hired in accordance with plan and implemented services as described.

2.2: Action implemented as written. Tier 2 social-emotional wellness services delivered by social workers and in wellness centers.

2.3: Action implemented as written. PBIS systems, support, and professional learning in place at all sites. CA-ISP training occurred throughout the year as scheduled. Use of SWIS in place at all sites.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between budgeted and estimated actual expenditures.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

2.1: Evidence of effectiveness includes implementation of Playworks strategies and activities at all elementary sites. WEB, Link Crew, and Anchored 4 Life programs in place and serving students across the district. There was a reduction in suspensions for targeted student groups, and the suspension rate is now .8% lower than when these actions and services began. Graduation rates remain highest in the region and high for all student groups.

2.2: Student attendance rates continue to improve, and our Chronic Absenteeism rate, as measured on the CA School Dashboard, is well below county and state averages. No student groups are in red status for this indicator, and we continue our downward trend toward pre-pandemic rates ahead of other districts in our region.

2.3: Each school site has received 6 sessions of CA-ISP training. PBIS is in place at all school sites, and a number have earned distinction awards from the state. Suspension data continue to trend downward. Wellness Centers are open at each site and have been visited over 3,000 times by over 750 students. SWIS data is utilized weekly at school sites to monitor current PBIS structures and to implement appropriate actions based on trends.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Historically, Travis Unified has used a local survey to gauge student sentiment around safety, well-being, and school connectedness, among other areas. While a fine survey, for the 2025 LCAP and beyond, we will use the California Healthy Kids Survey (CHKS) as it is a norm-referenced, industry standard survey of students. By using this survey, we will be able to gather more reliable information about our students, have access to a more robust reporting system, and be able to compare our results with other districts across the state.

Priority 3: Parental Involvement (Engagement)

An explanation of why the LEA has developed this goal.

Open transparent communication and authentic partnership with families are key for schools to succeed. We honor the role of families and the community in the educational process, and we recognize that schools that want to fully serve their students benefit from the active participation and support of their community. Staff and family surveys, along with the messages of the Board, continually highlight the pivotal role that families have in the work of education. Families regularly have favorable opinions of our schools, with most families rating their overall recommendation of their school at 8 out of 10. However, there are some areas of focus where families describe less positive experiences; these areas are items of focus for all staff, both classified and certificated alike. From survey data, families were overall positive for family involvement. An area of growth for all schools except TEC, is post high school planning and options.

The California Department of Education (CDE) has also developed a self-reflection tool to monitor progress in this area and encourages it's inclusion in LCAPs. Although this fact did not influence our motivation to add this goal area, it did influence the metrics that we are including, as they align with the CDE local indicators reflection tool. To make the questions more relevant to families, Likert scale questions used common language of "strongly agree, agree, neutral, disagree, strongly disagree" instead of CDE self-reflection tool language: exploration through full implementation and sustainability" Staff were also asked these questions, using the CDE language, information from both are included below to give a fuller understanding of our progress on these areas.

An analysis of how this goal was carried out in the previous year.

3.1: The work of the equity action team has been picked up by other standing groups, namely the Continuous and Improvement Monitoring (CIM) teams, the Administrator Academy team, CA-ISP trainings, PBIS teams, and MTSS teams. Additionally, training from social workers and behaviorists around trauma informed practices, cultural responsiveness, and de-escalation techniques are ongoing.

3.2: District and school committees are in place as written in the action. These include School Site Councils, PTAs, DELAC, Superintendent's Parent Advisory, among others.

3.3: Action implemented as written, with the exception of a months-long vacancy in the fall when the parent liaison resigned. The position has been hired for. Other actions, such as Parent Square, improved web services, and communication software are in place as planned.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The parent liaison position was vacant September through December, resulting in reduced costs for this program. Professional development for classified staff on providing welcoming environments did not occur. Monies allocated for Equity Action Team, whose work was absorbed by CIM and other groups, was not spent as allocated.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

- 3.1: Actions have resulted in improved outcomes for students targeted for disproportionate data. For example, African-American students with disabilities saw a drop in suspension rates after focused work from the CIM teams. Individual school sites have created action plans to address a problem of practice identified through data analysis during Administrator Academy training. CA-ISP sessions have focused on equitable, culturally relevant practices to ensure all students attend school in a welcoming, culturally responsive setting.
- 3.3: Suspension data continues its downward trend. There is evidence of improved satisfaction with home to school communication as reported in family surveys.
- 3.4: Parent participation in Parent University activities remains strong. Family nights at schools remain well-attended and positively received per family surveys.
- 3.5: Training classified staff to create more welcoming, culturally relevant experiences for a our community remains a priority with our labor and community partners.

Basic services are essential for fostering academic achievement. In alignment with State Priority 1, which focuses on Basic Services and Conditions at Schools, we have established a maintenance goal in our LCAP. This goal addresses the Williams Act requirements, ensuring all students have equal access to instructional materials, qualified teachers, and safe learning environments. It informs our educational partners about our efforts in teacher assignments, textbook adequacy, facility maintenance priorities, and the integration of new textbooks and technology. Additionally, our LCAP emphasizes a robust new teacher induction program designed to elevate the performance of students with high needs and narrow the achievement gap.

Additionally, the Board has identified facilities maintenance and overall safety as key areas of focus. Student safety and security (as related to physical setting) were the top priority of the new TUSD Strategic Plan and the District has spent considerable time and community feedback into a new Facilities Master Plan.
