

MEMORANDUM OF UNDERSTANDING
Between
SAN RAMON VALLEY UNIFIED SCHOOL DISTRICT (SRVUSD)
And
SAN RAMON VALLEY EDUCATION ASSOCIATION (SRVEA)

WALT DISNEY
MODERATE KINDERGARTEN SDC PROGRAM
2026-27

The San Ramon Valley Education Association ("SRVEA") and the San Ramon Valley Unified School District ("District"), collectively referred to herein as "the parties", mutually agree to the following provisions supporting the provisions to support the Moderate SDC program at Walt Disney Elementary Program during the 2026-27 school year.

Kindergarten students rostered in the Moderate Special Day Class (SDC) will receive their IEP-designated mainstreaming minutes in the general education kindergarten classroom as follows:

- Students enrolled in the Moderate Special Day Class (SDC) will participate in the general education kindergarten classroom as determined by their individual Individualized Education Program (IEP);
- The Moderate SDC teacher and paraprofessionals will accompany and support students in the Moderate class during their time in the general education classroom;
- The Moderate SDC teacher will be the teacher of record;
- The general education kindergarten classroom will maintain an enrollment of 12 general education students, with 12 spaces reserved for students from the Moderate Special Day Class, ensuring that the total number of students in the classroom does not exceed 24 students;
- The Kindergarten general education teacher will receive a monthly stipend of \$500. The stipend will be paid to unit member twice per year, once in January for the period August - December, and once in June, for the period January - June;
- The Kindergarten general education teacher and the moderate SDC teacher will be provided a maximum of (10) ten hours for summer planning and preparation at the instructional salary rate.
- The Kindergarten general education teacher will be exempt from the Kindergarten give back hour, to provide collaboration time with the SDC teacher and special education support providers.
- Any changes to a student's mainstreaming minutes will be determined through the IEP process, with an IEP team meeting convened to review and revise the student's Individualized Education Program (IEP) as appropriate.

The parties agree that the provisions outlined herein will be considered non-precedent-setting, and will sunset on June 30, 2027, unless extended and/or modified by mutual agreement. All provisions of this MOU are subject to the negotiated grievance procedure, including binding arbitration. The signatures below acknowledge full understanding of and agreement with the terms above.
