Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. At the Evergreen Community Day School (CDS), Our Place, the goal is to help students develop into self-disciplined, self governing individuals who respect themselves, others, and their environment, and who are capable of making decisions that are personally and socially responsible in order to successfully participate in a general education setting. They focus on ownership, unity, and respect. Students serviced by CDS are expelled, placed by a SART or SARB board, or through the SST process. The common denominator is that these students have not been successful in the regular education program and they have caused disruption and/or danger to regular education programs and students. Students are placed after other interventions have failed (Student Study Team referrals, classroom modifications, increased adult supervision by use of aide,

School Facility Conditions and Planned Improvements

The Evergreen CDS Program is located at the Evergreen Middle School campus. The CDS students share one classroom, which is separated from the rest of the school.

The Evergreen Middle School campus received an overall exemplary rating on the Facility Inspection Tool (FIT) in November 2025. The systems, interior, cleanliness, electrical, restrooms/fountains, safety, structural, and external systems are in all in good repair at this site. We have continued to increase the physical safety of students at Evergreen Middle during the past year by adding fencing around our perimeter, ensuring our lockdown and fire alarm horns are working effectively, and consistently checking our two-way radios and Aeries Communication for staff to communicate concerns and communicate with families, respectively. Window blinds, window tinting, and the use of magnets on all locked doors are used to ensure safety should we need to go into lockdown. Any issues regarding facility repair are either a) promptly brought to the attention of the EUSD Safety Committee, who meets monthly, or more often if need be, to address areas that are a safety concern, or b) submitted as a maintenance request to the EUSD Maintenance Department.

2025-26 School Safety Plan

Because the CDS Schools are located at the middle school campus, they are included into the Evergreen Middle School Safety Plan which is updated annually. We practice emergency drills including both lockdown and fire and hold trainings for staff on emergency preparedness and Covid protocols, annually. Every visitor must sign in and wear a name tag while on campus, and we require all employees to wear a name badge whenever they are on campus. We have fencing lights keeping campus well lit when dark outside, as well as additional cameras. Teachers regularly review the rules/expectations for safe, responsible student behavior.
