**A) [Review and Approve School SARC](#)**

Principal White reviewed the School Accountability Report Card (SARC), which included information on student enrollment, teacher preparation and placement, teachers without credentials, and credentialed teachers assigned outside of their authorized subject areas. School facilities were reviewed and appear to be rated in the “Good” category.

Principal White also provided additional information regarding CAASPP scores. S. Silveira noted that it was interesting that the homeless student subgroup tested higher. Principal White reported that this section of the SARC is also the only area that provides information related to the California Physical Fitness Test.

Principal White pointed out that the suspension rate as of last year was low; however, suspension rates tend to ebb and flow each year. There were no expulsions during the previous school year. The School Safety Plan was previously approved at an earlier Site Council meeting. Lastly, Principal White explained that page 18 of the SARC outlines all district funding sources.
