## **Announcement of Trustee Vacancy**

The Las Lomas Elementary School District Board of Trustees is seeking to appoint a provisional trustee to fill a board vacancy through December 11, 2026.

### **Eligibility**

Applicants must be residents of the Las Lomas Elementary School District, at least 18 years of age, and registered to vote. District employees are not eligible for appointment.

### **Service Expectations**

The board's regular meetings during this provisional term are scheduled to begin at 5:30 p.m. at La Entrada on August 26, September 16, October 14, and November 4. In addition to attending board meetings, trustees may be asked to participate in select committee meetings, school events, trainings, and other district-related activities.
