2025-2026 Autism Service Contract

THIS AGREEMENT is made this _____ day of _____, 2025 between the Ashtabula County Educational Service Center (ACESC), 2630 W 13th St, Suite A, Ashtabula, OH 44004, hereinafter referred to as the "ACESC" and the Buckeye Local School District, 3436 Edgewood Dr, Ashtabula, OH 44004, hereinafter referred to as "BLSD"

In consideration of the mutual promises herein contained, the parties agree as follows:

The ACESC shall provide teachers, paraprofessionals, occupational therapists, physical therapists, speech therapists, classroom materials and supervision for the ACESC Autism Classrooms located in the Ashtabula Area City School District (AACSD), Grand Valley Local School District (GVLSD), Pymatuning Valley Local School District (PVLSD), and Geneva Area City School District (GACSD).

The AACSD, GVLSD, PVLSD, and GACSD shall provide classroom space and classroom furniture. The student's home district will provide transportation for students to the educating unit. The AACSD, GVLSD, PVLSD, and GACSD shall make opportunities available for inclusion in the public school setting.

The staff and students will follow the calendar of the districts housing the unit(s). The district housing the unit will receive \$6,750 per unit a year for rent.

This Agreement shall commence on the above stated date and shall terminate on June 30, 2026.

The BLSD agrees to the following costs for the program.

Educational Services	\$39,240/yr*
Occupational Therapy Services:	\$54.97/hr-OTA; \$75.03 /hr- OT
Physical Therapy Services:	\$54.97/hr- PTA; \$75.03/hr-PT
Speech	\$72.50/hr
