IPM statement

It is the goal of Bonita Unified School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

Identify, exclude, and eliminate pests using natural and non-toxic methods. Minimize the risks associated with pests that may threaten the health and safety of students, staff, and the public, by utilizing alternative measures.
