Open Enrollment

On Wednesday, January 7, 2026, Elk Grove Unified School District (EGUSD) will begin accepting Open Enrollment requests for the 2026-2027 school year. Students who are currently enrolled in EGUSD and wish to apply for Open Enrollment at one of eleven available middle and high schools, parents/guardians will need to log-on to ParentVUE to make your school selection. The Open Enrollment process will be available **Wednesday, January 7, 2026, through Friday, January 16, 2026**.

If you need to register for a ParentVUE account, please contact your child's school to obtain an activation code and instructions. Once you have your account set up you will be able to select an Open Enrollment school.

Only students who are CURRENTLY ENROLLED and live within the EGUSD boundaries by January 1, 2026 are eligible to apply for Open Enrollment. If your student is not currently enrolled for the 2026-2027 school year, you will need to first register at the RESIDENT SCHOOL to obtain an EGUSD Student ID number and ParentVUE access code. ## Open Enrollment School Sites for 2026-2027

- Open Enrollment is **not first come, first serve**.
- If your son/daughter is currently at a secondary school on Open Enrollment and intends to continue at his/her current school for the 2026-2027 school year, you **do NOT need to reapply for Open Enrollment**.
- Students **must reapply** for Open Enrollment **after** grade 8. Approval to attend a particular middle school **does not** extend approval to attend the regional high school.
- The transfer request is valid for the requested school only; **all four years of requested high school OR two years of requested middle school**.
- The district **does not** provide transportation for students on an Open Enrollment transfer. Transportation must be provided by the parent/guardian.
- The district reserves the right to limit the number of students transferring into or out of any individual school site. If such limits are imposed, a random selection process will be conducted on **Thursday, January 22, 2026**, to select students for Open Enrollment transfer.
- Termination of the transfer request may be made by parent/guardian **only at the end of each school year, by July 1**.

### **Athletic Eligibility**

- **Open Enrollment may affect athletic eligibility**
  - 9<sup>th</sup> graders are eligible providing there is no evidence of **undue influence** by anyone associated with the school of choice.
  - 10<sup>th</sup> – 12<sup>th</sup> graders shall have their eligibility determination made in compliance with CIF Sac-Joaquin Section Bylaw 207.B
  - All such transfer students must complete the required CIF Sac-Joaquin Section 207/510 application form. No transfer student is eligible to compete for the new school of enrollment until a determination of eligibility has been made by the Sac-Joaquin Section office.
  - Open Enrollment students **may not participate in any type of athletic activity at his/her requested school until they have completed the 2025-2026 school year at their current school.**
