PUBLIC HEARING: CJUSD PRELIMINARY BUDGET FOR FISCAL YEAR 2025-2026

The purpose of this portion of the meeting was to set aside time to provide information to the public and to receive public comment and input on the district's budget for the upcoming year.

The Public Hearing on the CJUSD Preliminary Budget for Fiscal Year 2025-2026 was opened at 6:09 pm. Lisa Coronado, Director of Fiscal Services, noted that the budget has to be approved by July 1, but the governor has not finalized his budget yet. She shared the following slides: 2025-2026 CA Governor's May Budget Revision; District ADA, Enrollment, and Rate; Total Unrestricted Revenue vs Expenditures and Other Financial Sources/Uses; General Fund Unassigned/Unappropriated Ending Fund Balance; Site Budgets; Department Budgets; Classroom Teacher Salaries; Salary Increases – Past Five Years; One-Time Funding Used for Salaries; Other Major Funds; Conclusion & Looking Ahead; and Budget & LCAP. There were no public comments. There were comments and questions from the Board. The Public Hearing closed at 6:32 pm.

PUBLIC HEARING: LOCAL CONTROL ACCOUNTABILITY PLAN (LCAP)

The purpose of this portion of the meeting was to set aside time to provide information to the public and to receive public comment and input on the district's LCAP for the upcoming year.

The Public Hearing on the Local Control Accountability Plan (LCAP) was opened at 6:32 pm. Tami JBeily, Coordinator of Federal and State Programs, shared a presentation that covered the following slides: GOAL 1: Establish a positive school climate that promotes a sense of belonging for all students, staff and families; GOAL 2: Enhance classroom instruction to effectively impact all students through the integration of Multi-Tiered Systems of Support (MTSS), evidence-based practices, and differentiated instruction; GOAL 2: Foster an inclusive and supportive educational environment that values individuals, addresses diverse learning needs, and promotes positive behavior through the implementation of a Multiple Tiered System of Supports (MTSS) and Positive Behavior Supports (MTSS); GOAL 4: Establish environments that cultivate learning experiences and provide paths to college and career readiness, ensuring that all students thrive; GOAL 5: Dudley Elementary Equity Multiplier; GOAL 6: McClellan High Equity Multiplier; and Next Steps.
