In accordance with our updates from the California School Boards Association (CSBA) Policy Plus Program, we will incorporate the approved legal updates into our policy manual. How to read changes to existing policies: Addition/change will be in all red, and verbiage being removed is in black strike-through. This is the first reading of the 2025 CSBA updates; these policies/bylaws and/or regulations will come back for a second reading and approval.

17.5 2026-2027 New Course Proposals

Background: As part of our annual course development cycle, staff followed the Board-approved process for proposing, reviewing, and vetting new courses. Proposals were evaluated for academic rigor, alignment to district priorities and state standards, impact on graduation/A-G requirements, staffing and facilities, and equitable access for all students.

Summary of Proposed Courses:

Commercial Music (LAHS, Music Department, Grades 9-12) —This new course introduces students to the creative and technical processes behind today's music industry. Students will explore songwriting, beat-making, digital audio recording, mixing, and mastering using industry-standard software and equipment. Emphasis is placed on creating original projects across a variety of genres, from pop and hip hop to electronic and film scoring.

Photo II Dual Enrolled (LAHS, Visual Arts, Grades 9-12) — Fundamentals of black and white still photography. Introduction to the historical development of the medium and the role that photography has played in shaping social issues and its effect on culture. Practical investigation of photography's potential to contribute to personal visual expression. Exposure to multiple perspectives on photography as practiced and exploration of contributions by photographers from diverse cultures. Topics cover visual culture,

photographic seeing, camera operation, use of aperture and shutter settings for aesthetic and exposure control, film processing, and printing.

Fashion Design II (LAHS, CTE, Grades 10-12) — Fashion Design 2 is a new intermediate-level course that expands on the foundational skills introduced in Fashion Design I. Students will advance their understanding of garment construction, pattern development, textiles, and fashion design techniques. Through project-based learning, students will apply the design process to create original fashion pieces, refine their technical sewing and illustration skills, and explore sustainable and ethical fashion concepts. Emphasis will be placed on creative design thinking, craftsmanship, and preparing for future careers or postsecondary study in the fashion and design industries.

English IV Dual Enrolled (AVHS, English, Grade 12) — This new course is designed to build DE capacity within the target population of 12 grade students at AVHS ready for this rigor and level of college work. It will instill in them that they are able to do college, and this is in fact an option for them if they desire.

GIST 11 Dual Enrolled (LAHS, Elective, Grades 11-12) — This new course is the foundation course in an emerging field that blends many disciplines together. The basic course outline is the Introduction to the fundamental concepts of geospatial technology, including Geographic Information Systems (GIS), Remote Sensing (RS) and Global Positioning Systems (GPS), map reading, and cartography.

AVID Internship Dual Enrolled (MVLA, Elective, Grades 9-12) — The internship is a structured work experience with an organization or company external to the classroom, in this case, we are building and mimicking a real workplace setting where students are "tutoring" and helping other students in subject matter they are experts in. MicroEconomics Dual Enrolled (MVHS, Elective, Grade 12) — Microeconomics satisfies the CA state standards requirement for a course in Economics as a requisite for high school graduation. The course prepares students to earn college credits with Foothill College as dual enrollment.

Foundations of Health Careers and Sports Medicine (MVHS, CTE, Grades 9 - 12) — This new course will replace the current CTE course 'Health Careers 1'.

Advanced Sports Medicine (MVHS, CTE, Grades 10 - 12) — This new course will replace the current CTE course 'Health Careers 2'. Athletic injury prevention is emphasized through pre-participation physical exams, exercise programs, preventative taping, proper fitting of equipment, and protective braces.

Recommendation: Approve the listed new course proposals for implementation beginning in the 2026–27 school year.
