Schevenin shared that title 1 teachers were originally allocated but due to uncertainty of title 1 funds in spring of 2025, these teachers weren't hired. Instead staff asked to be sent to a pd about running classroom meetings. Seventeen teachers were sent. Last meeting 10k was set aside for subs so that teachers could assess students that reading specialists formerly supported. Funds have been shuffled from other funding sources to cover costs. K.Schevenin is asking for additional 20k in funds from title 1 to goal 2 to send 18 additional staff members to positive discipline training. There is a need for multilingual books and an additional 8k requested from title 1. Finally,
