

## Curriculum, Instruction, and Assessment |

- ☐ The Curriculum, Instruction and Assessment (CIA) Advisory met in January and approved course requests for Astronomy and Personal Finance at Willows High School, and CSU Expository Reading and Writing for grades 11 and 12 at Willows High School and Community High School.
- ☐ The CIA Advisory also approved the supplemental novels *The Merchant of Venice* by William Shakespeare and *Three Cups of Tea* by Greg Mortenson & David Oliver Relin for Willows High School and the ERWC course materials for Willows High School and Community High School. These items are available for public review at the District Office until February 12, 2026 at 4:00 pm.
- ☐ February 2-6 is National School Counseling Week. The focus this year is “School Counselors amplify student success!” We are lucky to have Yolanda Huerta at Murdock Elementary, Xochitl Rodriguez at Willows Intermediate, Hunter Thompson at Willows High School, and Bibiana McNeil at Willows High and Willows Community High. To see how they have impacted our students, please see the attached mid-year school counselor reports which gives a glimpse at what they have been working on this year.
- ☐ Our WUSD Cal Curriculum Math Adoption team continues to meet and look at the math curriculum options available.
- ☐ A group of teachers from Murdock and WIS attended day 1 of a three day Region 2 math adoption workshop series put on by the Shasta County Office of Education. They were able to learn about the updated math framework and work with a rubric to assess approved California math curriculum.
- ☐ This month each site had the opportunity to meet with their PLC (Professional Learning Community) coach from Solution Tree (1/22–MES, 1/28–WIS and WHS). Grade level teams (e.g. all 3rd grade teachers) or subject level teams (e.g. English) were able to have a dedicated period of time to meet with the coach. What they focused on depended on the needs of the team. If determining their essential standards, what they want all students to know, was their need, they focused on that. If it was helping them create common assessments, that was what they focused on. They will meet with the same individual again two more times this spring and then four times in the fall.
- ☐ This month begins our 2025-26 Summative State Testing season–ELPAC (English proficiency), CAASPP (ELA and Math), CAST (Science) and PFT (Physical Fitness). Attached is the current testing schedule for each site with the understanding that there may be some additions or changes that could be made as we progress.

## State & Federal Activities |

- ☐ Fall 2 CALPADS data collection and verification has been completed and submitted. This submission focused on English Learner services, Postsecondary Outcomes for 2025 graduates, student course enrollments, and staff assignments.
- ☐ Diana and I completed the Consolidated Application (CARS) Winter reporting which is a requirement for our categorical (e.g. Title I, Title IV etc.) state and federal funds.
- ☐ Diana and I completed the LCAP Midterm Report which examines the progress we have made on the four goals in our plan and the action items associated with those goals.
- ☐ School Accountability Report Cards for all four WUSD sites have been uploaded to the state by the Feb. 1, 2026 deadline. They have also been posted on the district website and shared with parents and staff via ParentSquare.
- ☐ On February 11th we will hold an LCAP Pursuit of Excellence Night that focuses on how WUSD sites are strengthening minds and building character. Our WUSD school counselors, wellness coaches and students will share some of the student services offerings on our campuses and how those are contributing to students' wellness and academic success.
- ☐ We are finishing up the second Golden State Risk Management RMAP submission which is due March 2nd. This submission focuses on compliance documentation around cybersecurity, board manuals, vehicle policy, safety committee, Payroll and loss exposure.

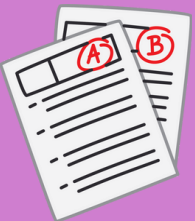

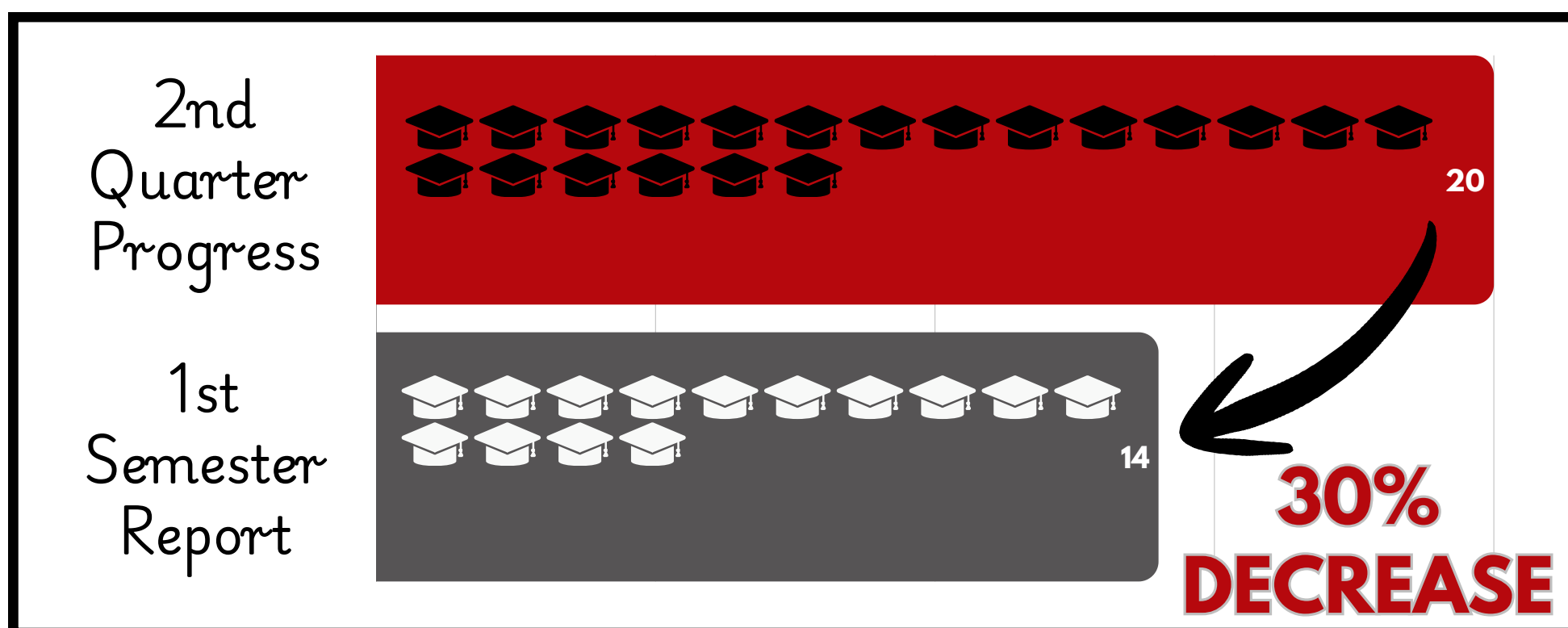

We will continue to meet with students to help get them to their goal of 8<sup>th</sup> Grade Graduation.

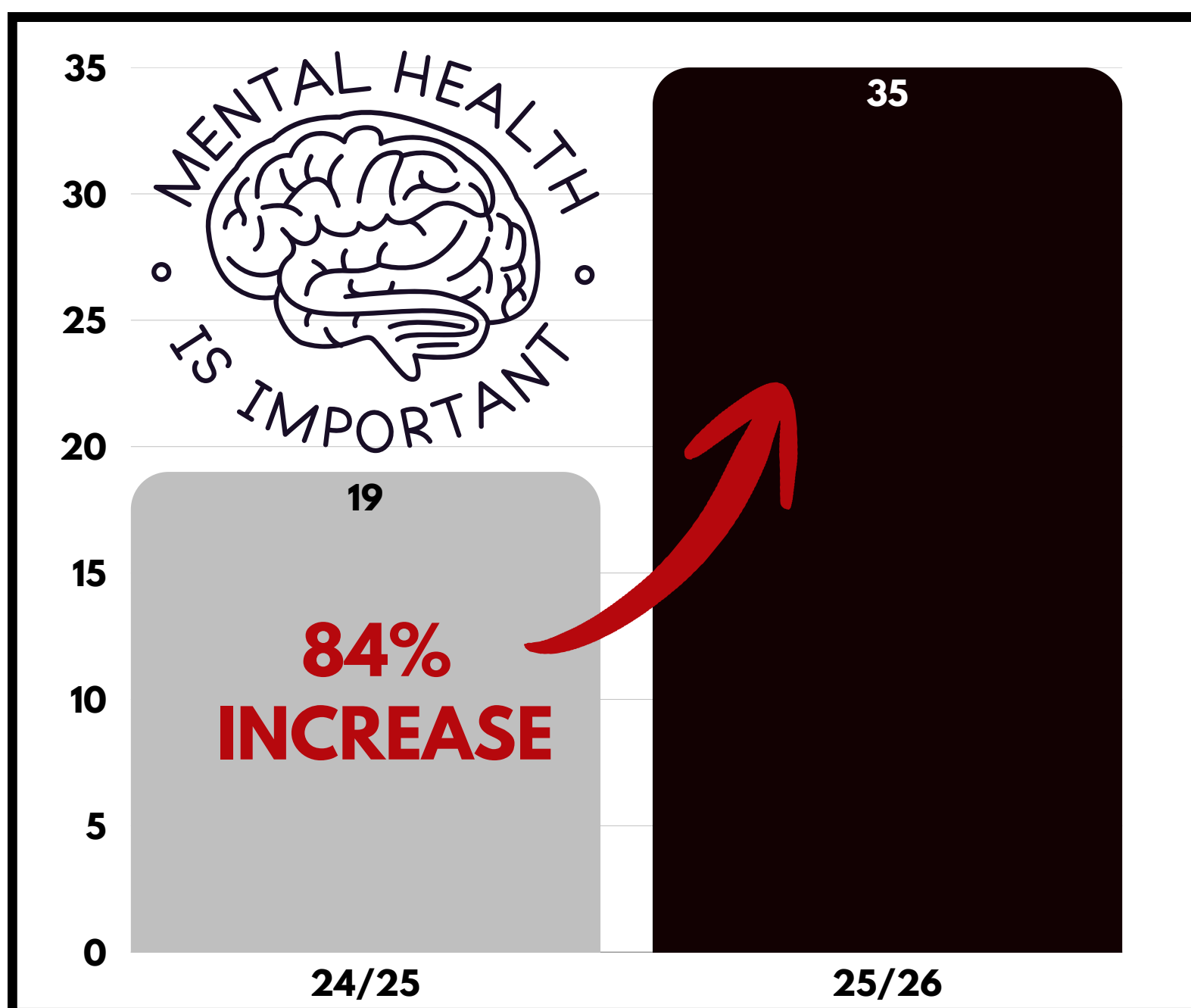
## Partnership Referrals

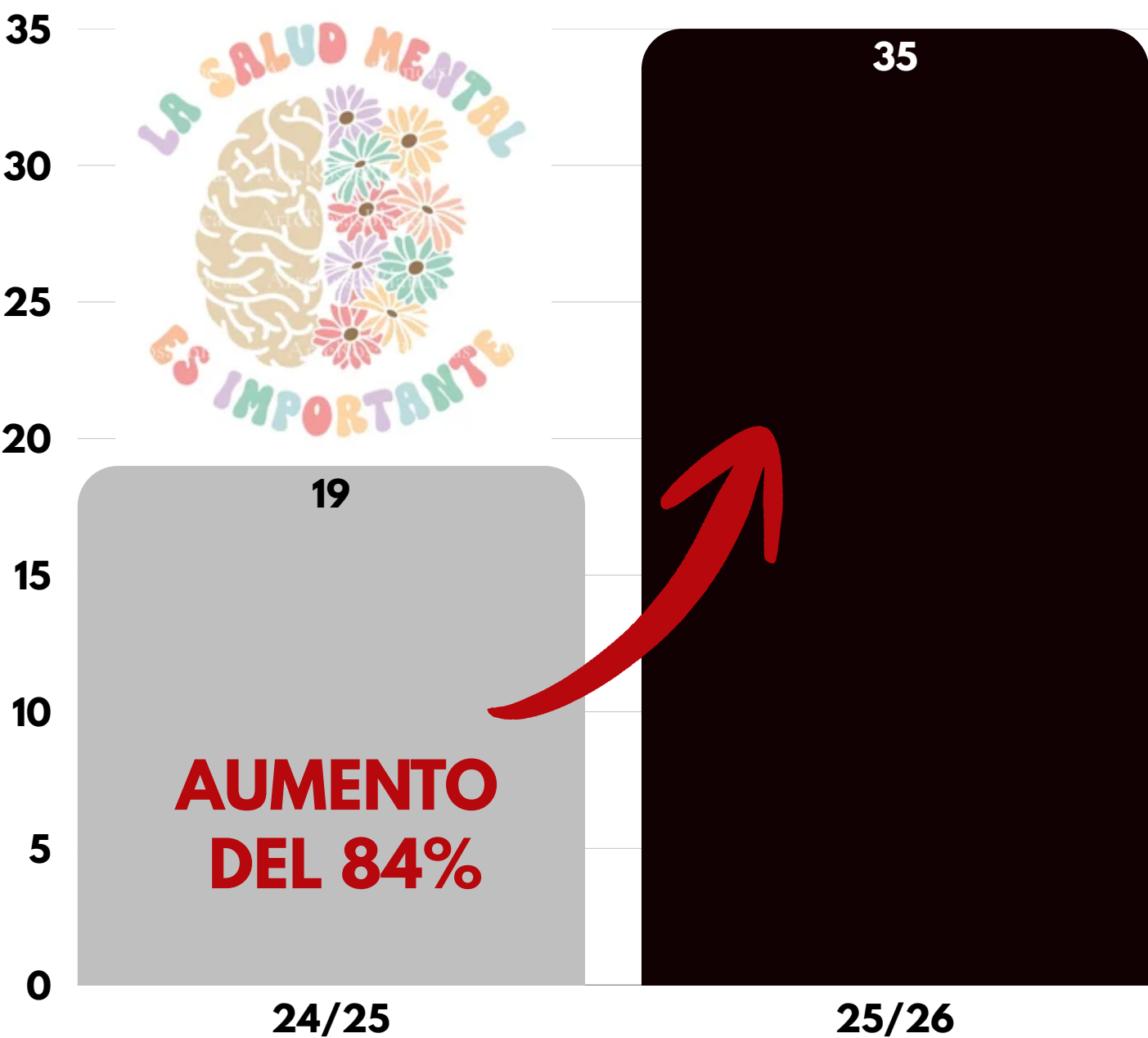
## Referencias de asociación

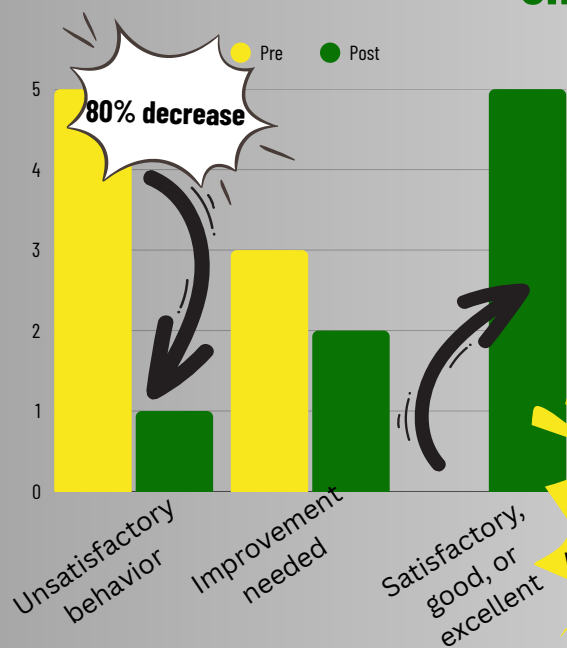

8 participants (TK-K Boys)



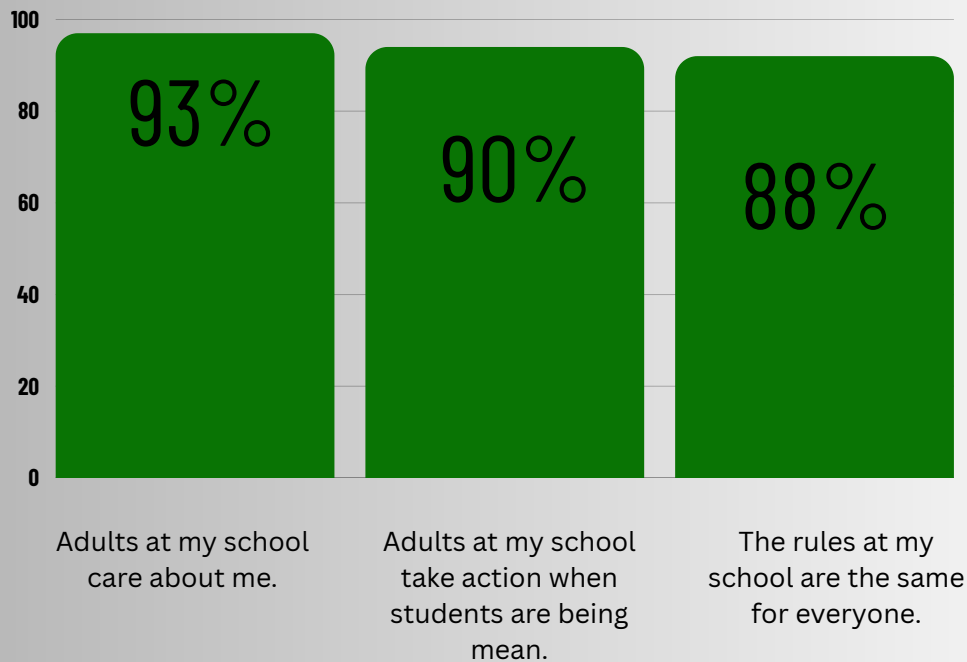
The small group comprised of students identified as having unsatisfactory classroom behavior or a need for behavioral improvement.

**Huge percentage jump in the # of students rated with satisfactory, good or excellent behavior.**

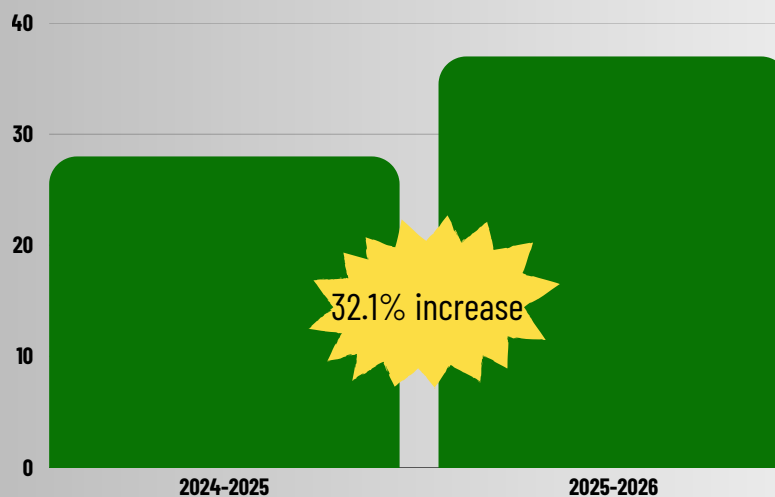
## What Students Say About Murdock Elementary

## Mental Health Service Referrals
